I agree to relieve the City of Los Angeles Department of Recreation and Parks, its officer agents and employees from any liability in connection with any injury to my child in connection with this league. I understand that the Recreation Facility **CARRIES NO INSURANCE**.

I, also, do hereby authorize the staff of **STONEHURST RECREATION CENTER** as agents for the undersigned to consent to X-Ray examination, anesthetic, medical or surgical diagnosis or treatment and hospital care which is deemed advisable by, and is to be rendered under the general or specialized supervision of any physician licensed under the provisions of the Medical Practice Act on the staff of a licensed hospital, whether such diagnosis or treatment is rendered at the office of said physician or a said hospital. It is understood that this authorization is given in advance of any such diagnosis, treatment or hospital care that the aforementioned physician in the exercise of his best judgment may deem advisable. This authorization shall remain effective for the duration of the program, unless revoked sooner in writing and delivered to the said agent.

I also authorize the City to make, obtain or use photographs, films, tapes or other likenesses of Minor's physical image and/or voice as may be needed for use projects or theme events pertaining to the **STONEHURST Recreation Center - Sports Program**. As it is difficult to pull individual children out of photographs, I understand that there is not an option for my child to be excluded from certain photographs.

Refund Policy: A non-refundable 15% administration fee will be assessed by the Recreation Center to any patron granted a refund, change or transfer of sports league registration. Full refunds will only be issued when the league is cancelled by the Recreation Center

7. I will remember that the goals of the game are to have fun, improve skills and feel good about playing. I will not take the game or myself too seriously. I will control my temper.
8. I will work equally hard for the team as for myself, and will always give my best effort.
9. I will remember that I am a league sports player, and that the game is for my enjoyment.
10. I will demonstrate good sportsmanship.
