**ACCEPTABLE FORMS OF PAYMENT, by MAIL: Money Order, Cashier's Check, Certified Check or Credit Card**  
**Paying in PERSON: Personal Checks under \$500 (with Driver's License or ID Card), or Mail methods (above)**

**IMPORTANT! If paying by check (personal or business), you must write your Driver's License Number & Expiration Date on the Check!**  
**If paying by Credit Card, we need the last group of numbers on the back of your card and the billing zip code.**

**WAITING LIST PROCEDURE:** All teams registering after February 12<sup>th</sup> may submit a completed registration form (no fees). If you are offered a slot, and you accept it, no changes can be made. Mail, bring, or fax to Municipal Sports Office (above).

**LEAGUE ORGANIZATION:** Your team will be placed in a league (usually a league consists of 8-14 teams), all games are played on Sundays. Usually 9:30am or 1pm.

**ROSTERS:** All softball players who participate in league games must sign a team roster. Rosters are due in the Sports Office prior to the third game of the 1<sup>st</sup> round of play. The Sports Office reserves the right to classify a player.

**UMPIRE FEE FORFEITURE REASONS:** 1) Failure to meet the games as arranged; 2) Withdrawal during the league; 3) Unsportsmanlike conduct; 4) Failure of any player to abide by official's decisions; 5) Failure to be active for a two year period; 6) Failure to abide by decisions of the Executive Board. Forfeited bonds will revert to the Municipal Sports Account.

**COMMUNICATION:** Telephone numbers for Team Managers and Assistant Managers must be kept up-to-date. If managers cannot be contacted – the game will be forfeited.
