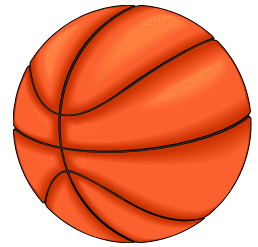

- Original Team Roster is due in the Sports office before the date of the 3<sup>rd</sup> league game. Only Original Complete Roster Accepted. (Receipt date effects City-wide Tournament invitation and protests)
- The last day to submit an Add/Drop form is prior to the first game of the second round. NOTE: Players MUST participate in a minimum of 5 league games to be eligible for the Play-offs and/or City-Wide Tournaments.
