## 2009 Winter/Spring Player Registration Add Drop

If the player/s that is being dropped is to be activated with another team, the soccer office must have received the player/s dropped form and the ID from his/her current team before the new add form can be accepted and a new ID can be issued. Failure to comply with any of this protocol shall result in forfeiture of the game(s).
