# GENERAL MANAGER'S REPORTS

RANCHO PARK GOLF COURSE - DRIVING RANGE IMPROVEMENT (PRJ20582) PROJECT - FINAL PLANS AND CALL FOR BIDS

The above item was described and presented to the Board by Department staff. Public comments were invited, however, no requests for public comment were received. A detailed discussion by the Commission ensued.

Michael Shull, Superintendent, Planning, Construction and Maintenance Division, amended the report as follows:

- 1. Add Recommendation No. 3: "Approve the use of the Business Inclusion Program (BIP) by the Bureau of Engineering for this project."
- 2. Add the following language to the 1st page, last sentence, second paragraph under Summary: "... base construction scope at \$900,000, (excluding the additive alternates).".
- 3. Add the following language just after the CEQA and above the "The bid package has been approved by the City Attorney's Office":

"It is noted that this is the <u>second</u> project with the bid package that incorporates and implements the City's new Business Inclusion Program (BIP), in compliance with the Mayor's Directive No. 14. For this project only, the Bureau of Engineering used the Business Inclusion Program (BIP) per Mayor Executive Directive No. 14 issued on January 12, 2011 which is intended to ensure that all businesses, including job-creating small business, have an equal opportunity to do business with the City of Los Angeles. The BIP has not been

approved by the Board for use by the Department. A board report to approve a process which will allow the Department to comply with the BIP and address the different types of contracts the Department (i.e., construction, personal service, concession, partnership, leases, etc.) will be presented at a later date. It is recommended that the BIP process used by the Bureau of Engineering be allowed for this project only."
