SUMMARY OF NEW AND CURRENT BUSINESS ITEMS

June 15, 2023

Wattles Mansion

• Wattles Mansion (Wattles) is a RAP Special Event Venue which has been closed for several years due to required repairs for which funding is currently unavailable. Traditionally, RAP staff provided maintenance & repairs, promotions, booking, and event oversight. In order to reopen Wattles, staff is considering development of a Request for Proposal (RFP) to contract with a concessionaire who will fund and oversee the needed repairs, reopen, and oversee operations under a multi-year concession agreement with revenue share – term length TBD.

RFP Update

- An RFP is in development for Golf Course Food and Beverage concessions at Encino/Balboa, Hansen Dam, and Woodley Lakes; for renovation, operation and maintenance.
- An RFP is in development for the provision of equipment, operation, and maintenance of the Griffith Observatory Coin-Operated Telescope Concession.
- An RFP is in development for the operation, maintenance, and renovation at Point Fermin in San Pedro for a Food and Beverage concession.

Rancho Park Golf Clubhouse Renovation Update

- Demolition and renovation has been delayed by the new concession operator due to the discovery of hazardous materials and obsolete electrical switchgear.
- A Board Report is being drafted recommending approval of an amended and restated Agreement.

Griffith Park Pony Ride

- The Pony Ride was closed in December 2022, and a consultant has been hired to oversee and analyze community engagement efforts in order to determine and make a recommendation on the best use of the space.
- The GP Train Ride operator is temporarily operating the birthday party corrals. Patrons are allowed to rent the party corrals for special occasions, such as birthday parties or picnic gatherings. The operator offers birthday party packages as well as a range of rental rates. The operator has successfully made a handful of reservations and has been open and fully operational since June 1.
