Job Description/Duties:

- Instruct First Aid and CPR-AED Classes for Adult, Child and Infants as an AHA/ARC Instructor. Provide high quality instruction per program guidelines, complete class paperwork/reports in a timely manner.
- Ensure all safety protocols, policies, and procedures are implemented and followed at all times.
- Communicate effectively with all participating entities (partners, participants, coordinator, volunteers, staff).
- Ability to adapt to change and maintain professionalism, while following directions given by Aquatics and/or Parks management.
- Able to work both independently and in a team setting.
- Able to work a flexible schedule and be available to work a minimum of 8-hours per week to include weekdays, and some weekends/evenings. Ability to work at various sites in Los Angeles.
- Ability to participate in all related activities: walking/standing for long periods of time, squatting, kneeling, lifting/carrying up to 50lbs of equipment, standing in inclement weather, 4-6 hours of sun exposure.
- Transport, loading and unloading of equipment.
- Maintain equipment decontamination and inventory.
- Ability to perform special assignments.



About the Position:

Responsibilities include but are not limited to: instructing students on the application of equipment and performance of practical skills, evaluating students during instruction and skills exams, acting as a student advocate in the learning process, creating an active learning environment, ensuring course requirements and objectives are met, and transporting and managing course equipment at off-site locations.

Highly Desired Skills

- Good communication and decision-making skills;
- Background in teaching in a group setting;
- A thorough knowledge of CPR and First Aid procedures;
- EMT Certification is highly recommended, but not required;
- Proficiency in computer usage including Microsoft suite / Google Docs;
- Friendly and outgoing attitude to engage participants while teaching classes;
- · Strong time management skills;
- Ability to travel to training locations.

Required Qualifications

- AGE: 18 years of age by hiring date.
- CERTIFICATION: A Recreation Instructor must maintain a valid California Driver License throughout the course of employment.
- CERTIFICATION: Proof of a valid American Red Cross BLS Card, American Heart Association BLS Card, American Red Cross Emergency Medical Response, Title 22 Card, Emergency Medical Technician or higher level of training is required.

Qualified Candidates will be invited to proceed with the next steps of the hiring process which includes an in-person interview and performance evaluation.

DOCUMENTS: DEPARTMENT OF HOMELAND SECURITY: All new city employees must show satisfactory proof of identity and a legal right to work in the United States.

- If you have ONE document from CATEGORY A, you will need no further documentation.
 - A. Documents that show both identity and employment eligibility: U.S. Passport, Alien Registration Receipt Card (Form I-551, Permanent Resident Card, or Unexpired Employment Authorization Document that contains a photograph (Form I-766, I-688A, I-688B).
- If you DO NOT have documentation from CATEGORY A, you need one document from each of Categories B and C.
- B. Documents that show identity only: Valid Driver License, D.M.V. ID Card, Current School ID with photograph, U.S. Military Card, Draft Record or Military Dependent's ID Card.
- C. Documents that show employment eligibility only: Social Security Card, Original Copy of U.S. Birth Certificate by a government agency with a seal, U.S. Citizen ID Card, or I.N.S Employment Authorization Document.
