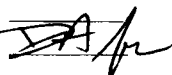

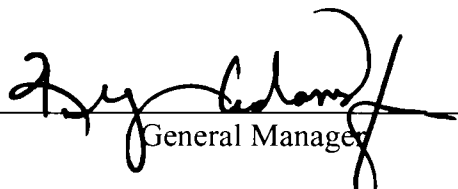

That the Board:

1. Approve a proposed Amendment to the Donation Agreement (Agreement), substantially in the form on file in the Board Office, between the Department of Recreation and Parks (RAP) and the Los Angeles Neighborhood Initiative (LANI) for the acquisition, development, and construction of new parks in Los Angeles, to add 111th Place Neighborhood Place to the list of projects in the Agreement, subject to the approval of the Mayor, the City Council, and the City Attorney as to form;

SUMMARY:

On March 2, 2011, the Board of Recreation and Park Commissioners (Board) approved an Agreement between RAP and LANI, a non-profit organization, for the acquisition, development, and construction of new parks in Los Angeles (Board Report No. 11-071).

As detailed in the Agreement, LANI is required to prepare, in coordination with RAP, grant applications and conceptual plans for the prospective park projects identified in the Agreement. If those grant applications are successful, LANI is responsible to coordinate with RAP, the acquisition (when necessary), development, and construction of each park project. Upon completion of construction of each prospective park by LANI, RAP staff will submit the completed project to the Board for final approval and acceptance. If those park projects are accepted by the Board, RAP will be responsible for long-term maintenance and operation of each park developed and constructed under the terms of the Agreement.

Subsequently, staff from RAP and LANI partnered together to identify additional prospective park projects that would result in the construction of new parks in the City of Los Angeles. On June 6, 2011, the Board authorized the General Manager to submit three grant applications, and supported the submittal of eight grant applications by various organizations working in partnership with the Department, for the second funding round of the Proposition 84 Statewide Park Program (Board Report No. 11-167). One of those applications, for the 111th Place Neighborhood Park project, was prepared and submitted by LANI. On March 26, 2012, LANI received notification from the State that the 111th Place Neighborhood Park project was awarded funding under the second funding round of the Proposition 84 Statewide Park Program.

The proposed amendment to the Agreement would modify the list of prospective properties by adding one additional park development project.

- 111th Place Neighborhood Park - Development and construction of a new park on a 0.09 acre site located at 207 East 111th Place, Los Angeles, California 90061.

On May 16, 2012, the Board accepted the donation of the parcel located at 207 East 111th Place, Los Angeles, California 90061 (Board Report No. 12-162). The acquisition of this parcel is still in process and is anticipated to be completed soon.

Staff has determined that the 111th Place Neighborhood Park project was previously evaluated for environmental impacts in accordance with California Environmental Quality Act (CEQA) and a Negative Declaration was adopted by the Board on May 16, 2012 (Board Report No. 12-162), and a Notice of Determination was subsequently filed with the Los Angeles City Clerk and Los Angeles County Clerk. Staff finds that the 111th Place Neighborhood Park project scope and environmental site conditions has not substantially changed from that previously evaluated, and would not require

any additional mitigations. Therefore, no additional CEQA documentation is required for approval of the supplemental funding of the project.

Authorize staff to initiate the process for the possible lease of real property from the Los Angeles Department of Water and Power (LADWP), totaling approximately 5.35 acres and located along 98th Street between Avalon Boulevard and Wadsworth Avenue, Los Angeles, California 90002 (Assessor's Parcel Numbers (APN): 6050-025-900, 6050-026-900, and 6050-027-900), for the purpose of creating a new neighborhood park;
 - B. Authorize staff to coordinate with LADWP, Department of General Services (GSD), and other Departments, as necessary, to expedite the lease of said property, complete due diligence requirements, and obtain the necessary environmental clearance;
 - C. Direct staff to return to the Board of Recreation and Park Commissioners (Board) for final authorization to lease said property upon the conclusion of negotiations with LADWP and completion of due diligence requirements; and,

SUMMARY:

On November 7, 2006, California voters passed the “Safe Drinking Water, Water Quality and Supply, Flood Control, River and Coastal Protection Bond Act of 2006”, which authorizes \$5.4 billion in general obligation bonds for a number of State of California (State) grant programs. One of the grant programs created is the Proposition 84 Statewide Park Program. A total of \$368,000,000 was dedicated to the Proposition 84 Statewide Park Program to make grant awards to projects that demonstrate the creation of new park and recreation facilities in proximity to the most critically underserved communities throughout California on a competitive basis in two rounds (\$184,000,000 available each round).

In September 2009, the State released a Request for Proposals for the first round of competitive grants for the Proposition 84 Statewide Park Program. RAP submitted grant applications for nine projects; however, due to the competitiveness of the hundreds of statewide applications submitted for consideration, none of the RAP’s projects were funded.

In January 2011, the State released a Request for Proposals for the second round of competitive grants for the Proposition 84 Statewide Park Program. On June 6, 2011 the Board authorized the General Manager to submit three Proposition 84 Statewide Park Program grant applications and supported the submittal of eight Proposition 84 Statewide Park Program grant applications by various organizations working in partnership with RAP (Board Report No. 11-167). Two of the eight grant applications that were submitted by organizations other than RAP were prepared and submitted by the Los Angeles Neighborhood Land Trust (LANLT), a non-profit organization.

On March 26, 2012, LANLT received notification from the State that the two grant applications that it submitted for the 98th Street Park and the Vermont and 81st Street Park projects were awarded funding under the second funding round of the Proposition 84 Statewide Park Program.

As the grant applications for these two projects were prepared and submitted by LANLT with the intent to turn over the completed projects to RAP to operate and maintain, RAP would need to enter into a Donation Agreement (Agreement) with LANLT in order to implement the lease or transfer of jurisdiction to the site, development, and construction of the projects.

As described in the proposed Agreement, LANLT has prepared, in coordination with RAP, grant applications and conceptual plans for the identified prospective park projects. LANLT is to coordinate the design and construction of the park projects with RAP and, when construction is completed by LANLT, RAP staff will submit each completed project to the Board for final approval and acceptance. If accepted, RAP would assume and be responsible for long-term maintenance and operation of each park developed and constructed under the terms of this Agreement.

The proposed Agreement requires LANLT to present the conceptual plan for each park project successfully awarded grant funding to RAP for review and approval. Once RAP approves a project's conceptual plan, LANLT will prepare a detailed set of final plans and specifications for that project, which will be submitted for approval to the Board in a subsequent report. The conceptual plans for the 98th Street Park project and the Vermont and 81st Street Park project are described below and attached hereto as Attachment A and Attachment B, respectively. These conceptual plans were developed with input from public workshops and meetings facilitated by LANLT in partnership with RAP and local community organizations.

98th Street Park – Lease of Real Property and Park Development Project

LADWP currently maintains a 5.35 acre linear property located along 98th Street between Avalon Boulevard and Wadsworth Avenue Los Angeles, California 90002 (APN'S: 6050-025-900, 6050-026-900, 6050-027-900) that the City can utilize for pocket park purposes. The site is currently improved with electric power transmission lines and is surrounded by residential housing.

This project proposes that RAP enter into a lease of real property from LADWP and develop the property with outdoor park and recreational improvements. RAP will provide LANLT with a right of entry permit to construct the proposed improvements. Following the approval of this report, and upon the completion of negotiations with LADWP and of any due diligence investigations, staff will return to the Board for final authorization to lease said property.

The conceptual plan for the 98th Street Park project (Attachment A) includes the construction of open space areas, children's playgrounds, picnic areas, family game table area, basketball half-courts, multi-use open spaces and turf areas, walking/jogging trails with outdoor fitness stations, perimeter fencing and gates, and landscaping. LANLT will bid and award the project, as funds were awarded to LANLT. The completed improvements will then be donated to RAP, subject to Board approval and acceptance.

The State awarded LANLT a total of \$4,997,584 in grant funding for this project. It is anticipated that this funding is sufficient to meet the project scope.

Staff has determined that the subject project will consist of the lease of approximately 5.35 acres of property and the development of a new park. The proposed park will include open space areas, children's playgrounds, picnic areas, family game table area, basketball half-courts, multi-use open spaces and turf areas, walking/jogging trails with outdoor fitness stations, perimeter fencing and gates, and landscaping. Therefore, the project is exempt from the provisions of the California Environmental Quality Act (CEQA) pursuant to Article III, Section 1, Class 3(6), Class 4(1,3), Class 11(3) of the City CEQA Guidelines, and Article 19, Section 15325, Class 25(f) of the State CEQA Guidelines.

Vermont and 81st Street Park - Transfer of Jurisdiction and Park Development Project

GSD currently maintains a 0.23 acre vacant surplus property located at 954 West 81st Street, Los Angeles, California 90044 (APN 6032-005-900) that the City can utilize for pocket park purposes. The site is currently vacant and is surrounded by residential housing.

This project proposes to transfer jurisdiction of this City-owned property to RAP and develop the property with outdoor park and recreational improvements. RAP will provide LANLT with a right of entry permit to construct the proposed improvements. Following the approval of this report, and upon the completion of the due diligence investigations, staff will return to the Board for final authorization to accept the transfer of jurisdiction of the property.

The conceptual plan for the Vermont and 81st Street Park project (Attachment B) includes the construction of a playground, fitness zones, climbing sculpture, walking trail, gazebo, fencing, and landscaping.

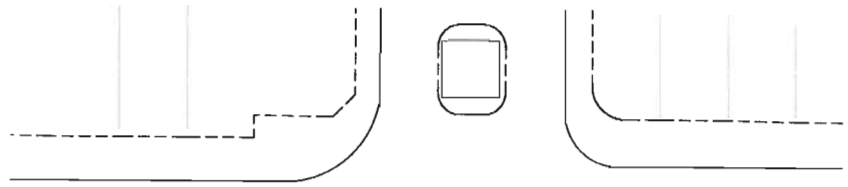
The State awarded LANLT a total of \$1,492,664 in grant funding for this project. It is anticipated that this funding is sufficient to meet the project scope.

Staff has determined that the subject project will consist of the acquisition of approximately 0.23 acres of vacant surplus property and the development of a new park. The proposed park will include a playground, fitness zones, climbing sculpture, walking trail, gazebo, fencing, and landscaping. Therefore, the project is exempt from the provisions of CEQA pursuant to Article III, Section 1, Class 3(6), Class 4(1,3), Class 11(3,6) of the City CEQA Guidelines, and Article 19, Section 15325, Class 25(f) of the State CEQA Guidelines.

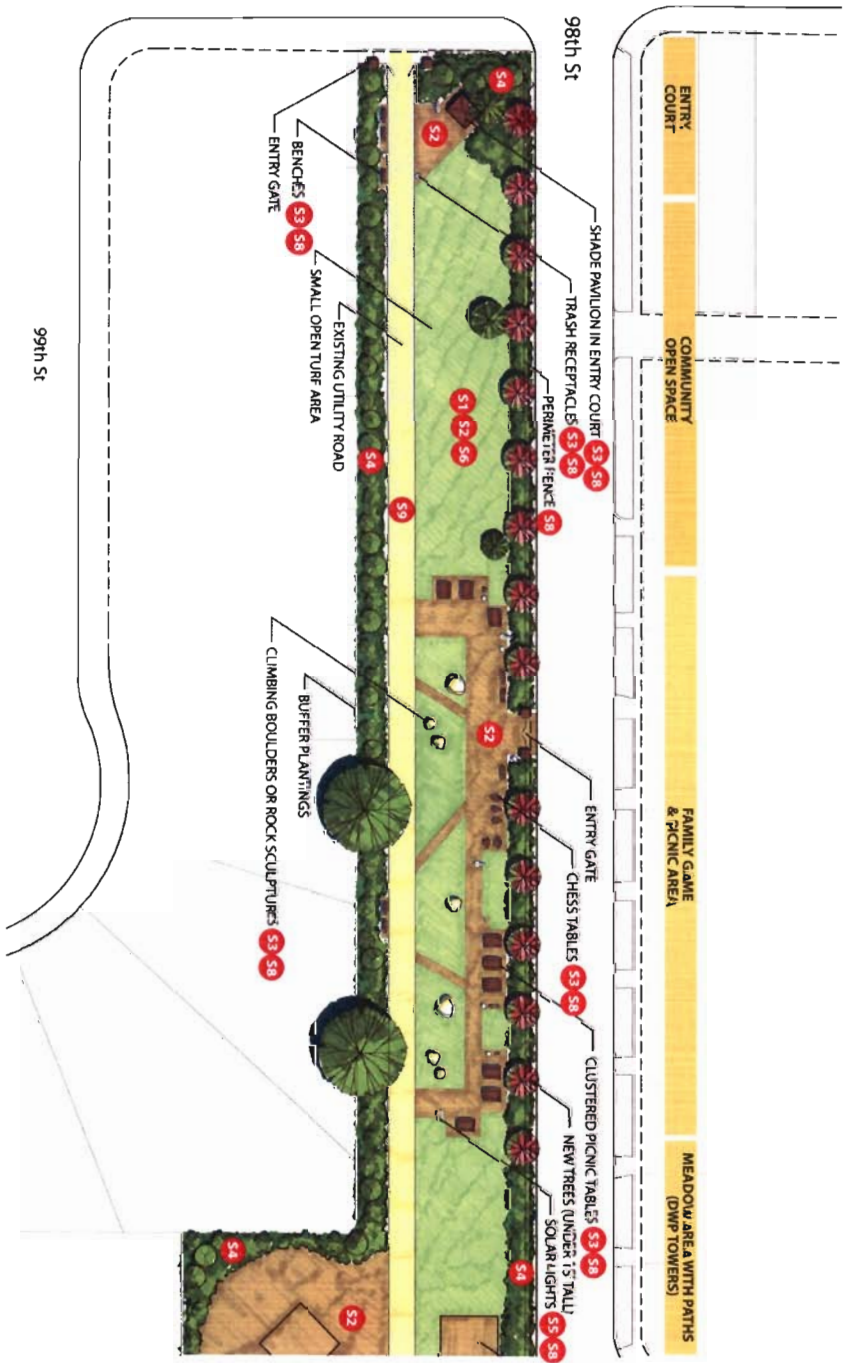
FISCAL IMPACT STATEMENT:

The approval and execution of the Donation Agreement and the approval the conceptual plans for these projects will not have any impact on the General Fund. The development of these projects is anticipated to be funded by the awarded grant funds or funding sources other than RAP's General Fund. Future operations and maintenance costs for the two projects, after project completion, are currently unknown.

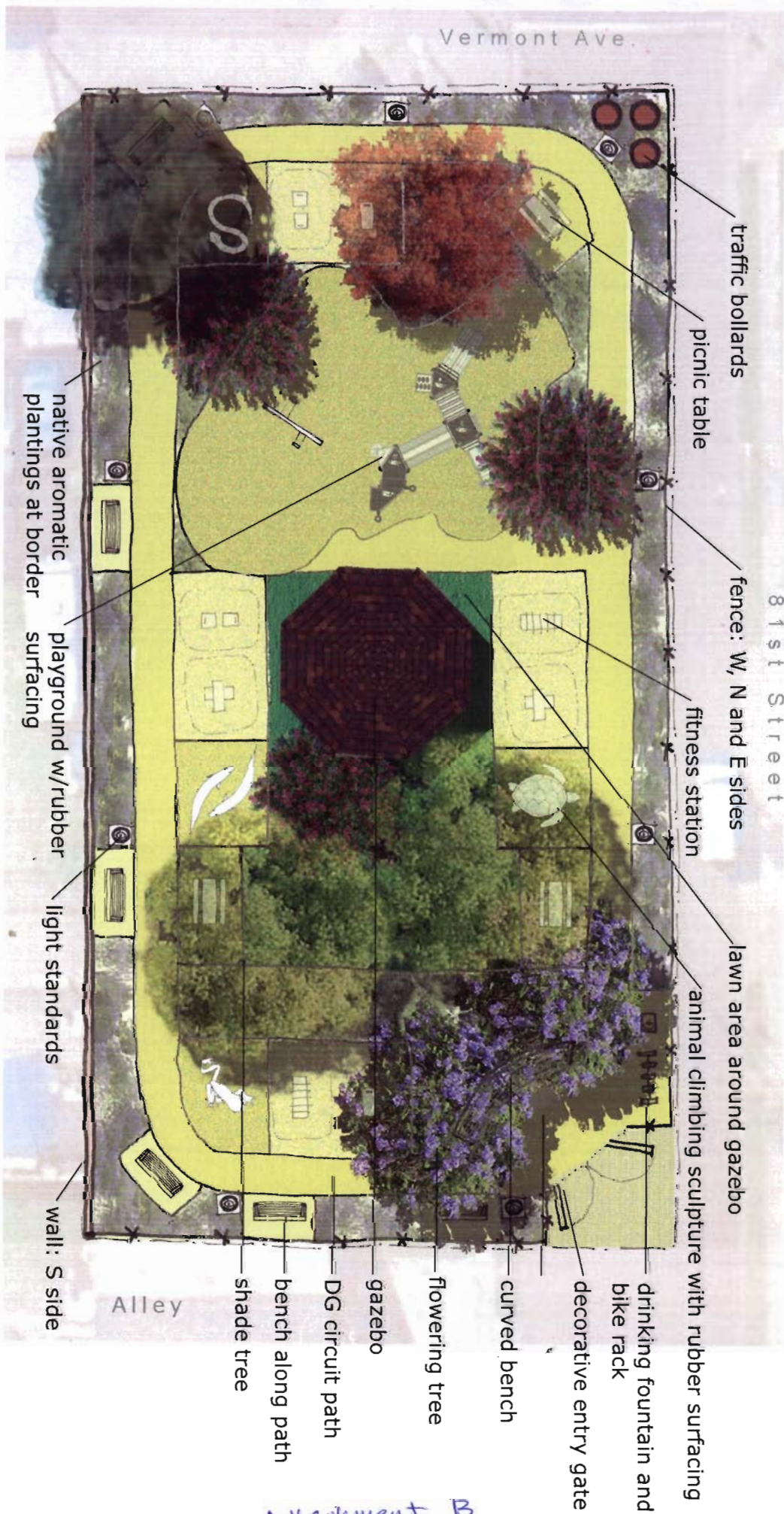

On November 7, 2006, California voters passed the “Safe Drinking Water, Water Quality and Supply, Flood Control, River and Coastal Protection Bond Act of 2006”, which authorizes \$5.4 billion in general obligation bonds for a number of State of California (State) grant programs. One of the grant programs created is the Proposition 84 Statewide Park Program. A total of \$368,000,000 was dedicated to make grant awards to projects that demonstrate the creation of new park and recreation facilities in proximity to the most critically underserved communities throughout California on a competitive basis in two rounds (\$184,000,000 available each round). Another grant program that was created was the Sustainable Communities and Climate Change Reductions Urban Greening Grant Program. A total of \$90,000,000 was dedicated to make grant awards for urban greening projects and plans that promote the development of sustainable communities that reduce greenhouse gas emissions.

In September 2009, the State released a Request for Proposals for the first round of competitive grants for the Proposition 84 Statewide Park Program. The Department of Recreation and Parks (RAP) submitted grant applications for nine projects; however, due to the competitiveness of the hundreds of statewide applications submitted for consideration, none of the RAP’s projects were funded.

In January 2011, the State released a Request for Proposals for the second round of competitive grants for the Proposition 84 Statewide Park Program. On June 6, 2011 the Board of Recreation and Park Commissioners (Board) authorized the General Manager to submit three Proposition 84 Statewide Park Program grant applications and supported the submittal of eight Proposition 84 Statewide Park Program grant applications by various organizations working in partnership with RAP (Board Report No. 11-167). One of the eight grant applications that were submitted by organizations other than RAP was prepared and submitted by the Mountains Recreation and Conservation Authority (MRCA), a joint powers authority between the Santa Monica Mountains Conservancy and the Conejo Recreation and Park District and the Rancho Simi Recreation and Park District.

On March 26, 2012, MRCA received notification from the State that the grant application it submitted for the El Dorado Avenue Park/Pacoima Wash Greenway was awarded \$1,075,000 in grant funding under the second funding round of the Proposition 84 Statewide Park Program. Additionally, on May 10, 2012, MRCA received notification from the State that that El Dorado Avenue Park/Pacoima Wash Greenway was awarded an additional \$463,056 in grant funding from the Sustainable Communities and Climate Change Reductions Urban Greening Grant Program.

As the grant application for this project was prepared and submitted by MRCA with the intent to turn over the completed project to RAP to operate and maintain, RAP would need to enter into a Donation Agreement (Agreement) with MRCA in order to implement the acquisition, development,

and construction of the project. As described in the proposed Agreement, MRCA has prepared, in coordination with RAP, a grant application and conceptual plan for the identified prospective park project. MRCA is to coordinate the design and construction of the park project with RAP and, when construction is completed by MRCA, RAP staff will submit the completed project to the Board for final approval and acceptance. If accepted, RAP would be responsible for long-term maintenance and operation of each park developed and constructed under the terms of this Agreement.

The proposed Agreement requires MRCA to present the conceptual plan for each park project successfully awarded grant funding to RAP for review and approval. Once RAP approves a project's conceptual plan, MRCA will prepare a detailed set of final plans and specifications for that project, which will be submitted to the Board for approval in a subsequent report. The conceptual plan for the El Dorado Avenue Park/Pacoima Wash Greenway project is described below and attached hereto as Attachment A. The project conceptual plan was developed with input from public workshops and meetings facilitated by MRCA in partnership with RAP and local community organizations.

El Dorado Avenue Park/Pacoima Wash Greenway Project

El Dorado Avenue Park is located at 11349 El Dorado Avenue in the Pacoima area of City. This 1.18 acre park, which is owned by RAP, is currently undeveloped and unimproved.

This project proposes that El Dorado Park be developed with outdoor park and recreational improvements. The conceptual plan for the El Dorado Avenue Park/ Pacoima Wash Greenway project includes the construction of a new picnic area, play area, fitness and walking trail, entry plazas, and landscaping.

The State awarded MRCA a total of \$1,538,056 in grant funding for this project. It is anticipated that this funding is sufficient to meet the project scope.

Staff has determined that the subject project will consist of the development of a new park. The proposed park will include a new picnic area, play area, fitness and nature walking trail, entry plazas, and native landscaping. Therefore, the project is exempt from the provisions of the California Environmental Quality Act (CEQA) pursuant to Article III, Section 1, Class 3(6), Class 4(1,3), Class 11(3) of the City CEQA Guidelines, and Article 19, Section 15325, Class 25(f) of the State CEQA Guidelines.

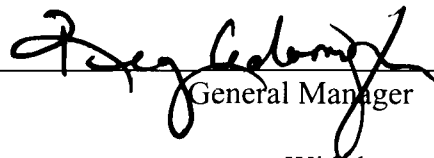

SUMMARY:

On May 17, 2010, the Board approved a Donation Agreement between the Department of Recreation and Parks (RAP) and the Trust for Public Land (TPL), a non-profit organization, for the acquisition, development, and construction of new parks in Los Angeles (Board Report No. 10-121). On March 14, 2012, the Board approved an amendment to the Agreement in order to add three additional park acquisition and/or development projects to the list of prospective properties (Board Report No. 12-066).

As detailed in the proposed Donation Agreement, TPL is required to prepare, in coordination with RAP, grant applications and conceptual plans for the prospective park projects identified in the Agreement. If those grant applications are successful, TPL is responsible to coordinate the acquisition (when necessary), development, and construction of each park project. Upon completion of construction of each prospective park by TPL, RAP staff will submit the completed project to the Board for final approval and acceptance. If those park projects are accepted by the Board, RAP will be responsible for long-term maintenance and operation of each park developed and constructed under the terms of the Donation Agreement.

On June 6, 2011 the Board authorized the General Manager to submit three Proposition 84 Statewide Park Program grant applications for the second funding round of the Proposition 84 Statewide Park Program and supported the submittal of eight Proposition 84 Statewide Park Program grant applications by various organizations working in partnership with RAP (Board Report No. 11-167). Three of the eight grant applications that were submitted by organizations other than RAP were prepared and submitted by TPL.

On March 26, 2012, TPL received notification from the State that two of the three grant applications that it submitted were awarded funding under the second funding round of the Proposition 84 Statewide Park Program - Madison Avenue Park and South Victoria Avenue Park projects.

Under the terms of the Donation Agreement, TPL is required to develop a conceptual plan for each park project successfully awarded grant funding and present those plans to RAP for review and approval. Once RAP approves a project's conceptual plan, TPL will prepare a detailed set of final plans and specifications for that project, which will be submitted to the Board in a subsequent report.

The South Victoria Avenue Park – Park Acquisition and Development project proposes to acquire privately owned property located at 6537 South Victoria Avenue in the Park Mesa community of the City and develop the property with outdoor park and recreational improvements. The subject property, with APN 4006-019-014, measures approximately 0.26 acres. It is currently vacant and surrounded by residential housing.

The conceptual plan for the South Victoria Avenue Park – Park Acquisition and Development project includes the construction of a new playground, junior-size basketball court, skate spot, entry plaza, fitness equipment, shade structures, screen plantings, site furnishings, decorative fencing, irrigation, lighting and landscaping. The current concept for the project is depicted in Attachment A of this Report.

The State awarded TPL a total of \$2,236,630 in grant funding for this project. It is anticipated that this funding is sufficient to meet the project scope.

TPL currently has an option agreement to purchase the property at 6537 South Victoria Avenue from the private owner at its appraised market valuation using the grant funding awarded to the project. TPL's option agreement to purchase this site expires on September 26, 2012. In accordance with the terms of the Donation Agreement, TPL would then, subject to the approval of the Board, donate the property to RAP for use as a public park.

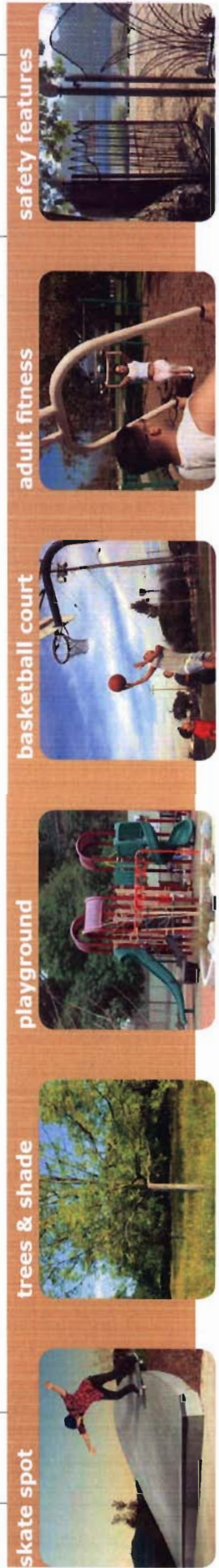
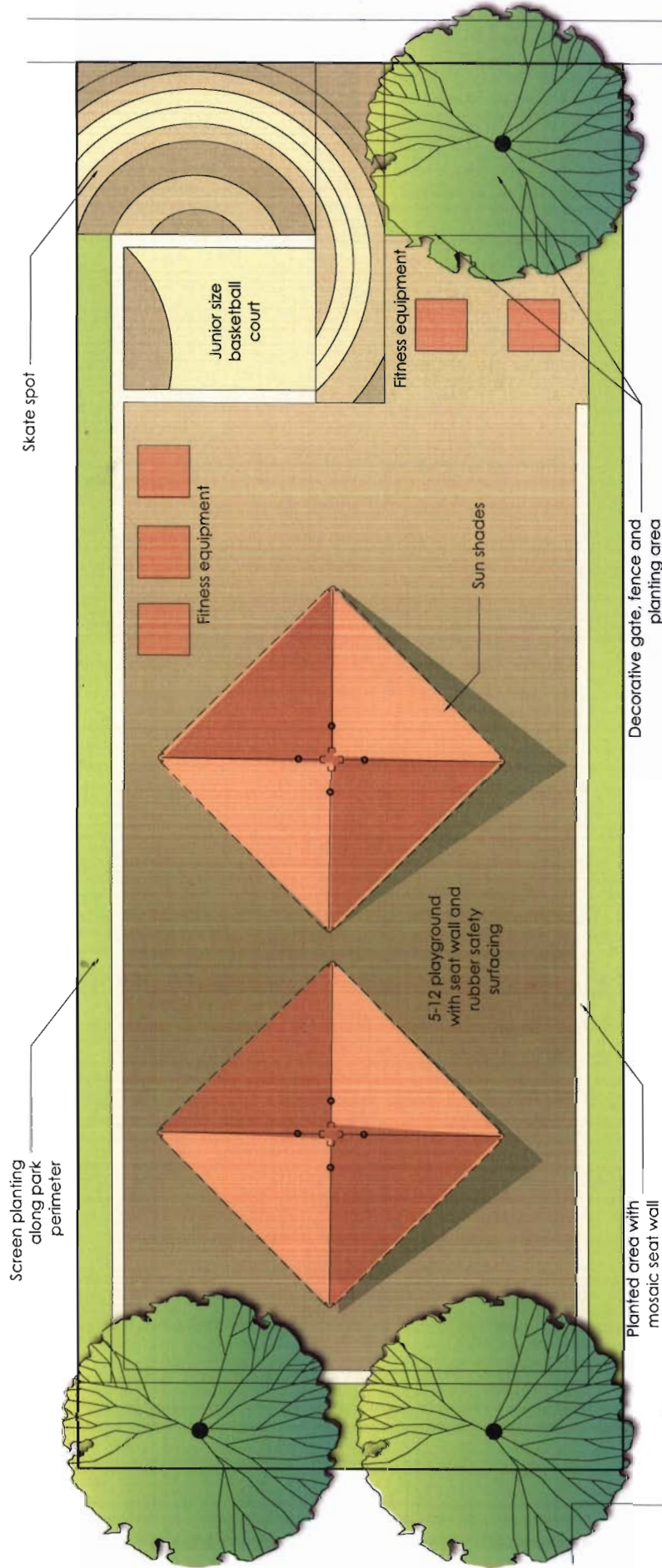
Staff has determined that the subject project will consist of the acquisition of land to preserve open space, and development of a new park with accessory structures including a new playground, junior-size basketball court, skate spot, entry plaza, fitness equipment, shade structures, screen plantings, site furnishings, decorative fencing, irrigation, lighting and landscaping. Therefore, the project is exempt from the provisions of the California Environmental Quality Act (CEQA) pursuant to Article III, Section 1, Class 3(6), Class 4(1,3) of the City CEQA Guidelines, and Article 19, Section 15325, Class 25(f) of the State CEQA guidelines.

FISCAL IMPACT STATEMENT:

The approval the conceptual plans for these projects will not have any impact on the General Fund. The development of these projects is anticipated to be funded by the awarded grant funds or funding sources other than RAP's General Fund. The estimated annual maintenance cost for this project has not yet been determined.

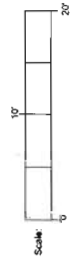

SUMMARY:

On November 7, 2006, California voters passed the "Safe Drinking Water, Water Quality and Supply, Flood Control, River and Coastal Protection Bond Act of 2006" (Proposition 84), which authorized \$5.4 billion in general obligation bonds for a number of State grant programs. One of the grant programs created is the Statewide Park Program. This program received a total of \$368 million for projects that demonstrate the creation of new park and recreation facilities in proximity to the most critically underserved communities throughout California on a competitive basis in two rounds (\$184 million available each round).

The Round One Request for Proposals for the Statewide Park Program was released in September 2009. At its meeting of February 20, 2010, the City Council authorized the Community Redevelopment Agency of Los Angeles (CRA/LA) to submit grant applications for the La Mirada New Park, Ord and Yale Street New Park, and Nevin Avenue Elementary School Park projects (Council File No. 09-2839). In November 2010, the CRA/LA was awarded a Proposition 84 grant for each of these projects. However, in January 2012, the CRA/LA was dissolved. As a result of the dissolution, the Department of Recreation and Parks (Department) was asked to assume the grants and complete the projects on behalf of the City of Los Angeles (City).

To complete the assumption of these grants, the State Office of Grants and Local Services has requested that the City submit by August 31, 2012, a City Council approved Resolution approving the grant applications and accepting the transfer of the grants to the City.

The scope of work involved and status of each of the projects is as follows:

- La Mirada New Park – Create the new La Mirada Park in the City of Los Angeles through the development of a 0.17 acre parcel, including the construction of a new path, lawn area, gathering space, play area, native and seasonal garden, streetscape and perimeter edge, and public art. A summary of the project scope and project concept is attached to this Report as Exhibit Nos. 1A and 1B. On April 21, 2010, the Board of Recreation and Park Commissioners (Board) accepted transfer of \$413,000 in Assembly

Bill 1290 (AB 1290) funds from the CRA/LA for acquisition costs and authorized the acquisition of the property located at 5401 La Mirada Avenue, Los Angeles, CA 90029, for this project (Board Report No. 10-095). The deed was recorded on April 26, 2010, and thus the City/Department now owns the property. The project is currently in the pre-design phase. The original Proposition 84 grant application submitted by the CRA/LA was for \$1,223,300, which included funding for the acquisition of the site. The CRA/LA had intended that the AB 1290 funds for acquisition would be reimbursed with Proposition 84 funds. However, the reimbursement did not occur prior to the CRA/LA being dissolved. Thus, the State has eliminated \$413,000 in funding for acquisition from the grant award. Therefore, the grant amount that will be transferred to the City for development of the site is \$810,300.

- Ord and Yale Street New Park – Create the new Ord and Yale Street Park in the City of Los Angeles through the development of a 0.58 acre parcel, including the construction of a new playground, fitness zone, plaza and performing arts space, fitness trail, upper viewing terrace, restroom, and related amenities. A summary of the project scope and project concept is attached to this Report as Exhibit Nos. 2A and 2B. This project will be part of the Proposition K Alpine Recreation Center Expansion project for which Proposition K funds were specified in the Ballot Measure to be used solely for the acquisition of property to expand the existing Alpine Recreation Center. The Proposition 84 grant amount to be transferred to the City is \$4,999,705. The acquisition portion of the Ord and Yale New Park project's original scope will be funded using Proposition K funds in an amount up to \$1,212,013. Geotechnical and site assessment due diligence, CEQA compliance, and acquisition negotiations are currently in process for the Ord and Yale New Park (aka Alpine Recreation Center Expansion project).
- Nevin Avenue Elementary School Park – Create the new Nevin Avenue Elementary School Park in the City of Los Angeles through the acquisition and development of 0.26 acres, including the construction of a new entry plaza and picnic area, children's playground, fitness zone, interactive plant and water demonstration garden, botanical learning garden, walking trail, "rolling" hill, and an indoor/outdoor learning/community center. A summary of the project scope and project concept is attached to this Report as Exhibit Nos. 3A and 3B. The Proposition 84 grant amount to be transferred to the City is \$2,898,340. Site assessment due diligence, CEQA compliance, and acquisition negotiations are currently in process for this project.

The Department's Planning, Construction, and Maintenance Division staff have worked in cooperation with the concerned Council District Offices, Mayor's Office, City Administrative Officer, Chief Legislative Analyst, and CRA/LA representatives to assess the viability of these projects and have determined that these projects are viable. The Department is able to complete these projects by the 2017 grant deadline as the Proposition 84 awarded funds are believed to be

sufficient to complete the above scopes with the exception of the Ord and Yale New Park project, which requires Proposition K funding for acquisition for expansion of the Alpine Recreation Center as described above. There are no known challenges to completing the three projects anticipated at this time.

Assuming Board approval of the recommendations in this Report, the appropriate recommendations will be submitted to the City Council for consideration and approval. Thereafter, the State will prepare that grant contracts for each project and will submit the contracts to the City/Department for review and execution which will constitute the City acceptance of the grants. However, prior to execution of the grant contracts, pursuant to the City's Grants Ordinance, the Department will transmit to City Council a request for final authorization to accept each of the grants. The recommendations in this report if approved by the Board constitute the Board's authorization to accept the grants and execute the grant contracts. Therefore, actions relating to final acceptance of the grants will only be submitted to the Board for these three projects if Board action is required regarding any additional funding necessary to complete any of the projects or regarding CEQA compliance.

ENVIRONMENTAL REVIEW:

Prior to undertaking the activities for which each grant is being sought, as lead agency for the projects, the Department must perform, complete, and certify the adequacy of the environmental review in accordance with the California's Environmental Quality Act (CEQA). The La Mirada New Park project was determined to be categorically exempt under CEQA in April 2010 as part of the acquisition phase (see Board Report No. 10-095). The appropriate CEQA documentation for the Ord and Yale Street New Park and the Nevin Avenue Elementary School Park will be completed and submitted in accordance with the terms of the grant contract.

FISCAL IMPACT STATEMENT:

The assumption, transfer, and submission of grant applications, approval of authorizing resolution and resolution accepting the designated projects has no fiscal impact on the Department's General Fund. However, future operations and maintenance costs after project completion, which is estimated to be in fiscal year 2017 are currently unknown.

WHEREAS, the City of Los Angeles (City) now desires to assume and accept the transfer of said grant for implementation of the subject project by the City's Department of Recreation and Parks (Department), thereby becoming the applicant for said grant; and

WHEREAS, the City/Department as applicant will enter into a contract with the State of California to complete the grant scope project.

NOW, THEREFORE, BE IT RESOLVED that the City Council hereby:

Approves the assumption, transfer and filing of an application for the Nevin Avenue Elementary School Park project, and

1. Certifies that said applicant has or will have available, prior to commencement of any work on the project included in this application, the sufficient funds to complete the project; and
2. Certifies that the applicant has or will have sufficient funds to operate and maintain the project; and
3. Certifies that the applicant has reviewed, understands, and agrees to the General Provisions contained in the contract shown in the Grant Administration Guide; and
4. Delegates the authority to the General Manager, Executive Officer, or Assistant General Manager, City of Los Angeles Department of Recreation and Parks, to conduct all negotiations, sign and submit all documents, including, but not limited to applications, agreements, amendments, and payment requests, which may be necessary for the completion of the grant scope; and
5. Agrees to comply with all applicable federal, state and local laws, ordinances, rules, regulations and guidelines.

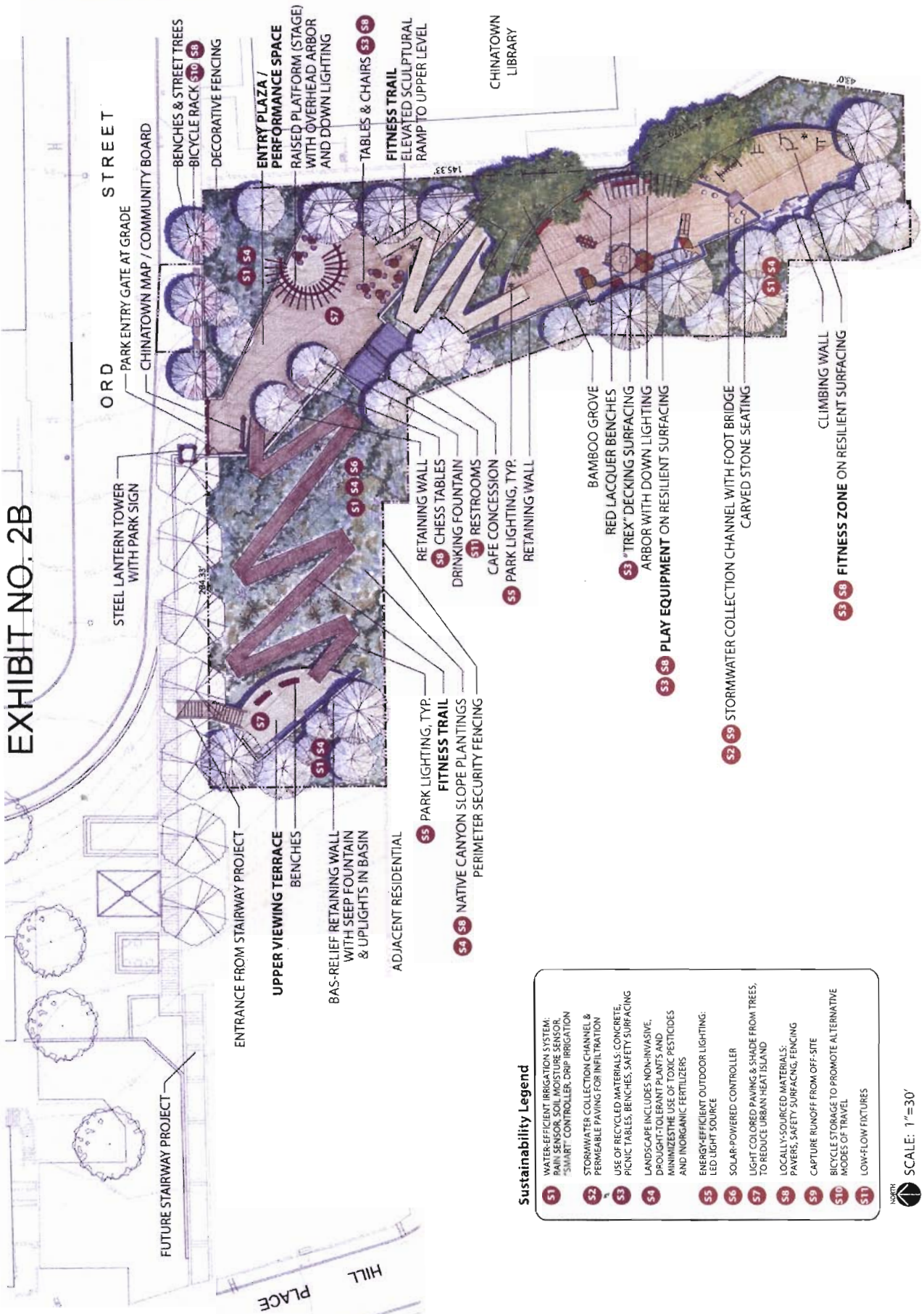

RECOMMENDATIONS:

That the Board:

1. Approve a proposed Personal Services Contract between the City of Los Angeles Department of Recreation and Parks and International Environmental Corporation, substantially in the form on file in the Board Office, to provide tree trimming and removal services at various city parks and facilities, for a period of one (1) year, with two (2) one-year renewal options, at the sole discretion of the General Manager, with total compensation not to exceed \$500,000 per year, subject to the approval of the Mayor, City Council, and of the City Attorney as to form;
2. Waive informalities, in accordance with Charter Section 371(c) and Los Angeles Administrative Code Section 10.15(c), for the three of the four submitted proposals;
3. Find, in accordance with Charter Section 1022, that the Department does not have personnel available in its employ with sufficient time and expertise to undertake these specialized tasks and that it is more feasible to secure these services by contract;
4. Direct the Board Secretary to transmit the proposed Personal Service Contract, concurrently, to the Mayor in accordance with Executive Directive No. 3 and to the City Attorney for approval as to form; and,
5. Authorize the Board President and Secretary to execute the Personal Service Contract upon receipt of the necessary approvals.

SUMMARY:

The Department of Recreation and Parks requires additional tree trimming personnel each year on an as-needed basis to assist with timely tree trimming and removal of unstable park trees for safety purposes. As the last contract for tree trimming and removal services was extended to expire in 2009 (Board Report No. 08-307), a RFP was approved for release in 2009 (Board Report 09-138). Due to economic uncertainties, the 2009 RFP, with the seven (7) proposals received, was held for sixteen (16) months pending instruction to proceed. The seven (7) proposals were rejected in 2011, due to proposed price aging, and the RFP was approved for re-release in order to select a responsible and qualified contractor to enter into a one (1) year contract with two (2) one-year options to renew at the sole discretion of the General Manager for a Personal Service Contract not to exceed a total contract amount of \$500,000 per year. (Board Report No. 11-059). The need for additional tree trimming and removal services personnel was required on an emergency basis, due to the wind storms of December 2011. The proposals received in response to the 2011 RFP had not yet been reviewed; consequently, the emergency services were paid with Board approval in April 2012 (Board Report No. 12-098).

The RFP was released on March 8, 2011 and advertised in the L.A. Daily Journal, the Chinese Daily, The Korea Daily and La Opinion. The RFP was also made available on the Department's website and posted on the Los Angeles Business Assistance Virtual Network (BAVN). In addition, a letter inviting bids was mailed to over thirty (30) organizations and individuals from a mailing list maintained by the Service Contracts Group.

On May 4, 2011 a Pre-Proposal conference was attended by eight companies. Four proposals were received on June 21, 2011.

- International Environmental Corporation
- So. Cal Tree Care, Inc.
- West Coast Arborists, Inc.
- Oakridge Landscape, Inc.

As stipulated in the RFP, evaluation of the bid proposals was to occur in two levels. Level I would be a check and review of all documents submitted for required compliance and Level II would be a comprehensive evaluation of the proposal, with interviews, by an evaluation panel. Proposers must successfully pass the first level to proceed to the next level.

Level I Evaluation

Staff performed a Level I review of the following required documents:

Proposals are either Responsive (pass) or Non-Responsive (fail). The following are the complete Level I findings:

- International Environmental Corporation was found responsive in eight compliance documents, non-responsive in one submittal document (Experience and Qualifications), and responsive in four submittal documents (Attachment A-1 and A-2).
- So. Cal Tree Care, Inc. was found responsive in eight compliance documents, non-responsive in two submittal documents (Cover Letter and Experience and Qualifications), and responsive in three submittal documents (Attachment B-1 and B-2).
- West Coast Arborists, Incorporated was found responsive in eight compliance documents, non-responsive in two submittal documents (Cover Letter and Experience and Qualifications), and responsive in three submittal documents (Attachment C-1 and C-2).
- Oakridge Landscape, Incorporated was found responsive in seven compliance documents, non-responsive in one compliance document (Good Faith Effort Subcontractor Outreach), responsive in four submittal documents, and non-responsive in one submittal document (Experience and Qualifications) (Attachment D-1 and D-2).

Staff reviewed the Compliance Documents submitted by the Oakridge Landscape, Incorporated and determined that the proposal did not pass the Good Faith Effort Subcontractor Outreach (GFE) portion of the RFP as required by Mayor's Executive Directive No. 2001-26 and the Board's Policy (Board Report No. 177-89). The proposal submitted by Oakridge Landscape, Incorporated is found to be non-responsive to the RFP.

On October 31, 2011, the four (4) proposers were given the reasons they did not pass the Level I evaluation and were advised they could either request a review of their submitted proposal or submit the missing documents, and that the acceptance of submitted missing documents was pending final determination by the Board of Recreation and Park Commissioners and City Attorney to determine if these informalities may be waived as per Los Angeles City Charter Section 371 (c). The three proposers found non-responsive to only the Submittal Documents requirement, subsequently provided all missing documents by November 28, 2011. Therefore, Staff recommends that the Board waive the late submission of Level I Submittal documents as informalities for three proposers, International Environmental Corporation, So. Cal Tree Care, Inc. and West Coast Arborists, Incorporated.

On February 1, 2012, an evaluation panel composed of two Department employees and one City of Los Angeles, Department of Public Works, Division of Street Tree Services employee, all with extensive Forestry, Tree Trimming and Removal expertise, interviewed the three proposers and evaluated the proposals for the Level II evaluation. The panelists were:

- Laura Bauernfeind – Principle Grounds Maintenance Supervisor II for the Department of Recreation and Parks
- Steve Dunlap – Tree Surgeon Supervisor II for the Department of Recreation and Parks
- Ronald Tull – Tree Surgeon Supervisor I for the Department of Public Works

Each proposal was scored in the areas of Experience and Qualifications (50 points possible, with the Best Proposal receiving 50 points, the Second Best receiving 47-49 points, the Third Best receiving 44-46 points); Tree and Palm Trimming or Pruning Pricing Plan and Tree Removal Pricing Plan (25 points possible for each both Pricing Plans with ranking was based on competitiveness of pricing plan relative to other proposals submitted. Each and every item price in RFP Exhibit E - Pricing Plan Addendum No. 2 was equally weighted for the ranking exercise and the weighting was multiplied by proposed price per tree and for each item and the products totaled to come up with an annual total cost. The annual cost for each of the three years was totaled. The pricing plan producing the lowest cost over three years was ranked number one. The Best Pricing Plan receiving 25 points, the Second Best receiving 22-24 points, the Third Best receiving 19-21 points. The averaged scores are as follows:

Award

International Environmental Corporation received the highest Averaged Total score. Staff reviewed the responsive proposals, verified background and experience and finds that International Environmental Corporation is a responsible and capable company whose proposal best meets the needs of the Department.

International Environmental Corporation (IEC), located in Panorama City, California, has been in business since 1986 and has provided services to The City of Los Angeles Department of Water and Power, the Los Angeles City Fire Department, Los Angeles County, and numerous other organizations, including the LA Metro Transportation Authority, Department of Veterans Affairs, Caltrans, and numerous other municipalities over the past 27 years. IEC currently consists of 28 full time employees and specializes in tree pruning, tree removal, tree planting, tree diagnosis with emergency response available for these services.

So. Cal Tree Care, Inc., located in Escondido, California, has been in business since 2005 and has provided services to the City of Los Angeles Public Works Department, Los Angeles County and numerous other organizations including the City of San Diego, the City of Palm Springs as well as State of California work and county work in San Bernardino, Orange and San Diego Counties. This company consists of 28 full time employees, provides tree care services, offers roof and rain gutter cleaning, concrete leveling and landscape maintenance service.

West Coast Arborists, Inc., located in Anaheim, California, has been in business since 1972 and has provided services to more than 200 California Municipalities and various public agencies from their office and service yards in Anaheim, Stockton, San Jose, Fresno, San Diego, Ventura and Riverside. The company consists of 600 full time employees and offers tree pruning, tree removal, tree planting, 24 hours tree emergency response, tree watering, small tree care, webpage development and master street tree pruning programs.

It is recommended that a contract to provide Parkland Tree Trimming and Removal at Various City Parks and Facilities be awarded to International Environmental Corporation for their proposal, in an amount not to exceed \$500,000.00 per year, for a term of one year with two (2) one-year options to renew, exercisable at the sole discretion of the General Manager.

Charter Section 1022

Los Angeles City Charter Section 1022 prohibits contracting out work that could be done by City employees unless the Board determines it is more economical and/or feasible to contract out the service.

On October 23, 2008, the Personnel Department completed a Charter Section 1022 review (Attachment E) and determined that there are City classifications that could provide as-needed tree trimming and removal services.

The ability of the Department to immediately respond to emergency situations (i.e., fallen trees and tree limbs) and protect the public, staff, and Department-owned facilities from harm currently exceeds staff availability. The certifications required to trim and remove trees makes it extremely difficult to hire qualified staff on a temporary basis in order to provide as-needed service. The recent damage caused by the December 2011 wind storms demonstrates the need for an as-needed contract to supplement existing City forces in order to quickly assess damage and remove fallen trees and tree limbs. It is therefore more feasible to secure these services through an independent contractor.

FISCAL IMPACT STATEMENT:

Funding for this service will be provided from various sources: Fund No. 302, Department 88, Account 3040 (Forestry Division; CLASS Parks; Waste Stream Diversion; Venice Beach Palm Tree Trimming) and the Golf Surcharge Account, Fund No. 302, Department 89, Account 3040.

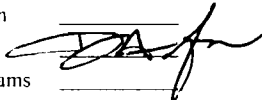

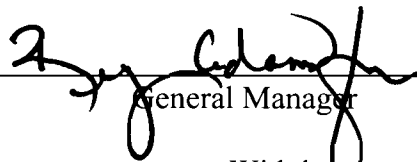

RECOMMENDATIONS:

That the Board:

1. Hold a hearing to determine whether to approve or deny the substitution of Andy Quioco Concrete as a subcontractor on the Culver Slauson Recreation Center – Phase II (Youth Community Center) (PRJ20550) (W.O. #E1907289) project as requested by Nile Advanced Construction, Inc. (NAC), the prime contractor, pursuant to Los Angeles Administrative Code (LAAC) Section 10.14.3, inasmuch as a letter of objection was received; and,
2. Approve the request for substitution, pursuant to LAAC Sections 10.14.3(c) and (f), the prime contractor, Nile Advance Construction, Inc. has demonstrated to the Board’s satisfaction that Andy Quioco Concrete, “the listed subcontractor has failed or refuses to perform its subcontract” with the prime contractor and such failure or refusal of the “subcontractor is substantially delaying or disrupting the progress of the work.”

SUMMARY:

LAAC Section 10.14.3 states in part that “No prime contractor whose bid is accepted may substitute any person as subcontractor in place of the subcontractor listed in the original bid or offer except in the following instances:

- (c) When the listed subcontractor fails or refuses to perform its subcontract.

- (f) When the awarding authority determines that work being performed by the listed subcontractor is substantially unsatisfactory and not in substantial accordance with the plans and specifications, or the listed subcontractor is substantially delaying or disrupting the progress of the work.”

On June 22, 2012, June 26, 2012, and again on June 29, 2012, the Bureau of Contract Administration (BCA) of the Department of Public Works received written requests from Nile Advanced Construction, Inc. (NAC), the prime contractor for the Culver Slauson Recreation Center – Phase II (Youth Community Center) (PRJ20550) (W.O. #E1907289) project, Contract No. 3361, requesting permission to substitute its approved listed subcontractor, Andy Quiocho Concrete, with their own forces for the remaining portion of work on this project (Attachment 1). Based on the information provided by NAC, BCA staff is recommending that the Board approve the subcontractor substitution request pursuant to LAAC Sections 10.14.3 (c) and (f). According to the letters to BCA, NAC stated that:

1. Prime contractor terminated its subcontract with Subcontractor because subcontractor was in default in completing their work in accordance with the construction schedule due to lack of equipment, lack of forming materials and lack of masonry materials. (Letters dated 6-22-12 and 6-29-12)
2. It was reported to the prime contractor’s project manager represented that the subcontractor “failed to make payments to their workers involved in the project...” resulting in the workers refusing to show up to the job site to do the work. (Letters dated June 22, 2012 and June 26, 2012)
3. The subcontractor “withdrew from the work at the job site disregarding (the prime contractor’s) various requests to complete the work.” (Letter dated June 26, 2012)

These issues have prevented the progression of construction activities in a timely manner.

On June 27, 2012, the Department provided written notification via certified mail and email to Andy Quiocho Concrete of the substitution request (Attachment 2). The Department, on June 29, 2012, received a timely written objection to the substitution via email from Andy Quiocho (Attachment 3). In accordance with Section 10.14.3, "if written objections are filed, the awarding authority shall give five days' notice to the prime contractor and to the listed subcontractor of a hearing by the awarding authority on the prime contractor's request for substitution. The determination of the awarding authority shall be final."

In the letter received via e-mail on June 29, 2012, Andy Quiocho Concrete contests the substitution, stating that NAC terminated the subcontract “prior to receiving the necessary

authorization to do so.” Issues to be considered by the Board during the hearing will include whether the subcontractor can complete the remaining portion of concrete work, and whether pursuant to Los Angeles Administrative Code Section 10.14.3 factual circumstances exist that satisfy the conditions specified in the Code to approve or deny the substitution request made by the prime contractor.

The Bureau of Contract Administration has recommended approving the request for substitution.

FISCAL IMPACT STATEMENT:

The approval or denial of the substitution request will not alter the contract amount and therefore has no impact on the Department's General Fund.

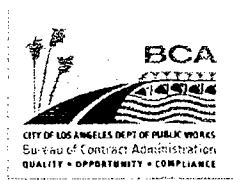

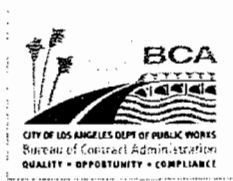

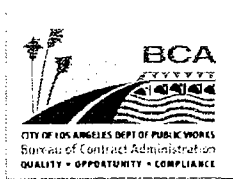

We refer to previous correspondence on the above subject and would like to clarify the breakdown of Quiocho Concrete's contract value of 159,098 as follows:

- Theo cost of the concrete flat work \$ 60,000
- Concrete work needed in respect for light pole foundations as part of the electrical subcontractor's subcontract to be coordinated between Quiocho Concrete and the electrical subcontractor.
- The Masonry work to be coordinated between Quiocho Concrete and their mason subcontractor.
- Concrete work for the palyground equipment area (Nile Advanced).
- The steel rebar work that was included in Quiocho's subcontract since the steel rebar contractor was firstly withdrawn from the project therefore such work was agreed to be done by Quiocho Concrete, however such amount is to be deducted from Quiocho 's subcontract on the ground that R & D Steel, the listed subcontractor changed their position and decided not to withdraw from the project.

Meanwhile it was agreed that a joint chech to include the name of Quiocho Concrete and the electrical subcontractor and the same is to be applied to R & D Steel.

On the other hand as mentioned before the total dollar amount for the work completed by Quiocho Concrete is \$ 57,438

- Quioco Concrete failed to provide us with the certified payroll in compliance with labor law requirement.
- They failed to make payments to their workers involved in the project that was reported to us by their workers.
- Quioco Concrete withdrawn from the work at the job site disregarding our various requests to complete their work.
- Nonpayment of their supplier's dues.

Please note that we have no objection that quioco Concrete may complete their work in the project on the condition that they satisfy the labor code, to have a proof of payments of the back wages due to their workers and, to obtain releases from their suppliers for the materials they have ordered on the project.

We would appreciate reconsidering granting us a temporary approval in respect of this critical path for the concrete pouring at this stage and you may please hold any further approval until the hearing is finalized.

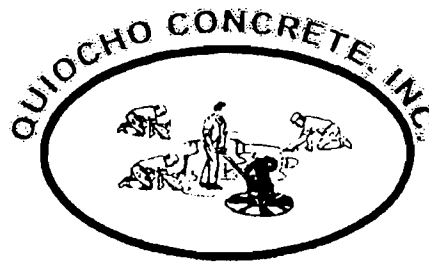

Dear Mr. Reamer;

We received your letter today regarding Nile Advanced Construction's request for substitution of Quiocho Concrete's subcontract agreement with them on the Culver-Slauson Recreation Center project.

We do not agree with the request and believe Nile Advanced Construction (NAC) is in violation of the California Public Works Codes. On May 29th, we received a letter from NAC's Attorney, Lisa Stepanski, which terminated our subcontract agreements on both projects we had with NAC; I have included the letter for your review. NAC did not follow the procedure set forth in the Public Works Contract Code when they terminated our subcontract prior to receiving the necessary authorization to do so. We further believe NAC may have violated the Subletting and Subcontracting code and prompt payment codes. Quiocho Concrete began work on January 17th and began communicating to NAC in March, our need to receive progress payments in order to pay our employees and suppliers. We did not receive a payment until April 30, 2012 which left us in an extremely difficult financial hardship; we requested copies of payments made for our scope of work on several occasions but were told by NAC it was not legal for them to provide us with those copies. The actions of NAC have caused Quiocho Concrete and our employee's devastating financial hardships and should be examined for possible violations against public funds.

We request a hearing to present our case and would like to state for the record that we have never intended to harm the City of Los Angeles and we are very sorry for the position this has put the City in.

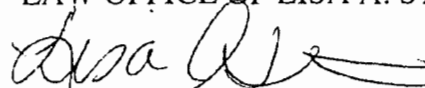
I appreciate your willingness to speak with me over the last few days, and your emails to me; however, last week NAC provided you with a notice to supply the job with labor and materials, which you refused. Furthermore, since you are accusing NAC of falsifying time and payroll records and NAC certainly denies such accusations, it is clear that the parties cannot get past their differences to get the job done. Additional communication, including a meeting with me, would be fruitless.

NAC has notified the Labor Compliance Board that there is a dispute as to how much is owed the various laborers and how much has been paid, as well as NAC's difficulties in determining the answers to these questions due to the inconsistencies and incompleteness in the paperwork.
