PARK FEE BOARD REPORT PUBLIC COMMENT

Public comments relevant to the Park Fee Board Report were invited, one such comment was provided. It was moved by Commissioner Halper, seconded by Commissioner Chase. There being no objections, the Motion was approved unanimously

COMMISSION TASK FORCE UPDATES

President Patsaouras reported that there were no Task Force Meetings this day and thus no updates to announce.

GENERAL MANAGER'S REPORT AND VERBAL STAFF UPDATES

Anthony-Paul Diaz, Executive Officer and Chief of Staff, announced that several RAP members attended the 2019 California Park & Recreation Society Conference and presented before other recreation and park systems from the state. Mr. Diaz also announced that RAP will be participating with Nike in an event to support the Department's GirlsPlayLA initiative. He also announced that Albion Riverside Park recently opened, and how proud RAP is to see this project come to fruition. Mr. Diaz announced that the Greek Theatre's 2019 Season Opener will be on April 13th. He then reported that RAP's GM and other senior management members recently met with the City's Ad Hoc Olympic Committee and presented RAP's plan for services and infrastructure updates related to the 2028 Olympics to take place in Los Angeles. Mr. Diaz

then reported that RAP recently participated in an outreach meeting with stakeholders for the First and Broadway (FAB) park development project. He also updated the audience about the upcoming Park Ranger interviews, as RAP looks to add staff in that class. Mr. Diaz mentioned that RAP recently met with LAFD to discuss further partnerships for brush clearance abatement to prepare for the upcoming fire season. He also communicated that RAP continues to meet with the Veterans' Affairs Department to ensure that RAP meets its goals and mandates regarding Barrington Park. Mr. Diaz closed by broadcasting that RAP will continue its community outreach as part of the Measure A grant application to expand services and facilities.

COMMISSION BUSINESS

Commissioner Halper requested an informational report on RAP's partnership with LAUSD to utilize school facilities to augment park programs in underserved communities. Commissioners Chase and Diaz requested a report back on the "hold harmless" clause in RAP's online court reservation system.
