President Patsaouras called for a motion to approve the minutes of the Regular Meeting of April 6, 2023. Vice President Alvarez made such motion, and it was seconded by Commissioner Chase. There being no objections, the motion was unanimously approved by a vote of 3-0.

# **GENERAL MANAGER'S UPDATE**

Jimmy Kim, General Manager, started his update by thanking all Recreation and Parks Board of Commissioners' for their support and dedication to this department. Mr. Kim also recognized all the volunteers to the department because it is national volunteer recognition week. Mr. Kim mentioned RAP launched our coach LA playbook. This playbook will give each coach the tools needed to provide the best experience for each youth. This event was hosted at Dodger's stadium.

Mr. Kim stated we will be hiring over 100 interns for various positions this summer through our City pathways for youth program. Mr. Kim stated registration for summer camp is now open. Over 120 Recreation facilities will offer summer camp activities. Mr. Kim mentioned our PlayLA spring sports league are still open for registration.

Mr. Kim shared a few upcoming events, today at the Travel town museum RAP will unveil an educational sign. On Saturday, April 22 nd at Augustus F. Hawkins nature park will celebrate earth day. On Saturday, April 29<sup>th</sup> El Sereno Arroyo Park will celebrate its 10<sup>th</sup> anniversary day of fun. On Saturday, May 6<sup>th</sup> our GPLA will be hosting its annual sports day at South Park and RAP will be

hosting the grand opening of West Lakeside Park. Pershing Square will celebrate a Cinco De Mayo event on May 6<sup>th</sup>.

Jimmy Kim, General Manager provided an update on looking into an Equine representative for the department. Mr. Kim mentioned a kickoff meeting with the pickle ball consultant that was held on April 11<sup>th</sup>. Mr. Kim stated the Griffith Park Pony Ride consultant went to RFP on April 3<sup>rd</sup> with the deadline for submissions on May 1<sup>st</sup>. Mr. Kim mentioned that RAP is working on an Agreement for Stoney Point currently with the City Attorney. Mr. Kim stated that RAP has made several repairs to Pedlow skate park. Mr. Kim stated Javier Solis, Superintendent of Maintenance met with the citizens of LA Mirada Park to address some of their concerns. Mr. Kim met with the Senior soft ball league from the Sepulveda Basin. Mr. Kim gave an update on our proposed Budget which has an increase of 19 million dollars.
