# **RECOMMENDATIONS**

- 1. Approve the newly proposed Department of Recreation and Parks' (RAP) Rates and Fees for the Wilmington Sports Complex, as set forth in Attachment 1 of this Report.
- Authorize RAP staff to amend RAP's Schedule of Rates and Fees to incorporate the proposed Rates and Fees for the Wilmington Sports Complex, to be effective upon approval of this Report.
- 3. Authorize RAP staff to make technical corrections to RAP's Schedule of Rates and Fees as necessary to carry out the intent of this Report.

# SUMMARY

The Wilmington Sports Complex (Complex) is located in Council District 15 in the Wilmington area of the City of Los Angeles. The Complex was recently leased to RAP by the County Sanitation District No. 8 of Los Angeles County, and it will be maintained and operated by RAP staff.

In addition to RAP's use of the Complex, RAP is also authorized to permit third parties to use certain areas of the Complex under permits issued by RAP. In connection with such use, RAP staff is proposing rates and fees for use of the Complex as set forth in Attachment 1 of this Report. These rates and fees mirror similar rates from RAP'S schedule of rates and fees for Youth Sports Groups, Municipal Sports and Synthetic Turf Soccer Fields.

# TREES AND SHADE

The approval of the proposed rates and fees for the Complex will have no impact on existing trees or shade at the Wilmington Sports Complex.

# FISCAL IMPACT

The proposed Rates and Fees for the Complex will provide needed revenue to the site.

The Wilmington Sports Complex would deposit 100% of the permit fees collected to the Facilities MRP account since the facility is on County of Los Angeles Sanitation property and requires fees charged to be used only at this facility.

# WILMINGTON SPORTS COMPLEX 2023

100% to be deposited into the center MRP Fund Account

Facility is on County of LA Sanitation property and requires fees charged to be used only at this facility

# **APPLICATION FEE:**

All permits issued for this facilities will be assessed a \$25.00 permit application fee.

Reservations require an advance deposit of 50% of total estimated fees.

# **FACILITY USE FEE:**

# YOUTH SPORTS ORGANIZATIONS AND ASSOCIATIONS operating a league\*

This fee applies to youth ages 17 years old and under (not individual teams) during their traditional regular season that have no restrictions to their registration of participants (other than age divisions). This fee does not apply to pre or post season play, tournaments, or all-stars, club teams, and/or travel teams.

#### **Tournament Fees**

A fee of \$40.00 per hour will be charged during the day and \$50.00 per hour at night for baseball, softball, flag football, and soccer or any multi-purpose field.

# PRIVATE YOUTH, SCHOOL TEAMS, ADULT USE \*\*

Including but not limited to: adult use, private, individual youth teams, travel teams, club teams, all-star teams, tournament teams, and use outside of traditional regular season (pre or post season play)

Private, non-profit sports leagues providing ongoing maintenance and repair of sports fields shall receive a \$5.00 per hour reduction of fees, as determined by the Principal Recreation Supervisor.

For Special events and fundraising events, the Region Superintendent may charge more depending on size and scope of the event - 20% may be non-refundable\*\*\*\*

# **CANCELLATION FEE \*\*\*\*\***

More Than 2 Weeks Prior to Event 50% Refund of Fees

Less Than 2 weeks Prior to Event No Refund of Fees

Department cancelations due to Rain days, Field maintenance, or Department need, will be credited or days rescheduled\*\*\*\*

Non-use of the field by organization is subject to the cancellation fee above\*\*\*\*

# **STAFF FEES**

If staff to monitor the fields is required for entire permitted time, permits issued will be assessed a staff fee per hour. Part-time staff fees are established in the GENERAL INFORMATION section. Staff fees may be reduced if only one staff is monitoring multiple fields. If staff is not required for entire permitted time, permits issued will be assessed an additional \$5.00 per hour for staff to open and close the restrooms.

At the discretion of the Region Superintendent, some events or activities may require additional maintenance, security, traffic control, and/or event monitor staffing, due to size, location, scope of activities, or other factors. Part-time staff fees are established in the GENERAL INFORMATION section. Full-time staff fees will be charged at the current overtime rate
