REGULAR MEETING MINUTES

BOARD OF RECREATION AND PARK COMMISSIONERS OF THE CITY OF LOS ANGELES

Thursday, August 17, 2023

The Board of Recreation and Park Commissioners of the City of Los Angeles convened the Regular Meeting at 9:33 a.m. Present were, Vice President Luis Sanchez, Commissioner Fiona Hutton, Commissioner Marie Lloyd and Commissioner Benny Tran. Also present were Jimmy Kim, General Manager, Matthew Rudnick, Executive Officer and Deputy City Attorney IV Steven Hong.

CALL TO ORDER

APPROVAL OF THE MINUTES

Vice President Sanchez called for a motion to approve the minutes of the Regular Meeting of August 3, 2023. Commissioner Lloyd made such motion, and it was seconded by Commissioner Hutton. There being no objections, the motion was unanimously approved by a vote of 4-0.

GENERAL MANAGER'S UPDATE

Jimmy Kim, General Manager, began his update by sharing that RAP's special update page is listed on our website. Mr. Kim gave some general updates for the department. He stated that our summer camp season has ended and our summer pool season will end on September 4, 2023. Mr. Kim stated our fall program registration are now open as well as our PlayLA youth and adaptive sports programs.

Mr. Kim mentioned there has been multiple shootings in the past couple months at our parks. Mr. Kim stated the department is working closely with LAPD, the Mayor's office, the Council offices and intervention officers to come up with a solution to reduce shootings in our parks. Mr. Kim mentioned that RAP is also providing assistance to staff by providing mental health counseling.

Mr. Kim provided brief updates on some of the constituent's concerns. Mr. Kim mentioned at Pedlow Skate Park staff has been in communication with the constituents to mitigate a lot of their concerns that have been brought to our attention. Mr. Kim stated that he has assigned the Maintenance division to follow up on the Westwood Gardens Park. Mr. Kim mentioned he requested that staff ensure that all events at Pershing Square end at the posted times. He also stated that during non-event times the park is open to the public. Mr. Kim stated that at Dearborn park they are still working on mitigating issues with illegal permitting. Mr. Kim mentioned that RAP will no longer host hybrid meeting beginning September 7, 2023 all public comments must be made in person.

Steven Tran provided the board with a Measure a Status update.
