RECOMMENDATIONS

- 1. Approve the reallocation of Quimby and Zone Change Fees from various capital improvement projects to their respective Quimby and Zone Change Fees accounts as detailed in Attachment 1 of this Report and authorize the Department of Recreation and Parks' (RAP) Chief Accounting Employee to transfer such fees to such accounts consistent with the approval of this reallocation;
- 2. Approve the reallocation of One Thousand, Nine Hundred Seventy Eight Dollars and Thirty Five Cents (\$1,978.35) currently allocated to the El Sereno Recreation Center Skate Park Renovation (PRJ20903) Project to the El Sereno Recreation Center Swimming Pool Mechanic Systems (PRJ20513) Project;
- 3. Authorize RAP's Chief Accounting Employee to transfer Seven Thousand, Three Hundred Two Dollars (\$7,302.00) in Quimby Fees from the Quimby Account No. 89460K-00 to the Algin Sutton Recreation Center 89460K-MC;
- 4. Approve the increase of the Zelzah Park Road and Parking Lot Improvement (PRJ1349B) Project's budget in the amount of Twenty-Nine Thousand, Eight Hundred Eighty Nine Dollars and Seventy Nine Cents (\$29,889.79) and approve the reallocation of Twenty-Nine Thousand, Eight Hundred Eighty Nine Dollars and Seventy Nine Cents (\$29,889.79) currently allocated to the Zelzah Park Outdoor Park Improvements (PRJ20352) Project to the Zelzah Park Road and Parking Lot Improvement (PRJ1349B) Project;

- 5. Approve the reallocation of Twelve Thousand, Two Hundred Eighty-Three Dollars and Fourteen Cents (\$12,283.14) currently allocated to the Zelzah Park Outdoor Park Improvements (PRJ20352) Project to the Zelzah Park Account No. 89460K-ZE; and,
- 6. Authorize RAP's Chief Accounting Employee to make technical corrections as necessary to carry out the intent of this Report.

<u>SUMMARY</u>

As a part of RAP's ongoing administration of the Quimby/Park Fee Program, RAP staff regularly reviews and reconciles projects funded with Quimby and Zone Change Fees and the related Quimby and Zone Change accounts funds. The goal of this regular review is to identify projects and accounts that need additional funding in order to enable completed projects to be accepted and closed out, and to reconcile those projects and accounts to balance the Quimby and Zone Change accounts.

RAP staff has identified various Quimby and Zone Change funded capital improvement projects that are complete, have been final accepted, and have funds available for reallocation to future projects. The projects listed in Attachment were previously identified in Report No. 22-288 as completed capital improvement projects with unexpended Quimby or Zone Change fees. Upon approval of this Report, the Quimby and Zone Change funds detailed in Attachment 1 can be reallocated and transferred to the Quimby Account No. 89460K-00, the Zone Change Account No. 89460K-00, or the facility account in order to be made available for future allocations.

Recommendation 2 is to correct a previous staff error for the El Sereno Recreation Center – Swimming Pool Mechanic Systems (PRJ20513) Project. RAP staff identified an error in which the amount of unexpended Quimby funds for the completed project that was subsequently reallocated and transferred did not account for a pending expenditure (Report No. 20-094). This reallocation of funds to the El Sereno Recreation Center – Swimming Pool Mechanic Systems (PRJ20513) Project will reconcile the negative project balance. Upon approval of this Report, One Thousand, Nine Hundred Seventy-Eight Dollars and Thirty-Five Cents (\$1,978.35) currently allocated to the El Sereno Recreation Center – Skate Park Renovation (PRJ20903) Project can be reallocated to the El Sereno Recreation Center – Swimming Pool Mechanic Systems (PRJ20513) Project.

Recommendation 3 is to balance the Algin Sutton Recreation Center Account No. 89460K-MC. After the reconciliation of the various projects within the account, RAP staff has determined that it is necessary to transfer Seven Thousand, Three Hundred Two Dollars (\$7,302.00) in Quimby Fees from the Quimby Account No. 89460K-00 to the Algin Sutton Recreation Center 89460K-MC to avoid a negative account balance.

Recommendation 4 is to correct an over expenditure for the Zelzah Park – Road and Parking Lot Improvement (PRJ1349B) Project, which was completed in 2004. Upon recent review of the Zelzah Park Account No. 89460K-ZE and the associated projects, staff identified expended funds that exceeded the budgeted amount for the Zelzah Park – Road and Parking Lot Improvement (PRJ1349B) Project. In order to correct this error, staff is recommending that the project budget be increased by the amount of the over expenditure and the reallocation of Quimby funds to the project to fund the over expenditure. Upon approval of this Report, Twenty-Nine Thousand, Eight Hundred Eighty-Nine Dollars and Seventy-Nine Cents (\$29,889.79) currently allocated to the completed Zelzah Park – Outdoor Park Improvements (PRJ20352) Project can be reallocated to the Zelzah Park – Road and Parking Lot Improvement (PRJ1349B) Project. The remaining unexpended amount of Twelve Thousand, Two Hundred Eighty-Three Dollars and Fourteen Cents (\$12,283.14) currently allocated to the completed Zelzah Park – Outdoor Park Improvements (PRJ20352) Project can be reallocated to the Zelzah Park Account No. 89460K-ZE in order to be made available for allocation to future projects.

These Quimby and Zone Change Fees allocations comply with the fee expenditure radii pursuant to Los Angeles Municipal Code Section 12.33 E.3.

It should be noted that no new Capital Improvement Projects are being approved as a part of this Report.

ENVIRONMENTAL IMPACT

The proposed recommendations for the Board of Recreation and Park Commissioners (Board) consists in transferring funds among accounts for projects that have already been completed, as well as transferring funds to reconcile discrepancies in various project accounts. Such action is not going to cause any direct physical change or any foreseeable indirect physical change on the environment, and does not fall under the definition of "project" included in Section 21065 of California Public Resources Code (PCR). Therefore it is not subject to the provisions of the California Environmental Quality Act.

FISCAL IMPACT

The final acceptance of the capital improvement projects and approval of the reallocation and transfers listed in this Report's Attachments and this Report will have no fiscal impact on RAP's General Fund.
