


Figure 1: Map of the Rim of the Valley Trail Projects



Scope of Work: The scope of work entails the installation of six equine crossings throughout Griffith Park. The crosswalks are proposed at the intersection of Condor Trail and Griffith Park Dr, at the intersection of Griffith Park Dr and Skyline Trail, and at the intersection of Rattlesnake Trail and Griffith Park Dr. Crossings with raised crosswalks are proposed at the intersection of Crystal Springs Dr and Cadman Trail, at the intersection of Crystal Springs Dr and Fire Rd, and at a location 100' south of the intersection of Fire Rd and Crystal Spring Dr. Culverts are to be installed along with the raised sidewalks to allow proper drainage. The scope also includes renovating the ramp at the eastern edge of Tunnel One and installing two equine crossing signals, at each end of tunnel.




Figure 10: Aerial view of Fire Rd southwesterly of Crystal Spring Dr




Figure 14: Map of Mulholland Core Trail
