REFERRAL FOR AGENDA ITEM NO. 6: REQUEST TO ADOPT THE HIKING AND EQUESTRIAN TRAILS MASTER PLAN

The Los Angeles Equine Advisory Committee (LAEAC) unanimously agreed at their February 23, 2010 meeting that the 1968 Hiking and Equestrian Master Plan needs updating. Not only does this Master Plan affect 17 of the City's 35 Community Plans, but it also needs to be updated to reflect the growing number of National Historic and National Recreational Trails within the City. An updated Master Plan is essential for future projects to be eligible for both State and Federal funding.

A major issue of concern today is that of childhood obesity. Lack of open space and lack of exercise contribute to this problem. Incorporating innovative green spaces throughout the City is part of the solution.

More than just a recreational geature, greenways can provide passive connections to different locations in the community and encourage walking on a natural, permeable surface. A 20-foot wide trail easement creates an acre of open space for every 264 feet in length, and can extend an outdoor experience to hundreds of families.

We understand that there are no planning funds available for a new study of trails. However the LAEAC would like to propose a partnership based on the Adopt-A-Park model. Additionally, Proposition K has set aside \$2 million dollars for Rim of the Valley development. The National Park Service has begun the process of conducting its federally funded National Resource Study for Rim of the Valley. Projects are eligible for both State and Federal appropriations for the design and building of trail systems.

The LAEAC would consolidate existing information, be responsible for public outreach, and catalogue community input for the planning and construction of equestrian trails. The LAEAC would also like to discuss the possibility of having a member of your advanced planning staff serve as a facilitator for trail planning to oversee our efforts in updating the Hiking and Equestrian Trails Master Plan.
