Job Duties

- Ensure all safety protocols, policies, and procedures are implemented and followed at all times
- Communicate effectively with all participating entities (participants, parents, coordinator, volunteers, staff)
- Ability to adapt to change and maintain professionalism while following directions given by Aquatics and/or Parks management
- Conduct and perform the following: parent/camper meeting, participant evaluations, assign training groups and training times,
- Organize trip rosters, check-in and check-out participants/equipment
- Promote program involvement through the discovery of kayaking by utilizing best practice methods and a progressive step-by-step approach
- Assist with additional duties as needed for the effectiveness of the program
- Ability to participate in all related activities: walking/standing for long periods of time, squatting, kneeling, lifting/carrying up to 50lbs of equipment, standing in inclement weather, 4-6 hours of sun exposure
- Ability to work at various sites in Los Angeles and transport participants to different locations



About the Program: Learn-to-Kayak is a new program for Summer 2023. Youth will be taught about open water safety, equipment, and provide a bridge to the sport of kayaking for Angelinos ages 9-17 years old. The program strives to provide opportunities for Angelinos to experience an open water Olympic sport as well as techniques to build self awareness, self-esteem all while making friends and most importantly having fun.

QUALIFICATIONS

- Strong background in kayaking equipment, including teaching progression, current techniques, and understanding of open water safety
- 2 years or more of consistent kayaking experience, coaching/teaching in an individual or group capacity and teaching kayaking classes to youth aged 9-17

As a condition of employment and under close supervision of Citywide Aquatics Team Sports Coordinator and Aquatic Facility Manager, a Recreation Instructor must attend all in-service trainings, workshops, and be available to work for the entire season. Work assignment is restricted to the Learn-to-Kayak program unless given approval by the program coordinator.

REQUIREMENTS

1. **AGE:** 18 years of age by hiring date; proof of age with Driver's License will be required during the interview
2. **CERTIFICATION:** A Recreation Instructor must maintain a valid California Driver License throughout the course of employment.
3. **EXAMINATION**
 - WRITTEN SUBMISSION: Qualifying**
 - Cover Letter - Detailing why you are interested in being a kayak instructor for Learn to Kayak Program
 - Resume - Detailing qualifications for the position
 - ORAL INTERVIEW: Weighted 100%**
4. Candidates that meet the qualifications will proceed to the application submission.
