Recreation and Park's Licensed Preschool Program is currently hiring Recreation Assistants throughout Los Angeles to work at our newly opening preschool sites. Staffing placements will be prioritized for facilities currently open or scheduled to open soon.

**Description of Duties:** Preschool Teacher

- Organizes, conducts and supervises activities for children ages 2 to 6 years of age
- Responsible for creating and implementing monthly/weekly lesson plans.
- Assist in program marketing; recordkeeping and preparing related reports.
- Makes recommendations regarding the acquisition or replacement of supplies.
- Set-up facility for special events, classes and activities.
- Adheres to City and departmental policies and procedures; performs related duties as required.

Pursuant to City of Los Angeles Ordinance No. 187219, beginning Monday, November 29, 2021, PROOF OF COVID-19 VACCINATION will be required for individuals eligible for COVID vaccination to enter all indoor LA Parks facilities. All individuals that are eligible for COVID vaccination participating in indoor programming must show PROOF OF COVID-19 VACCINATION.
