The Department of Recreation and Parks is recruiting a Special Program Assistant II (SPA II) for Citywide Aquatics, located at the Central Service Yard (CSY), 3900 Chevy Chase Drive, Los Angeles. SPA II's are part-time, at-will employees throughout the City of Los Angeles.

**HOURS:** Looking for someone who can work 16-20 hours per week, depending on operational needs.

**DESCRIPTION OF DUTIES:** Maintain the Citywide Aquatics Office (mostly indoor), perform custodial functions (cleaning the building, individual offices and conference room, restrooms, kitchen and public areas), remove litter and empty all trash receptacles.

QUALIFICATIONS: Must possess a valid California Driver's license and a good driving records; must be available to work 16-20 hours during the week (morning and/or afternoon); must be responsible, dependable, and have a "can-do" attitude; ability to understand and follow direction; ability to work under minimal supervision; ability to get along well with others and be a team player; ability to safety use cleaning products; some knowledge and experience in custodial duties is highly desirable.
