SEASONAL POOL MANAGER I

This position is exempt from civil service.*

THIS EXAMINATION IS GIVEN TO FILL SUMMER 2022 SWIMMING POOL POSITIONS ONLY

SALARY: \$22.57/hour (The current salary is subject to change. You may confirm the starting salary with the hiring department before accepting a job offer.)

DUTIES: Lead aquatic facility staff; act as a lifeguard; assist in the operation of a municipal pool and is in charge in the supervisor's absence; conduct swimming and lifesaving classes; organize and coach water sports; organize and lead aquatic camp, develop, direct and promote the activities of a municipal swimming pool; and instruct in swimming and lifesaving techniques.

As a condition of employment, a Pool Manager I must attend all in-service trainings and must work a minimum of 40 hours (does not include paid training time such as orientation; HO, CPTO/VC, PL or SK Hours) between Opening Day and Labor Day (6/12/22-9/5/22) in order to continue employment with Citywide Aquatics (after Labor Day).

REQUIREMENT(S)/MINIMUM QUALIFICATIONS:

CURRENT LA CITY LIFEGUARDS:

- Complete Interview
- Attend all mandatory manager trainings

OUTSIDE APPLICANTS:

- Complete Interview
- Strong background in aquatics and/or lifesaving is strongly desired but not required; and,
- Pass Los Angeles City Lifeguard Test Lifeguard test which consists of a 70 Foot Dummy Tow Swim and 200 Yard Lifeguard Medley; and
- Complete the LA City Lifeguard Academy
- Attend all mandatory manager training prior to June 12, 2022.
