### SEASONAL POOL MANAGER II

(Code No. 2408)

This position is exempt from civil service.\*

#### THIS EXAMINATION IS GIVEN TO FILL SUMMER 2022 SWIMMING POOL POSITIONS ONLY

**SALARY:** \$29.65/hour (The current salary is subject to change. You may confirm the starting salary with the hiring department before accepting a job offer).

**DUTIES:** Supervise the operation of a municipal pool; train and supervise aquatic facility staff; act as a lifeguard; develop, promote, direct and conduct pool programs in swimming, lifesaving, swim team, springboard diving, synchronized swimming, and water polo; enforce rules, policies and codes related to municipal swimming pool operations.

As a condition of employment, a Pool Manager II must attend all in-service trainings and must work a minimum of 40 hours (does not include paid training time such as orientation; HO, CPTO/VC, PL or SK Hours) between Opening Day and Labor Day (6/12/22-9/5/22) in order to continue employment with Citywide Aquatics (after Labor Day).

#### REQUIREMENTS:

##### CURRENT LA CITY LIFEGUARDS

- Two (2) seasons as a Pool Manager I with the City of Los Angeles
- Completion of the American Red Cross Lifeguard Management – Online Course by June 1, 2022
- Attend all mandatory manager trainings

##### OUTSIDE APPLICANTS

- Two (2) full seasons paid experience at the level of a Pool Manager and/or lead lifeguard; and,
- **American Red Cross Lifeguard Management** – online course - Due by June 1, 2022; and,
- Pass Los Angeles City Lifeguard Test - Lifeguard test consists of a 70 Foot Dummy Tow Swim and 200 Yard Lifeguard Medley; and
- Complete the LA City Lifeguard Academy; and,
- Attend all mandatory manager trainings prior to June 12, 2022; and,

1. **AGE:** 18 years of age. Proof of age with picture ID **will be required** at the interview.
