SEASONAL OPEN WATER LIFEGUARD II

(Code No. 2420-2)

THIS EXAMINATION IS GIVEN TO FILL SUMMER 2024 OPEN WATER II POSITIONS ONLY AND IS OPEN FOR PROMOTIONAL CITY OF LOS ANGELES OPEN WATER LIFEGUARD STAFF ONLY

SALARY: \$34.18/hour (The current salary range is subject to change. You may confirm the starting salary with the hiring department before accepting a job offer).

DUTIES: Oversees the safety of patrons at open water facilities; effects rescues and performs preventative actions for persons using the facility for recreational boating, jet skiing, water skiing, sailboarding, swimming, and other related recreation activities; completes incident reports and summaries, may operate rescue trucks and rescue powerboats to perform these tasks; acts as a lead and trains subordinate employees; and perform related work.

REQUIREMENTS:

1. **EXPERIENCE:**

- a. Two (2) full summer seasons as an Open Water Lifeguard; or,
- b. 1000 hours service as an Open Water Lifeguard; or,
- c. One (1) full summer season as an Open Water Lifeguard and one (1) full summer as a Pool Manager with the City of Los Angeles

2. **CERTIFICATION:** Candidate must maintain a valid California Driver License throughout the course of employment. California Driver License must be presented at the time of interview.

4. **EXAMINATION:**

TESTING CRITERIA: Candidate must complete an oral interview. A minimum score of 80% is required to be placed on the Open Water Lifeguard II eligibility list.
