- 3. **Cameras** request of CD 9 did apply for \$400K CDBG funds for Lighting and Cameras for Augustus Hawkins
- 4. Play Area Removing the locked BBQ pit and replacing it with a kids nature play area-cost pending (Columbia Science Center had done playgrounds like this, their rough order of magnitude exceeded \$100,000 and that's in part because in California, the natural wood had to be specially "treated" as opposed to bringing in logs that you cut down in a forest in the Carolina's for example. Alternative Sensory Playground is being explored together with Tiffany, the CEO of "Aiden's Place".) Other bids should be sought simultaneously.
