- Fireworks have become an ongoing problem with public safety ramifications. What can be done?
  - Possible discussion: pole top cameras (a pilot program)
- Restrooms & Playground ADA compliance and funding issues/ideas
  - Community members in addition to board members, have begun to express their continued frustration with respect to this matter and are demanding RAP either fund, make a plan to fund or allow partial private funding and construction of upgraded bathrooms to ADA compliance.
