Summary: Therefore, be it resolved, that the Venice Neighborhood Council calls upon the Los Angeles City Council to immediately pass an ordinance to reinforce and enhance the current LA City Fire Code by; prohibiting tents and/or temporary flammable structures to be located within 20 feet of lot lines, buildings, other tent or membrane structures, parked vehicles or internal combustion engines; banning any fires for any purpose on public property within 50 feet of any structure; banning flammable-liquid-fueled equipment use in tents or membrane structures; requiring flammable and combustible liquids shall be stored per LA Fire Code not less than 50 feet away from lot lines, buildings, other tent or membrane structures, and parked vehicles; and ensure all fire access lanes are clear for emergency use. The Venice Neighborhood Council further calls upon the Los Angeles Fire Department to conduct an immediate study of the fire hazard posed to structures in Venice by encampments and to issue orders for those encampments that pose a fire threat to be removed from proximity to those structures and fire access lanes.



Summary: Therefore, be it resolved, that the Venice Neighborhood Council calls upon the Los Angeles City Council to immediately pass an ordinance to reinforce and enhance the current LA City Fire Code by; prohibiting tents and/or temporary flammable structures to be located within 20 feet of lot lines, buildings, other tent or membrane structures, parked vehicles or internal combustion engines; banning any fires for any purpose on public property within 50 feet of any structure; banning flammable-liquid-fueled equipment use in tents or membrane structures; requiring flammable and combustible liquids shall be stored per LA Fire Code not less than 50 feet away from lot lines, buildings, other tent or membrane structures, and parked vehicles; and ensure all fire access lanes are clear for emergency use. 
The Department of Cultural Affairs (DCA) would like to submit a proposal for Category 1 – Regional Recreation/Education Facilities funds totaling \$680,000 to complete Phase II Restoration of Frank Lloyd Wright's Residence A. Located in East Hollywood's Barnsdall Park at 4800 Hollywood Boulevard, Residence A is one of two buildings designed by the famed American architect and owned by the City of Los Angeles. It is part of the National Historic Landmark 'Aline Barnsdall Complex' and within the Hollyhock House UNESCO World Heritage site. Begun in 2017, a major restoration of this structure was initiated as a collaboration between the DCA, Bureau of Engineering, General Services Department, and Project Restore. Completion of the project will preserve and make this landmark site accessible to youth and general audiences through educational programming and tours.

The scope of work for this funding request is as follows:


1. Restoration of interior historic features: plaster walls and ceilings, wood flooring, fireplaces, and stairways.
2. Restoration of the original millwork: wood windows and doors, wood trim and molding, and period appropriate wood finishes and treatments.
3. Restoration and upgrade of interior electrical and lighting systems, including period appropriate light fixtures, outlets, and switches throughout the house as well as secondary lighting to enhance architectural features and functionality in and around the structure.
4. Recreation of key furniture elements and built-in components based on original design drawings.
5. Implementation of site grading, exterior lighting, and landscaping, as well as ADA commensurate hardscaping and a path of travel, which together provide access, safety, security, and historical interpretation.
6. Engagement of designers and consultants specializing in historic preservation.

Pursuant to the Request for Proposal (RFP), the DCA proposal must include a Council approved motion committing to make the property available for the project.

MOTION

Completing the active transportation paths along the Los Angeles River, known as the "LARiverWay," will create a 51-mile spine for the region's growing bicycle network. The LARiverWay's completion is a fundamental goal of the Los Angeles River Revitalization Master Plan and the Mobility element of the General Plan. Significant gaps in the LARiverWay system exist along the L.A. River through the San Fernando Valley. The City of Los Angeles has been proactive in investing in planning and design; and seeking grant funding to fill the system gaps in the Valley. The Bureau of Engineering completed a feasibility report that identifies the nine segment alignments and a sequencing plan for implementation (C.F. 17-0302).

Los Angeles County Voters approved Measure M in 2016 to invest in the region's transportation facilities. Among its programs, Measure M includes \$60 million to complete the San Fernando Valley LARiverWay. This funding, while not sufficient to complete the needed projects on its own, is available to be used as a match for applications seeking external grant funding.

The Federal Lands Access Program (FLAP) is a program under the United States Department of Transportation (USDOT) the objective of which is to create and enhance access to federal recreation lands by constructing and improving transportation facilities. Because the L.A. River and the nascent LARiverWay run through the federal Sepulveda Basin Recreation Area, LARiverWay elements adjacent to the Sepulveda Basin are good candidates for FLAP funding as they will help bring more people to the federal recreation lands more safely.

The Rebuilding American Infrastructure with Sustainability and Equity (RAISE) grant program is a program also under the USDOT the objective of which is to invest in various types of transportation infrastructure throughout the nation. Segments of the LARiverWay are good candidates for RAISE program funding because of their safety, health, greenhouse gas reduction, and other benefits. Additionally, the RAISE program encourages the creative inclusion of other key infrastructure elements into project applications, especially to benefit disadvantaged communities.


To formulate grant applications for both the FLAP and RAISE programs for segments of and related infrastructure along the LARiverWay in the San Fernando Valley;



On behalf of the Westwood Homeowners Association, we are very concerned about the process now in place by which the Commissioners authorize RAP's request for funds for proposed projects. As it pertains to the Westwood community, RAP has already obtained authorization to use \$650,000 to replace play equipment at Westwood Recreation Park and \$.13 million to place the play equipment at Holmby Park even though there had not been any notice to the community that RAP was seeking these funds nor had there been any community input regarding either of those plans. In fact, the funds were allocated before any actual plans were submitted to the community for comment. It makes no sense that RAP should be authorized to be allowed to use these allocated funds as it deems fit without first having the community involved.. A rational process should be that RAP be required to present its proposal to the community, the community vets the plan and has the right to approve or disapprove the proposal. Only then, once a plan has been fully developed and it is bid, should RAP come before the Commission to seek approval,

A perfect example of how this current process makes no sense was exemplified last week when Darryl Ford again presented RAP's new playground proposal to the Holmby PAB. Several members of the PAB and the community had strong objections to the proposal, questioned whether it was necessary and inquired whether the allocated funds could be used elsewhere. For instance, for a bathroom closer to the childrens' play area. The response was that the Commission has already approved the use of the funds for the playground.

At the recent PAB meeting at Westwood Recreation Park, again the same issues were raised. Fortunately the community had learned about RAP's intention to seek an additional \$750,000 for the replacement of all of the equipment at Aiden's Place and was able to mobilize the community's objection. Fortunately the Commission did not rubber stamping a project because it had not been vetted by the community. And it is astounding that RAP requested these addition funds even though there were only a rough schematic had done. In fact, to date, only concept drawings are available.

We are pleased that there are funds available to restore or enhance our parks, but the process must be altered.

- First the community must be engaged.
- Second, there must be a viable plan that has the buy in from the community.
- Third, the approved plan should be bid.
- Fourth, only then should RAP come before this Commission seeking approval of the costs.

The existing process is backward. The Commission needs to demand the RAP become more transparent and collaborative before it comes before you. As a community we are tired of being blindsided by RAP imposing its agenda upon us. We hope that in the future, that will change. But it will only occur if the Commission places demands on RAP and refuses to rubber stamp a project unless there has already been collaboration and buy in by the community

The Quimby funds are not a slush fund that can be doled out at the whim of RAP.


Dear Commissioners:

I am a concerned resident of Glassell Park writing to you about violence that was enacted by Recs and Parks Rangers towards two residents this morning at Avenue 64 and the 110 freeway.

Early this morning, while my friend was away at work, Rec and Parks Rangers along with LAPD tore down and seized the structure that she was living in. My friend doesn't have housing; and has been living in a shelter she constructed. Not only did Rangers and LAPD destroy her shelter and the shelter of an 80-year old man who lives nearby, but your staff also took all of their personal belongings from them. **These actions violate the U.S. District Court for the Central District of California's ruling in Garcia vs. City of Los Angeles, which prohibits the city from seizing and permanently destroying bulky items in public spaces. The due process required in this ruling is protected by the Fourth amendment and Fourteenth amendments of the United States Constitution, and California Constitution.**

In addition, Recs and Parks Rangers and LAPD told one resident that he would have to move from the area and could go into Project Roomkey. This is false information, as LAHSA case workers in the area have told us that Project Roomkey is at full capacity and not accepting any new residents. **Please make sure your staff are aware of current practices before misinforming someone and saying they can get into temporary housing.**

The public servants employed within your department destroyed these residents' shelters; took away their personal belongings; and gave them false information. This behavior is completely unacceptable, and in fact deplorable that Recs and Parks staff would serve the public in this destructive fashion. **I request that you use your position to find out where all of their personal belongings are being held, so we might alleviate some of the violence committed against my neighbors. It is a requirement that any property seized by the City from unhoused community members must be stored for at least 90 days, and you must allow for retrieval by the owner.** I look forward to hearing more details about how their belongings can be returned to them.

Homelessness in our city is the result of a lack of both affordable housing and supportive community services. In the absence of these basic services, displacing and robbing our neighbors causes enormous harm, and I hope that Recs and Parks Rangers will not participate in such destructive behavior towards my community again.

Good morning.

I am a concerned resident of Eagle Rock writing to you about violent displacement that was enacted by Recs and Parks Rangers towards unhoused residents at the Avenue 64, Marmion Way island near the 110 freeway. The individuals living there have no housing and have been living in a shelter constructed on that site.

At 6:30am Thursday morning, May 20, 2021, while one of the residents of that encampment was away at work, Rec and Parks Rangers, along with LAPD, tore down and seized the structure that the residents were living in. Park Rangers and LAPD destroyed shelter of the main resident and an **80-year-old man** who lives in a tent nearby. Recs and Park staff also took all of their personal belongings from them including a mattress and bedding of the elderly man. **These actions violate the U.S. District Court for the Central District of California's ruling in Garcia vs. City of Los Angeles, which prohibits the city from seizing and permanently destroying bulky items in public spaces. The due process required in this ruling is protected by the Fourth amendment and Fourteenth amendments of the United States Constitution, and California Constitution. The Recs and Parks Dept is part of the City of Los Angeles and is required to conform to this ruling.**

No advance notice was given of the displacement and LAHSA outreach workers were not available to ACTUALLY offer housing to the residents at that location.

Once the displacement occurred Recs and Parks Rangers and LAPD told one resident that he would have to move from the area and could go into Project Roomkey. This is false information. First of all LAPD and Rec and Parks Rangers have no authority to offer anyone housing through Project Room Key as they have very little knowledge of the process. Second, as LAHSA case workers in the area have told us, Project Roomkey is at full capacity and not accepting any new residents. Third, no LAHSA outreach workers were present to offer actual available housing to these individuals.

It is a requirement that any property seized by the City from unhoused community members must be stored for at least 90 days, and you must provide a notice and an address where belongings can be retrieved and allow for retrieval by the owner. Please provide explicit details about how their belongings can be returned to them.

The location at Marmion Way and Avenue 64 is actually an island next to a freeway and no park amenities are present for public use. Previously the site was unkempt, overgrown with weeds, in a state of disrepair and an actual fire hazard before the unhoused residents created shelter there. Therefore, that location does not actually conform to the definition of a "park" in LAMC 63.44 B (26). The unhoused residents cleared the overgrown weeds, landscaped, planted and maintained sunflowers and trees, purchased operational fire extinguishers to prevent fires from fireworks set off during July 4th and New Years, and improved the location considerably. The unhoused resident of that location is well known to the community and has received help from many community members to maintain that space. Depriving her and the other residents of that property is not in keeping with other City ordinances that allow unhoused residents to maintain their tents and belongings according to LAMC 56.11 and COVID emergency protocols.

In addition, most of North East LA is within a High Fire Severity Zone, therefore using the High Fire Severity Zone as a reason to displace the residents of that location does not take into account that the unhoused residents' practice of clearing that location of weeds and other debris actually helps to mitigate any high fire risk, along with keeping on hand operational fire extinguishers. The unhoused residents did a much better job at clearing brush than most housed residents. In addition, they planted, watered and maintained healthy trees, shrubs and flowers to the delight of community members.

Homelessness in our city is the result of a lack of both affordable housing and supportive community services. In the absence of these basic services, displacing and dispossessing our neighbors causes enormous harm, and I hope that Recs and Parks Rangers will not participate in such destructive behavior towards our community again. Please allow the residents to remain in that location until suitable permanent housing is available for them.





At 6:30am Thursday morning, May 20, 2021, while one of the residents of that encampment was away at work, Rec and Parks Rangers, along with LAPD, tore down and seized the structure that the residents were living in. Park Rangers and LAPD destroyed the shelter of the main resident and an 80-year-old man who lives in a tent nearby. Recs and Park staff also took all of their personal belongings from them including a mattress and bedding of the elderly man. These actions violate the U.S. District Court for the Central District of California's ruling in Garcia vs. City of Los Angeles, which prohibits the city from seizing and permanently destroying bulky items in public spaces.
