Dear Recreation and Park Commissioners Recreation and Park Commissioners,

As a Los Angeles resident who cares about the wellbeing of animals and an In Defense of Animals supporter, I urge you to stop animal suffering in your district by eliminating the Griffith Park Pony Rides and Petting Zoo's contract, replacing Griffith Park with a non-animal model and sending all of the animals to a sanctuary.

For five years, your agency has passed inspection reports for the concession, while the owner Stephen Weeks has been breaking California Health and Safety Code 25998. Elderly ponies and horses at Griffith Park Pony Rides have documented depression. Spot the pony has lameness, yet is forced to carry people on his back.

Recently an overweight sheep was in distress with no worker attending to her needs, and many horses and ponies were itching due to their halters, which appear to be on all the time. Elderly ponies and horses were also seen being hit and chased for almost eight and half hours on the weekend.

No amount of improvement will ensure that these animals are not suffering from depression. Independent equine expert Rachael Sacher DVM, CVA reported elderly ponies working with saddle sores, elderly ponies with no dental treatment, no identification methods for any of the animals, and an elderly pony with a fever undetected by this concession while your department and Stephen Weeks make millions off the backs of these elderly ponies. Griffith Park Pony Rides pays Recreation and Parks a revenue-sharing fee of 25 percent of their gross income, and as a Los Angeles constituent, I oppose city funds generated from animal abuse.

Pony rides exploit animals for amusement and profit. This practice teaches children the wrong lessons about animals as objects for amusement instead of appreciating our animal neighbors as sentient beings.

This concession also poses a risk to children. Last year, a child was reportedly dragged by a pony after her saddle slipped, and the pony continued dragging her body because the pony was spooked.

I respectfully request that the pony ride contract be canceled rather than renewed. Please undertake a study to consider alternative proposals that are generated from a non-animal model for the site that would engage children and families. Lastly, I urge you to send all of the animals to a sanctuary, which advocates have already arranged and confirmed.

Thank you for considering the well-being of animals in our community. Please make compassionate choices to improve the quality of life for our animal neighbors.

I am writing to ask that you grant Stephen Weeks another 1 year extension on his operating permit for the pony rides. I've been up there since the fiasco with the animal extremist groups started. I'm a registered veterinary technician, experienced with working with all breeds of horses, a horse owner until my own horses passed on, and a former employee of Disneyland's Circle D Ranch, which housed horses, ponies, draft breeds, burros, goats, as well as many other species.

The Pony Rides are kept in a manner very similar to Disneyland's Big Thunder Ranch- employees cleaning, interacting with guests, animals calm and well-behaved. The ponies are not being forced to work, in fact, several ponies would take a trip around their track even when it wasn't their turn.

The fact that Mr. Weeks has complied with all of the recommendations made, plus hired a full time Animal Welfare Officer to oversee each pony's health daily, says a lot about his commitment to provide a safe, well-run facility in which Angelenos can spend quality family time. Ponies are not treated as commodities- if they were, they would be sent to auction the second they became infirm, or ill. Ponies are treated as the valuable partner in an entertainment field. Please don't take that away from the children. This may be their only chance to interact with a horse.

Will someone also send me the presentation which did not get displayed on the LA RAP call about the Oakwood Park renaming on Nov. 17.

Just want to share this information with the LA RAP management and commissioners. Irvin Burns Tabor was not the first African American man to own a maintenance service in Venice. There were other Black men such as Arthur L. Reese and Charles Brunson who owned maintenance businesses before 1920. Irvin Tabor did not start his maintenance business until later.

Additionally Joseph and Charles Tabor arrived in Venice around 1910, before Irvin arrived. All eleven Tabor brothers and sisters, along with their parents and grand children moved to Venice by around 1920. It is appropriate to urge recognition of the families as pioneering Venetians and shapers of this Los Angeles and California coastal community.

I am a publicly engaged independent historian who is doing deep research on the Black experience in the Venice district of Los Angeles right now. I am the author of the book *Living the California Dream: African American Leisure Sites during the Jim Crow Era* which includes a small section on the Black Venice pioneers. I have worked extensively across the Los Angeles region to elucidate and re-insert the erased and overlooked African American experience in local history and the American identity.

Thank you for conducting the presentation tonight. Please email me your presentation, which was not visible to us attending the Zoom meeting.

I am mindful of and appreciate the reasons some of the attendees at tonight's meeting do not support the naming of the park for Arthur Reese and Irvin Burns Tabor, historical black figures in early Venice history, to wit: "it does not honor other groups, ie, Native Americans or Mexican-Americans who live in Venice". I noticed that the opponents did not mention the Japanese-Americans or other non-white populations, who also lived in that part of Venice because they, too, were subject to racist CCRs.

I might argue that this is not a zero-sum game. Naming the park after early black pioneers does not mean that other sites cannot be named for Native Americans/Chicanos, et al. There are many place names in Venice that could be named in honor of other notable people or groups. Oakwood Park, (which has no historical derivation, despite the claims of some of the callers) is not the only place that can be subject to name change.

I urge the opponents to seek other places and suggest honorific name changes, or erect monuments, as mentioned by some of the callers (i.e., the circle). Two rooms in the Rec. Center honor other residents. This is a good start. Perhaps an historical walk of signs could be erected, like the park in Santa Monica, which commemorates the contributions of many groups to Sta. Monica history.

Several callers pointed out that naming the park for people made them aware of their contribution to history and the community. This is key. The word "Oakwood" means nothing and does not prompt anyone to look into the history of "Oakwood".

I urge the RAP commission to retain the name change to include Reese-Tabor. By naming the park after individuals, a memory of their contribution to the formation of Venice will remain in the public eye long after the last of the people of color are gone from Venice.

Just want to share this information with the LA RAP management and commissioners. Irvin Burns Tabor was not the first African American man to own a maintenance service in Venice. There were other Black men such as Arthur L. Reese and Charles Brunson who owned maintenance businesses before 1920. Irvin Tabor did not start his maintenance business until later.

Additionally Joseph and Charles Tabor arrived in Venice around 1910, before Irvin arrived. All eleven Tabor brothers and sisters, along with their parents and grand children moved to Venice by around 1920. It is appropriate to urge recognition of the families as pioneering Venetians and shapers of this Los Angeles and California coastal community.

General Manager Kim,

On behalf of the community, I formally requested that the City of Los Angeles consider renaming the Oakwood Recreation Center to the **“Reese-Tabor Oakwood Park and Recreation Center”** in recognition of the deep, rich, and diverse history of the neighborhood. Per your request, I have compiled the following historical information to enrich your discussion on the matter and share the stories of this community and the contributions of these families.

Over one hundred years ago, the Reese and Tabor families were pioneering Black members of a once independent shoreline community that became the City of Venice before being annexed by the City of Los Angeles. Most Black residents in Venice up until the 1940’s lived in clusters between California Avenue, Electric Avenue, Brooks Avenue, and Lincoln Boulevard. By the 1970’s, Black residents expanded to living farther north to Rose Avenue. These residential patterns were due to housing discrimination in the form of informal discrimination, racist covenants, and redlining. Attached to this letter are maps demonstrating the entrenched residential segregation of Venice during the 1970s positioned in contrast to the outcome of decades of displacement that we see today.

This Black community had an important impact on the development of Los Angeles' special coastal community. Venice’s Black progenitors moved here wanting to fulfill the dream of buying land, achieving prosperity, and self-fulfillment. Black migrants were especially looking for escape from the worst of White supremacy, anti-Black restrictions, and social injustice in the Jim Crow South. The contributions of these settling families survive well into the twenty-first century despite decades of community change.

Venice in the 1890s was largely part of the Ballona Creek marshlands and lagoons that was later purchased and developed by the businessman Abbot Kinney (1850 –1920). Kinney’s ventures evolved into new resort and amusement facilities with vacation and permanent dwellings along the beach. “Venice-of-America” would open in 1905 as an imaginative, spectacular and picturesque resort with its architecture, canals, walkways and streets inspired by Venice, Italy. Many Black and Mexican-American paid laborers worked to build these canals and Kinney’s vision for this shoreline community.

Arthur L. Reese, Jr. and The Reese Family

Arthur L. Reese, Jr. (1883–1963) was a transcontinental railroad porter living in New Orleans, Louisiana who aspired to own his own business. As a Black man in this era, he was blocked from corporate management positions

and high wage jobs due to his skin color. Arthur saw an opportunity when he read about the construction of “Venice-of-America” in a newspaper and moved to Los Angeles by 1903 as a result.

Arthur became a successful entrepreneur who established several businesses including shoeshine, building cleaning, and beach towel supply operations serving Santa Monica and Venice. Through his contract work, he became associated with Kinney’s “Venice-of-America” and other amusement facilities. He earned the moniker “The Wizard of Venice” for his marvelous and creative decorations of the Venice amusement buildings and for various parade floats and celebrations, such as for the Mardi Gras Carnival. Among his many ventures, Arthur was a business partner for the Lake Shore Beach Club, a resort site at Lake Elsinore in Riverside County which became an important venue for Black vacationers from 1921 into the middle of the twentieth century.

The first home owned by Arthur and his wife, Gertrude Sercey (1885–1950), was at 555 Westminster Avenue. They later built their next home at 541 Santa Clara Avenue by 1920 where they lived together until their passing. Arthur encouraged many of his relatives and friends still living in New Orleans and Morgan City in Louisiana to join him in California - including his mother, two brothers and one sister. Many came to Venice and became part of his workforce for various lengths of time into the coming decades. These Black migrants took up residence in what was first called West Venice, and much later “Oakwood.”

Arthur was extremely involved in his community and used his experience as a real estate investor to donate land for the First Baptist Church’s then new facility at 688 Westminster Avenue that opened in 1928. This edifice was designed by the renowned Black Angeleno architect Paul R. Williams (1894– 1980). Arthur’s brother, Joseph Allen Reese (1890-1972) was the first Black U.S. Postal Service mail carrier in the Venice area, serving in this position for over 40 years. Joseph developed youth programs at First Baptist Church before he went on to become an active member of Santa Monica’s Calvary Baptist Church founded in the 1920s. Arthur’s other younger brother, Edward A. Reese (1896–1945) joined Joseph in establishing the Baptist Young People’s Union at the First Baptist Church and an outing club for young men and their families and friends for mountain trips, truck rides, and fishing parties.

In addition to his contributions to the local community, Arthur was a founding member of Santa Monica’s Crescent Bay Lodge Number 19, a Black Mason group established in 1910. Arthur later became the Santa Monica-Venice branch president of the National Association for the Advancement of Colored people (NAACP) in 1918. Joseph Allen Reese would also serve as president of the NAACP for a time. Some of Arthur’s other civic accomplishments include becoming an elected member of the Republican County Central Committee of the 61st Assembly District in 1920 and his appointment to the Venice local election board and Chamber of Commerce in 1934.

Irvin B. Tabor and the Tabor Family

Arthur’s cousins from the Tabor Family soon followed as his local enterprises became established. Arthur’s cousins, Joseph H. Tabor (1883-1930) and Charles G. Tabor (1888–1963) were the first to join in 1910. These two brothers were part of a large family of eleven children - six boys and five girls - born to William Alfred “Fred” Tabor (1844-1925) and Elizabeth McCullen (1857-1919) who also migrated with them. All Arthur’s brothers and male cousins worked with his maintenance business and other ventures as they got themselves established in Venice.

Of the eleven siblings, Irvin B. Tabor (1893-1987) became the most well-known locally due to his close relationship with Abbot Kinney as his chauffeur in 1913. Even though he had never sat in or driven a car, he accepted the driver position and then learned to drive from a friend. By 1916, Irvin purchased a bungalow court property at 605-607 Westminster Avenue. By 1920 several other of his siblings who had moved out from Louisiana were living in the bungalows with him. After Kinney died, Irvin would go on to work as a guard at Bank of America and later founded Tabor’s Bay City Maintenance Company.



Irvin was bequeathed Kinney's guesthouse on the Venice Grand Canal upon his death in 1920. Although Irvin attempted to move into the house, there was extreme resistance from the White neighbors. As a result, Irvin and his brothers moved the house to 1310 Sixth Street where it stands today. He would move in with his family and live there until his passing.

Several figures from the Tabor family made notable contributions to local history. Brothers Charles and John Quincy Tabor had a trucking and hauling business and filled in the canals to make streets in Venice in the 1920s. Sister Jenny Tabor Henry and her husband Alphonse were one of the first Black families to move north of Brooks Avenue and they had a concrete business which serviced the Venice and Santa Monica area by 1930. Paul McCarty, Jr., the son of Ruby Tabor and Paul McCarty worked for the Los Angeles Planning Department as principal architect for over 40 years. Novelette Tabor was the first Black graduate of Santa Monica High in 1933. John Quincy Tabor Jr. became the first Black lifeguard in the city and the county providing service at the beaches in the 1940's. Also in the Reese family, sister Fanny would marry Arthur F. Adams; both their sons Arthur and Joe would become recognized entertainers and radio personalities.

I would like to extend my deepest appreciation to the many community members who shared their stories so we can formally recognize Arthur L. Reese, Jr., Irvin B. Tabor, and the contributions of these families to the Oakwood community. I would also like to express my gratitude to Alison Rose Jefferson, a historian with a focus on American history, the African American experience, heritage conservation, historical memory, spatial justice, and cultural tourism.¹ Due to her passion and expertise, we continue to learn more about this historic community and give voice and recognition to their story. Lastly, I would like to thank Dario Rodman-Alvarez, Rudolph Mattheis-Brown, and Luis de la Rosa from the Center for Pacific Urbanism for their thoughtful demographic research on the community of Venice.²





Attachment 1: Black Population by Census Tract in Council District 11 between 1970 and 2020

My name is Gregory Francois and I live one block northeast of Dearborn Park in Northridge. My wife, 3 kids, and I have owned and resided in our current home for more than 25 years. All three of my kids attended the neighborhood elementary and junior high school and have now graduated from Southern California universities.

When we first purchased our home, one of the attractions of the area was the local park within walking distance. We had very young kids at the time and saw the park as a great place to take them to enjoy its many amenities. In our early years living in this area, the park was mostly used by neighborhood families. Over time it became a practice spot for youth sports teams as well, but it still had the family feel.

Several years ago, we began to see more family parties and party bouncing apparatus, but the parties were basically limited to toys, tables, and chairs. These parties could sometimes be large, but they were never a nuisance to the surrounding neighborhood.

At the start of the COVID-19 pandemic, the neighborhood parks became overrun with people looking to get out of their residences. This was totally understandable and expected. My family also took advantage of spending more time enjoying more outdoor Southern California venues. Over the course of the pandemic and even after it was lifted, we began to see larger adult-style parties. DJs with outrageously loud amplified equipment and full bands playing for parties became the norm.

On any given Saturday or Sunday, there can be 5 or more parties that consist of between 20 to 100 people in each group. Giant tents are now erected and tables and chairs are set up inside and outside of the structures. Some parties have full kitchen setups for both cooking and cleanup. It has gotten so out of hand that there is not enough space for a family to come and enjoy the park. Many times, people are arriving as early as 6 am just to secure their space.

As you know, Dearborn Park is relatively small and surrounded by homes. These excessively large parties that are now occurring every Saturday and Sunday are impacting the peacefulness of the surrounding neighborhoods. At this point it does not feel like there are any rules or regulations being followed. Music is extremely loud; partygoers are loitering long after dark and liquor can be observed just passing by in a car.

As the Park Commissioners, I feel it is your duty to set some rules to return stability to this park. I feel that amplified music should never be allowed in a park this small that is surrounded by homes. There should be a limit as to the size of the structures that are being erected. There should be no public consumption of alcohol and the park hours should be enforced especially on the weekends. Finally, there should be an individual or group that monitors the parks on the weekends to ensure that the rules are followed.

As neighborhood homeowners and taxpayers, we need you to return order to this park. As I stated above, this neighborhood park was always the pride of the area. Now it has become a source of stress and concern for all of the neighbors. I look forward to your comments and hope to see some expedited improvements.

Griffith Park has an undeniably rich and often storied history, which should be available and accessible to all users of the park. Over the past year, Recreation and Parks staff has done an amazing job identifying locations and narratives of historical significance to be highlighted through educational and informational signs throughout the park. We applaud this effort to bring both the positive and complicated stories to life.

During World War II, thousands of Japanese, German, and Italian immigrant leaders were confined without due process in US detention and internment camps as suspected threats to national security. One such camp, operated by the Army, resided in Griffith Park at the site of the former Civilian Conservation Corps Camp Riverside, now home to Travel Town Museum and Los Angeles Live Steamers. For more than a year, this small camp, which could accommodate over 500 people, served as a staging area for larger camps in other parts of the country.

While this shameful part of our nation's history is problematic, we applaud the effort to acknowledge it and educate visitors. Shining a light on our park's role in this sad chapter will enhance the experience of visitors by deepening the public's understanding of its history. We strongly support the signage proposal for the Griffith Park Internment Camp and look forward to seeing more proposals for educational signage brought forward by Recreation and Parks staff and others who are knowledgeable about the park's history.

Over the past year, numerous stakeholders have come together in support of projects that highlight the rich history of Griffith Park. One such project continues a trend of improving educational signage throughout the park, an endeavor we wholly support. So many Angelenos rely on Griffith Park as an outlet and resource in their daily lives, and tapping into its many, varied stories brings yet another important aspect of this beloved park to life.

Long before the Autry Museum, the present-day LA Zoo, or the collection of nearby freeways, the northeast portion of Griffith Park was an airfield. In 1946, a housing crisis for returning veterans highlighted the need for emergency housing. Thankfully this 100-acre airfield, which was already connected to gas, water, and sewer lines, provided an ideal solution. In barely two months, 1,500 Quonset huts were assembled to ultimately house 5,000 residents. The village was named for Rodger Young, a World War II private who posthumously won the Congressional Medal of Honor for drawing fatal fire so that the rest of his cornered platoon could escape.

With the help and hard work of the LA Parks Foundation, funding from the Griffith J Griffith Charitable trust, and of course the leadership of RAP staff, this fascinating story will be on display outside the Autry Museum. GPAB views this installation as a worthwhile addition to the growing educational and informational signage throughout the park.



My family and I live in a house situated on the back rim of Potrero Canyon, on Lombard Ave., for well over 10 years. I am a 30 year Palisades resident. We have lived in this pocket neighborhood in relative bucolic quiet and safety until the last several years when there was a sudden uptick in all kinds of local crime as well as the sudden and now current, commonplace appearance of threatening and sometimes violent homeless and transients in this specific Via Bluffs neighborhood, as well as in the rest of the Palisades. Our young teen daughter has not been allowed to walk our dogs alone by the bluff on Via De Las Olas (street along a side of Potrero Canyon) for the last year during the day and absolutely never at night.

This park should absolutely **not** be open from 5:30am -10:30pm. This is a very dangerous plan - for my pocket neighborhood on the Potrero Canyon rim and the Palisades. I can only speak for my family in this note, however, I know full well that my many immediate neighbors feel the same; absolutely no one with a home on the Potrero Canyon rim and this surrounding Via Bluffs neighborhood, wants the attraction of this soon to be "free for all haven" park - with the currently planned and categorically

unacceptable open and closed to the public times, virtually unrestricted access through gates with no security locks 24/7, no lights at dusk/night and no park security or patrol whatsoever. As a long-time resident of this pocket neighborhood, I know full well that if this park is open from 5:30am - 10:30pm it will without question attract even more homeless and transients, meth-heads and destructive stoner kids exponentially, making my home and neighborhood much less safe for my family - and my neighbors. My family and I would strongly prefer not to have to be forced to move out of a home, neighborhood and community that we love and care about due to what is inevitably coming down the pike if things stand where they are now with the current stated Potrero park hours and the total lack of park security or patrol.





Despite Erich Haas (the Palisades Recreation Director for over 20 years) assuring us in 2020 that all grills would be subject to advance permitting only (email chain below), the Palisades Recreation Center continues to allow groups to simply walk up and request for the grills to be open.

Erich's email to us is below.

In response to my question of February 17, 2020 (question 2): "Can you confirm only permits obtained in advance will be permitted to grill? How will this be enforced?"

Erich responded:

"Use of all park picnic areas are by permit only. If they state they will be grilling, a staff will go and unlock the grill when the permit begins, periodically monitor the area throughout the permitted time and when the permit is over will ensure the fire is out and re lock the grill."

Your staff at Palisades Recreation Center continue to permit groups to walk up and grill, with no advance permit, as has **always been required in the Palisades Recreation Center.**

I have contacted LAFD, who informed me that "it is dry and windy today, and no one should be grilling."

You continue to oversee and allow hazardous conditions in a very high fire severity zone park.

Sonya,

I was not allowed to respond to the ensuing debate between the PAB Board and Bill McGregor, despite the fact that I was the one who placed the grills on the Agenda, so I was not able to respond that historically, the grills have never been permitted to be used without an advance picnic permit obtained online.

As you can see in the written correspondence from the prior Park Director, advance permits have always been required. Showing up to grill without a permit is something new you have introduced to this park, without any considerations of the fire zone's impact on neighbors, or of no-burn-days in the winter months, which are frequent.

How does your Department plan to administer the opening of the grills without an advance permit---can anyone show up at the park office and demand on the spot that one is opened? Are you going to check IDs to make sure they are over 18 years of age? What if they are a homeless individual or appear incapable of operating a grill safely—is your team going to vet their ability to safely grill and monitor them? This sounds like an invitation for a lawsuit.

You asked for us to confer regrading the grills. You also let me know that the previous park Director had told you they'd remain locked. I offered to bring this to our board because I could see the merit in your concern, and believed others would too. I sent you one email updating you on egregious safety violations involving high fire risk in a park and community you volunteered to serve, as well as two follow ups with photos of coal in the park, highlighting the myth perpetuated on the call that these grills can somehow be managed. I'm not sure that qualifies as "inundating", but nevertheless, you won't hear from me following this email, at least in your capacity on PAB.

To clarify, the agenda item I asked to be placed on the PAB call for was concerning the year-round fire risk posed by the grills, not a "traditional fire season", which anyone involved with fire safety in California will tell you no longer exists. The fire hazards on red flag days such as today do not magically disappear because it is not a "traditional fire season". Hi Jennifer, replying in reverse order to your emails – once again, I, as an individual, hear your concerns over fire.

I believe that at the PAB meeting, members made clear that we collectively were concerned about fire, particularly during fire season and in relation to bbq'ing at the park. What we asked was for the grills to remain locked, and only opened by request during months that were not included within the traditional fire season. I believe that has been put into practice.

If you, as a nearby resident, feel a more urgent need to appeal to the city for more restrictions on the grills, that will be something you will have to do as an impacted citizen. I believe the park board has gone as far as we were asked to go. We meet again in January. If at that time, you'd like to ask the chair to take up this issue again, and see if there's some consensus around eliminating the use of grills all together, you are welcome to do that.

Of all the grills chosen by the bocce group to be used today, "coincidentally", the one directly behind our home and closest to our hedge was selected and opened by the Park today for grilling. The winds blew the smoke directly into our yard and home, as no doubt the grilling bocce group was well aware would happen.

This, on a day designated as a "fire watch", with critically low moisture levels, increasing winds and red flag warnings starting tonight. It's no wonder LAFD sent a fire truck over immediately when they learned of it.

Furthermore, we photographed tonight the fresh ash that was dumped all over the ground and plants around the grill—again, behind our hedge, and in a Very High Fire Severity Zone Park, surrounded by flammable podocarpus trees and highly flammable eucalyptus

Commissioner Halper and Sonya,

It has come to our attention that there is a provision of the Los Angeles Municipal Code that codifies Chapter 49 of the California Fire Code, and addresses specifically "open burning" in the Very High Fire Hazard Severity Zones of Los Angeles. "Open Burning" is defined in the Fire Code as "the burning of materials wherein products of combustion are emitted directly into the ambient air without passing through a stack or chimney from an enclosed chamber". The 8 outdoor charcoal barbecues located within the Veterans Gardens of the Palisades Recreation Center fall under the description of "open burning", as they have no stack or chimney.

Under **LAMC Sec. 57.4908.2:**

"There shall be no open burning or smoking in the Very High Fire Hazard Severity Zone. The Chief shall cause such districts to be posted at all times by suitable signs giving notice thereof."

There is no exception under this code provision for the months of November through March, the period when RAP is currently allowing parkgoers to burn in this Park. The provision of the LAMC 63.44 dealing with fire months applicable to park grilling, applies only to "High Fire Hazard" parks—the Palisades Recreation Center is located within a higher risk fire zone, and therefore, LAMC Sec 57.4908.2 is directly on point and prohibits grilling at any time.

We will be providing notice to the local Fire Captain of these city laws, which codify Section 4908 of the California Fire Code (state law). The Park's approval of any grilling within the parameters of any VHFHSZ park is in clear violation of state and local law.

I am writing on behalf of the Rancho Park Men's Club and join with Marcy Valley of the Women's and Senior's Club to support all necessary efforts to get the Clubhouse at Rancho Park reopened and a thriving asset to the park, its users and the surrounding community. I appreciate how the Concessions Committee has expressed interest in the clubhouse and welcomes the community's input.

It is good news that a restart of construction is targeted for February, 2023. However, after the three year delay since the Clubhouse concession was granted and two years since it was closed, our community of golfers and the general public seem to have taken a sideline stance of "we'll believe it when we see it." At a regularly scheduled board meeting on Wednesday, November 16, 2022, the topic of shielding commercial operations inside Runyon Cyn Park within the parameters of SB 946 was considered and the following motion passed 18 yay - 0 nay. Motion: In order to ensure that Runyon Cyn Park remains an urban wilderness area park, the HHWNC requests that the Los Angeles Rec & Parks advocate, via a motion to the LA Parks Commission, a restriction / prohibition on Park Vending within Runyon Cyn Park, based on the provisions of LA City Ordinance 185900, specifically that 1) vending restrictions are directly related to objective health, safety or welfare concerns for parkgoers (vending activities often literally block emergency egress, ingress); 2) they are necessary to ensure the public's use and enjoyment of natural resources and recreational opportunities which would be impacted without them; 3) that these restrictions are necessary to prevent an undue concentration of commercial activity that unreasonably interferes with the scenic and natural character of the Park, and 4) that vending restrictions follow the 1986 Runyon Canyon Master Plan and Design Guidelines requiring the park be foremost a place for a wilderness experience. Jane Boeckmann was the beloved matriarch of the Boeckmann Family, the First Lady of the Galpin Motors organization, and a local resident who was a San Fernando Valley icon. She was an amazing and dynamic person with a fascinating background, and a true one-of-a-kind who lit up a room the moment she entered it. Jane was truly a woman of unwavering faith, limitless energy and boundless optimism, as well as a selfless humanitarian, civic leader, and astute businessperson.

Jane Boeckmann is perhaps most recognized for her role at the Galpin Motors automotive organization, where she served for many years as Treasurer and Corporate Director. She worked side-by-side with her husband Bert to build Galpin Ford from a small dealership into the #1 Volume Ford Dealership in the world and the most recognized automotive family in the country.

In addition to her accomplishments as a businesswoman, Jane built a long and distinguished record of local community involvement, and her heart for serving the community was boundless. Examples of her service and leadership positions include serving as a Trustee of the Valley Industry and Commerce Association and also King's College, as well as a Board Member of such diverse groups as the Valley Economic Alliance of the San Fernando Valley, Valley Presbyterian Hospital and the Salvation Army.
