- According to an independent assessment study, Griffith Park Pony Rides and Petting Zoo has not met the basic standards of care for working equines. The ponies suffer from mouth and teeth problems, hoof ailments, saddle sores, and lameness, but they were still forced to give rides until the public and legislators intervened. Many of the ponies are geriatric and should be retired.
- The ponies are [routinely overworked](#), even forced to continue in [90-degree heat](#) for nearly seven hours without water, which can lead to painful colic. Forcing horses to be ridden in circles for hours teaches children to treat them like carnival equipment.
- The pony rides pose a safety risk for children. Last July, [a child was dragged by a pony](#) after her saddle slipped. Please do not renew the contract for the pony rides and petting zoo. All the animals should be retired to reputable sanctuaries, and the pony rides should be replaced by a merry-go-round, go-karts, or another form of non-animal entertainment.

- According to an independent assessment study, Griffith Park Pony Rides and Petting Zoo has not met the basic standards of care for working equines. The ponies suffer from mouth and teeth problems, hoof ailments, saddle sores, and lameness, but they were still forced to give rides until the public and legislators intervened. Many of the ponies are geriatric and should be retired.
- The ponies are [routinely overworked](#), even forced to continue in [90-degree heat](#) for nearly seven hours without water, which can lead to painful colic. Forcing horses to be ridden in circles for hours teaches children to treat them like carnival equipment.
- The pony rides pose a safety risk for children. Last July, [a child was dragged by a pony](#) after her saddle slipped. Please do not renew the contract for the pony rides and petting zoo. All the animals should be retired to reputable sanctuaries, and the pony rides should be replaced by a merry-go-round, go-karts, or another form of non-animal entertainment.
- Please cancel their permit and do not allow them to operate anywhere else.

Firstly, as a citizen of California, and secondly as an educator and aunt, I cannot, but speak up against this outdated, abusive practice happening in the beautiful, progressive city of Los Angeles, which poses tremendous animal cruelty concerns as well as threat to child safety and health of the general public. One does *not* have to be a so-called "extremist animal rights activist" to see the animals at Griffith Park Pony Rides and Petting Zoo are under massive stress from prolonged hours of nonconsensual labor that violate their free will and natural instincts, constant exposure to loud noise, burden on their backs, psychological and physical abuse from the employees, rough handling by visitors in the overcrowded petting zoo.

Equine experts among over 68,000 concerned citizens, including countless parents and children from various parts of the world agree that pony rides and petting zoos have no place in a developed, modern world.

Dear Commissioners and LA Parks & Recs,

It is unfortunate that the loudest voices are not the correct voices. The animal rights group that is trying to shut down the Griffith Park Pony Rides is extremely vocal and well organized and well funded. Unfortunately, they are disseminating misinformation and outright lies in order to further their agenda. I have yet to see a veterinarian or true professional equine expert back up any of their claims of abuse, neglect and mistreatment.

I have had horses for over 50 years. We equestrians have built beautiful shelters for our horses just to see them willfully stand in the rain or sun or snow. Horses are individuals and some of them prefer to be out in the elements. Some of them don't. But they are historically accustomed to living outdoors.

Equines need their teeth to be cared for once or twice a year and their feet trimmed every two months - most of the ponies Mr. Weeks acquires have been neglected for many years and he is doing best to keep up with all of their deferred maintenance and veterinary needs. This takes time...and money.

The activists say that Mr. Weeks is getting rich off of the poor ponies. I beg to differ. Hay, labor and veterinary care are extremely expensive - yet Mr. Weeks's concession charges \$5 per pony ride. Believe me, no one is making a great deal of money off of that - I am surprised he is even able to break even. My hay bill for 2 horses is running close to \$800/month...that's just for hay - there are also farrier and vet bills, board and care and much more. I realize that the ponies eat less than a full sized horse - but getting hay in Los Angeles is still a very expensive proposition.

The activists say that the ponies aren't getting "paid". I beg to differ - they are paid with shelter, food and maintenance and medical care. My horses are similarly paid. They actually like having a job to do - a routine. And ponies especially need exercise - they can get a physically devastating conditions due to lack of exercise.

Finally, the activists say "Send the ponies to a sanctuary..."). What sanctuary can take two or three dozen ponies? I support several equine sanctuaries, and they are all at or near capacity. They ask for donations constantly. I have seen sanctuaries FAIL and end up with a pasture full of starving horses. I have seen this several times. The truth is, if the Griffith Park Pony Rides concession's contract is not renewed, the ponies will eventually end up either starved or on a truck going to a slaughterhouse in Canada or Mexico. It is an extremely uncomfortable transport to a grisly death. Mr. Weeks may try to get them good homes, but the truth of the matter is, somewhere down the line - the ponies new owners won't want to foot the bill for elderly ponies

and send them to auction. The animal activists should go to these auctions to see where unwanted animals end up. That's the true crime in this situation.

The following court rules shall apply to all players:

1. The Ethics of Tennis and Sportsmanship shall prevail.
2. Only Tennis or rubber soled heel-less shoes are permitted on the courts
3. When others are waiting:
 - a. Only one set may be played
 - b. No singles may be started
 - c. Double matches shall be played
 - d. Courts will be given at the end of set in progress
 - e. Players who do not wish to play a set may, instead, rally for 39 minutes, after which the court must be relinquished.
 - f. Warming up for match must not exceed 3 minutes
 - g. Sets resulting in 6-all shall be determined by one additional game
 - h. Waiting players must remain in person at court desired
 - i. Courts may not be held by one person alone
4. Children not playing shall not be permitted on courts at any time
5. Dogs are not allowed in tennis courts at any time
6. Municipal Sports Office of the Dept. of Recreation and Parks shall, from time to time grant permits for special events. When these permits are granted, courts must be relinquished to permit holders for the length of time designated on the permit.
7. No teaching or paid service of any kind is permissible except by authorized Rec. Center Program and Dept. authorized concessionaire. No equipment other than tennis rackets and balls are allowed on the court except by authorized Rec. & Parks Programs & Permittees.
8. No Food or Drink is allowed on the courts.
9. No pets allowed on the courts
10. No Skateboarding allowed on the courts
11. A maximum of 6 balls shall be used on any one court, except for Dept. tennis instructors.
12. The preceding rules will be interpreted and enforced by the on-site Recreation Staff or Dept. Instructors.
13. NON-CITY RELATED SIGNS ARE NOT TO BE POSTED.
