Dear RAP Commissioners,

I was on the call yesterday, but didn't get the chance to formally respond on the call. That being said, I wanted to voice my opinion/concerns to you.

When I review your mission statement, it appears you desire to provide a "...attractive, safe and well-maintained parks with diverse opportunities to serve and enrich every community." That is an excellent goal.

However, my concerns are with the potential approval of the "safe parking" effort in Westchester Park. While I support the concept, I have the following concerns as related to Westchester Park:

1. Westchester Park is exactly that, a park for all to enjoy, both for the resource and the "availability to access it". Its original design was only that and the limited associated parking was to allow that. When the "safe parking" was first approved by the Neighborhood Council Westchester/Playa (NCWP) it was contained in the councilman's lot and had no impact to the parking lot footprint approved for the operation.

2. At some point in time, that was expanded to include "park managed property", with park users losing 50 spots for usage during the daytime (lot secured during the day) Understanding this came at the onset of Covid19, some latitude was applied to assist with the pandemic.

3. Since that time, the park has been cleared of all the homeless encampment and major renovations have occurred (pool upgraded and opened and ball fields redone for multiple usages - baseball, soccer and football to name a few). With those improvements, it is highly anticipated the utilization of "our" park will dramatically increase and return to the vibrant recreational area we so desperately need.

So why is there so much apprehension to a effort such as "safe parking"?

Simply put: it is an excellent concept, BUT is not conducive to a "park environment". We have so little space for people to enjoy recreational activities, so why take that away for a process that can be accomplished in many other locations than that of a park's parking lot.

Couple that with the fact that the assigned location has been highly underutilized since its migration to the park managed lot AND that there is LAWA approved 50 slots on property outside of a park, why would the RAP Commissioners see this as "in line" with their Mission Statement?

Finally, the only other parking opportunity, available to park goes, is a "municipal lot", NOT controlled by RAP, and as you can see is completely mismanaged by CD11 and the city of Los Angeles and if CD11 leadership (Mr. Bonin) gets his way, he will acquire 50 more slots there for more "safe parking" and you will be committed to a lease that takes away critical parking for the park with no recourse.

I hope this does not fall on deaf or prior committed ears and you truly weigh all the factors here and the potential impact to Westchester Park, that you are spending tons on money for our community.

I am on the NCWP, but this represents ONLY my personal viewpoint, however, I do believe it represents much of the community as a whole. I have live and raised my my family here for over 34 years and have utilized the park extensively and would love to see that to continue for young families for years to come!

Honorable RAP Commissioners:

Last Friday, we learned from RAP that Council Member Mike Bonin requested another permit for Safe Parking in the parking lot of Westchester Park that serves the recreation pool and the four lighted multi-plex fields. This lot includes 50 spaces, and 25 spaces are fenced off for the Safe Parking program.

Our recreation pool is open, and the ballfields will be open within three months after undergoing renovation. People line up in front of the recreation pool beginning early in the morning to sign up for swim lessons. Our ballfields serve thousands of children. The park serves children from Westchester and surrounding communities, including Inglewood. The users of the park are racially mixed, split equally among Latino, African-American, and Caucasian. It is a park of equity and inclusion.

Our youth need all 50 parking spaces in this lot. There is a shortage of parking in the park in general, with a couple hundred parking spaces serving the entire park and all the amenities a recreation center park offers. Our youth and their families cannot safely park across Lincoln (Hwy 1) or Manchester (a main artery) to access the park.

I include the photos below which I took over the past several months showing that the Safe Parking program in Westchester Park is not well used. Most nights, only a fraction of the spaces are used. I took these photos because I was informed by Sonya Young-Jimenez that Safe Park LA told me that the Safe Parking program in the park was successful and well used. That was not consistent with the observations of our community members who drive by the park at all hours while driving people to the airport, etc.

I would not dispute that people are enrolled in that program and that the City is paying for their use of the program, but they are not using it. The program is inefficient and it uses the much needed parking of park users. Those 25 parking spots are fenced all day, and no one else can use them.


We have a 50-space Safe Parking program opening at LAX this summer, just a mile or two away from the Westchester Park site.

Please do not allow the City to take parking from park users who need it. The safety of our youth, from all communities, using the ballfields and the recreation pool depends on the availability of these parking spaces.

 Good afternoon,

We had another incident involving a homeless person on the tennis courts at Westchester Park this morning. A homeless man with his dog walked to the entrance of a court and would not let the tennis pro onto the court to use it. The stand-off lasted for about 15 minutes.

This follows three incidents involving homeless people at the tennis courts last month. In one incident, a homeless man wrapped in a blanket walked onto a court on which a pro was giving lessons to 12-year-old girls and started saying so all could hear, and repeatedly, that "these girls just want to f\*\*\* me." The next day he showed up again and jumped a fence onto a court on which a tennis pro was giving lessons to five-year-old girls. He spoke lewdly again. These incidents were frightening to children and tennis pros.

A week or two before that, a homeless woman walked onto the court area and grabbed a clipboard from a woman who keeps track of court assignments and yelled at the woman until a tennis pro went to the woman's rescue.

Over the past couple years, we have had hundreds of incidents in the park involving homeless people and children. These incidents have included indecent exposure, meth-infused meltdowns, racial slurs children could hear, following children, trying to engage children in conversation, poking penises through the chain link fence surrounding the tennis courts and urinating on the courts, attacking children in the restroom, claiming that children belong to them and demanding the children be turned over to them, fires, open drug usage, and more. The danger is well documented, and it continues.

It is not safe to have homeless people living in the park, and we have nearly 30 vehicle dwellers living in the park now. Most of these vehicle dwellers use more than one parking space, and some use up to six parking spaces each. There is already an insufficient amount of parking in the park. Families cannot be expected to cross Lincoln Blvd. or Manchester Ave. to find parking. These are both very busy streets with multiple lanes. The ball fields in the park will be open on October 3 which will increase the need for parking. I am attaching photos taken this week so you can see the state of this parking lot and the number of spaces used by homeless vehicle dwellers.

We ask that the City find another location for these vehicle dwellers so users of the park can be safe and have adequate parking available for users of the park for purposes for which it was intended.

Mr. Royster, we have repeatedly asked you and your office, the General Services Division, for information as to CM Bonin's plans for the lot that is bounded by the senior center, the city library, and CM Bonin's field office. Your department has jurisdiction over that lot.

While your office has provided estimates CM Bonin obtained in January to fence that entire lot, you have provided no further information in response to our questions as to why Mr. Bonin obtained these estimates. We are aware that CM Bonin's office inquired of the CAO in March regarding funding to use that lot for "Safe Parking."

We strongly oppose this, as it is not an appropriate use for a city parking lot that is basically in a park and needed by park, senior center, and library users. That parking lot has been used by park users for 75 years.

We ask you to provide information we have requested by filing Public Records Act requests months ago. We have been excluded from this public process.

Once again, we request a meeting with you, Mr. Royster. Please provide, at your earliest convenience, times you will be available to meet in person or by Zoom.

Dear Council Members and City Officials,

This might be the third letter I have written to some of you to no avail. I am writing to you in sheer frustration on behalf of my handicapped mother-in-law and other handicapped patrons of Westchester Senior Center and Westchester Library located in CD 11 on the busy Manchester and Lincoln boulevards and in support of the woman and children who wish to use this parking lot for the library or to use the parking lot for children's sports. I have sent letters, emails and have called numerous times with absolutely NO acknowledgement or action taken. Our elected officials need to listen and respond. *Am I wrong to believe that clear safe access to public spaces is a right to all, and not just for the homeless?*

### **THE CITY HAS ILLEGALLY PREVENTED THE CLEAR ACCESS TO PUBLIC SPACES FOR HANDICAPPED AND FRAIL SENIORS**

I have a handicapped mother in law whom I cannot take to the Westchester Senior Center or the Westchester Library because of these illegal RVs and campers taking up the handicapped spots. Due to her circumstances, I cannot park on the street because I would have to park illegally (and dangerously) 3 feet away from the curb to be able to get her out of the car and into her wheelchair. On Manchester, this would be certain injury to body and car. I am unable to park in another regular spot because if someone parks in the adjacent spot after I'm in the building, I will not be able to open the door wide enough to accommodate her wheelchair. *Don't the handicapped and seniors matter?* Seniors are vulnerable and yet our politicians do NOTHING.

Woman and children don't feel safe as the daily Westchester news about these homeless living in this lot assaulting park goers, starting fires, stabbing people, stealing and even shooting at people in and around this parking lot. Handicapped children use the Westchester Library as their mental playground, yet they are prevented from accessing this important building due to the homeless encampments taking valuable spaces and the lack of safety as it takes quite some time to load and unload a severely handicapped person into and out of a vehicle rendering them vulnerable to aggressive homeless people. It is hard enough for a family to transport their handicapped loved one, you are making it harder on them. *Don't handicapped children matter?* Really, this simply disgusts me to have to ask.

Below are photos taken just 2 days ago showing how the handicapped spots are obstructed by RVS and people camping in handicapped spaces. This is a typical day. Many of these people are aggressive to anyone wishing to park here. They have illegally camped in the public parking spaces, including the handicapped with no enforcement, no safety patrols,





### **THE CITY HAS PREVENTED EQUAL ACCESS TO COOLING STATIONS, POLLING STATIONS, LIBRARY AND SENIOR SERVICES DISENFRANCHISING THE ELDERLY AND HANDICAPPED**

The Senior Center has been a designated city cooling station, as well as the Library, unofficially, for people to seek refuge from the heat for heat stroke prevention. Elderly people on a fixed income can't afford to cool their homes and would go to the library during the day to stay cool. They do not feel safe to go there with the homeless encampment in the parking lot. They cannot park in a close handicapped spot. *Don't the seniors matter? Will more seniors die from heat stroke because they could not get cool during the hot summer days? Are they out of sight and out of mind? Or no squeaky wheel taking a microphone....*

Seniors and handicapped were disenfranchised in the June election as they were unable to vote due to the lack of handicapped parking and safe parking at their polling station there at the library. In June, the Westchester/Playa Neighborhood Council met and demanded Bonin's office to allow for safe passage to the Senior Center and the Library.

*Bonin cared not, did nothing, and has clearly no interest in public safety, only HIS personal safety, but I will address that below.*

The Senior Center has been a place for legal assistance, rent assistance, nutrition to help seniors from becoming homeless, too! But due to the homeless encampment, the Senior Center was closed for quite a long time. It is supposed to have opened by now, but looking at the pictures above from 1 days ago, I can assure you that seniors will

not feel safe going there. How many seniors will lose their homes because they didn't get valuable legal and financial assistance from the free services provided at the Senior Center? How many seniors will be undernourished and lonely because they were unable to go to the Senior Center? How many seniors have fell victim to crimes that they won't have resources for because they feel unsafe going to the Senior Center or because they can't park close to the entrance? The City has caused this problem by not enforcing laws on the books for handicapped parking and camping but has chosen not to enforce these laws. *Do the 20 or so homeless encamped here illegally matter more than the thousands of seniors and handicapped residents?*


The Library has been the only location for seniors to get information from computers as many of them can't afford a computer or internet. Blocking their access to the library prevents them for daily activities that YOU take for granted. The library, aside from a cooling station, is a safe place to research and read. *Seniors and handicapped are unable to do this basic activity due to the lack of adequate, safe handicapped parking from illegal parking, camping and dumping in handicapped spaces.*

**BONIN IGNORES OUR PLEAS FOR PARKING LOT CLEARANCE AND SAFETY YET SEEKS PERSONAL GUARDS AND FENCING FOR REGIONAL OFFICE LOCATED NEXT TO WESTCHESTER SENIOR CENTER AND LIBRARY**

Bonin was begged and pleaded by thousands of Westchester residents to please do something to remove the homeless from the parking lot due safety and he ignored us. However, in June 2021, his own staff member sent a letter to the city attorney asking if the homeless can be removed from the entrance of this very building because he was "disruptive". Once she got pushback, she apologized to the community for speaking on her own but not from Bonin's perspective.

Again, through thousands signing park [petitions](#), [homeless petitions](#), emails, phone calls we pushed and asked to please move the homeless from the park and parking lot as it was unsafe for the public using the facilities and we were stonewalled. Bonin actually was a dissenting vote not to enforce the anti parking/camping ordinance that was passed by the City Council. Yet, secretly, overnight he erected a barbed fence around his field office at Westchester Park and hired private duty security while telling us there is not a safety issue.

**HOMELESS ENCAMPMENTS/PARKING AT WESTCHESTER PARK REDUCES PARK USE DUE TO SAFETY IN AN UNDER PARK/GREENSPACE COMMUNITY**

The mayor mandated a 4.0 acre park/1000 person plan for the city. This community park space as shown below from the Los Angeles Countywide Comprehensive Park & Recreation Needs Assessment Study below is critically below the Mayor’s park equity goal. It shows that at present the park acres/1000 is terribly below the goal with less than 0.8 park acres/1000. Homeless encampments take valuable space needed for park and facility use. It has come to our attention that Bonin is clandestinely getting bids to fence the entire lot for 24 hour homeless camping. Where will our seniors, handicapped, families park? Don’t they matter? Increasing safe parking by taking these valuable spots will reduce park usage in a very needed area that is underserved.

Here is an excerpt of an email that was sent to the Park & Recreation and City Council yesterday that summed up the most crimes against children and adults by homeless living in the Park that we have become aware of:

"We had another incident involving a homeless person on the tennis courts at Westchester Park this morning. A homeless man with his dog walked to the entrance of a court and would not let the tennis pro onto the court to use it. The stand-off lasted for about 15 minutes.

This follows three incidents involving homeless people at the tennis courts last month. In one incident, a homeless man wrapped in a blanket walked onto a court on which a pro was giving lessons to 12-year-old girls and started saying so all could hear, and repeatedly, that "these girls just want to f\*\*\* me." The next day he showed up again and jumped a

fence onto a court on which a tennis pro was giving lessons to five-year-old girls. He spoke lewdly again. These incidents were frightening to children and tennis pros.

A week or two before that, a homeless woman walked onto the court area and grabbed a clipboard from a woman who keeps track of court assignments and yelled at the woman until a tennis pro went to the woman's rescue.

Over the past couple years, we have had hundreds of incidents in the park involving homeless people and children. These incidents have included indecent exposure, meth-infused meltdowns, racial slurs children could hear, following children, trying to engage children in conversation, poking penises through the chain link fence surrounding the tennis courts and urinating on the courts, attacking children in the restroom, claiming that children belong to them and demanding the children be turned over to them, fires, open drug usage, and more. The danger is well documented, and it continues.

It is not safe to have homeless people living in the park, and we have nearly 30 vehicle dwellers living in the park now. Most of these vehicle dwellers use more than one parking space, and some use up to six parking spaces each. There is already an insufficient amount of parking in the park. Families cannot be expected to cross Lincoln Blvd. or Manchester Ave. to find parking. These are both very busy streets with multiple lanes. The ball fields in the park will be open on October 3 which will increase the need for parking. I am attaching photos taken this week so you can see the state of this parking lot and the number of spaces used by homeless vehicle dwellers.

We ask that the City find another location for these vehicle dwellers so users of the park can be safe and have adequate parking available for users of the park for purposes for which it was intended.", as written by Debra Huston a resident of Westchester.

**Our vulnerable have rights to safe use and passage of public spaces. Homeless near public parks and services harms more than it helps. Seniors, handicapped, children deserve access to the Library, Senior Center and park space without harm. Using the Park parking lot has proven to harm this community. We insist on relocating these individuals to lots not close to parks, schools or vulnerable people.**

**As our city representatives, I implore you to take action: enforce handicapped parking laws, enforce anti-camping/encampment laws. Find another lot, move these people, make safe passage today for the vulnerable.**

Thank you in advance for your assistance in this matter, as our own City Councilman has ignored our urgent requests.



Once again, we request a meeting with you, Mr. Royster. Please provide, at your earliest convenience, times you will be available to meet in person or by Zoom.

Good morning, all.

Wanted to let you know that I received a call from someone from the tennis courts telling me that on Sunday, 8/21, a man walked on to court 7 while people were playing on that court and urinated, exposing himself. He spent the entire day pacing and lurking around the tennis courts. He has returned two days since, walking on the walkway between the courts, sometimes carrying a beer. It appears he may be mentally ill because of all the pacing he does, aside from the act of urinating on the court. He has shown other forms of aggression by knocking down a sign at the courts. He has been seen walking between the courts with a can of beer.

The man was described to me as follows:

Caucasian, 5' 10" or so. All three days he was at the court he was wearing the same grey or black bermuda shorts. The first day he wore no shirt and the next two days he wore a black t-shirt. He was wearing slippers on his feet most of the time. He is in his late 20s or early 30s. Light brown straight hair that is short. Caucasian but maybe "in between" because his complexion is darker than that of most caucasians.

People using the courts are afraid of him and of what he might do. LAPD was called.

The people at the courts would feel safer if officers, rangers, or private security could be there to keep a watch for this man, as they fear he will be returning and may escalate in his behavior.



I have only two things to add to Debra's email:

In yesterday's news item, Ms. Goldman from Mr. Bonin's office said they have found housing for over 100 people who were living in the park. However, the number of campers has grown. People moved from the park to housing is an output, not an outcome. Does Mr. Bonin's office or any other agency have information about what the daily population of campers in the park has been over the last 12 months? Among the 100 people moved, how many are "dual residents" with campers in the park? How many are still in transitional or permanent housing?

Also, the email from Sachin Medheker indicates the intent to convert the entire lot to Safe Parking has been considered for some time. When was this first proposed or considered, and what community outreach was done before the email asking for costs was sent to the CAO? Converting the parking lot to Safe Parking would be a fundamental repurposing of the park's physical plant, and certainly not consistent with its original purpose. This week, a vicious dog owned by a homeless person who is living in the municipal parking lot at Westchester Park attacked an LAPD officer and a social worker. This same dog had already attacked others in the same parking lot within the last week. The man was arrested and spent a day or two in custody. He is expected to try to retrieve his dog and return to the park.

Yesterday a CBS News team went to the municipal parking lot to do a story on homeless vehicle dwellers interfering with public access to the library, the senior center, and other facilities in the park, and that news team, which included two women, were accosted by homeless men as they were doing their work in filming footage and interviewing people who were trying to use the library.

The news team left that parking lot rather abruptly out of fear for their safety, and went to another parking lot to continue their interviews.

The CBS news team reached out to CM Bonin's office for a statement, and in their news piece quoted Bonin's office as saying they have placed so many people in Westchester Park and they will continue to do that. Basically, that means he is not going to allow anyone or any city agency to move these vehicle dwellers out of the park and to another location.

CM Bonin, in his statement to CBS, also omitted the fact that he is trying to get a permanent Safe Parking program in that. CM Bonin has obtained estimates to fence that entire lot and a member of Bonin's staff has inquired of the CAO by email regarding funding sources to use that entire lot for Safe Parking.

We asked our County Supervisor, Holly Mitchell, to help us get information from Mr. Bonin's office, as he will provide no information at all to our community regarding his plans for this lot. The only information we have received is in response to PRA requests filed over the last five months. Yesterday, we received an email from Sup. Mitchell's staff stating Mr. Bonin's office would reach out to his constituents when he has something to report. We are aware that Bonin reaches out to constituents only after his plans are approved.

We have been doing everything within our power to work with Mr. Bonin's office, but we are met with a brick wall. We have reached out to Mr. Royster, GM of the GSD, many times, and we are met with a brick wall. Because we understand GSD has jurisdiction over this lot and any request for a permit to use this lot for Safe Parking would be issued by GSD. We have requested meetings with Mr. Bonin's office and with Mr. Royster, to no avail.

Community members of Westchester have been entirely excluded from this public process. Meanwhile, people do not feel safe in that parking lot, and they are not safe there. Also, this parking lot is the largest in the park, 112 spaces, and people who use the senior center and the library need this parking. The ball fields, which have undergone renovation, will open October 3 and thousands of youth athletes use those fields. We cannot expect children and their families to find parking across Lincoln Avenue--a seven-lane stretch of Highway 1.


I am attaching one of the estimates CM Bonin obtained to fence the entire lot. I am also attaching an email from Sachin Medhekar of CM Bonin's office inquiring of the CAO about the availability of Roadmap (covid) funding to use that parking lot for Safe Parking.

I noticed in the news piece the man lying next to the entrance to the senior center. This man, who is homeless, has walked onto tennis courts on two separate days. The first day he walked onto the court where several 12-year-old girls were taking tennis lessons from a pro. The man began saying "These girls just want to f\*ck me. I tell them I'm just a homeless guy and they still want to f\*ck me." The next day, he leapt over a low fence onto a court where five-year-old girls were taking lessons and began the vulgar sex talk again. In each case, the girls and the pros teaching them were terrified.

**We plead with our city officials to find another lot for people who reside in their vehicles in Westchester Park. There is no other park in the City, out of 480 parks, that has a Safe Parking program. Using this lot as a Safe Parking program is not consistent with park uses or purposes, and it is not safe for children, seniors, and others.**

Please contact me with any questions, and if you would like to visit the park and see this situation for yourself. Our community would like to work with you and be a part of this public process. Thank you.

Hello all -

I am sorry to have missed the zoom but I finally got Covid. It seems like a lot was accomplished on the call and thank you Mrs. Greenwald for the notes/zoom recording, and thank you all county offices for devoting their time and future energies to this problem. We do appreciate you and are doing everything in our power to help you.

I was uplifted when I heard LAPD was at the park but I am surprised that tickets weren't issued. We all heard the warning issued to the dog owners on a bullhorn or loud speaker but these are the same people who have been coming every night for the last year. They know they aren't supposed to have their dogs off-leash. The park crowd was scarce for a couple days after the warning but all these owners know the drill - warnings are given but never citations, They wait a few days until the dust settles and are all back.

There are currently 15 or so dogs that have been off-leash in the park for the last hour plus. They include the owner of the black lab with the cropped tail that was warned last week, the man with the corgi who emptied out the other day when the warning was issued, the woman in the white lexus who drives to Oakwood every night, the couple in the Mazda who park on oakwood and comes every night for about 2 hours (that have been warned by Animal Control, LAPD, and Keith Rice and his staff) , the mini-golden doodle that was warned, the labradoodle owner that was in the park 2xs when warnings were issued last week.

While I appreciate the effort, we have all agreed time and time again - **the only thing that works is repercussions in the form of tickets. How have there been 20+ dogs in the park on most evenings and 1 citation given this week?**

Just want to make sure we aren't pinning the tree issue on urine. These trees are older than the park in most cases and have only recently become distressed because of the watering issue. No tree expert that I've talked to has worried about the dog urine. For the record I am still concerned about the amount of water that the trees are getting.

Thank you for the items that you have addressed. Some things we are still waiting for answers to. Most importantly the park budget plus available funds vs funds that would need to be found outside of RAP. Realistically the only item that should need outside funding vs our park's yearly budget and the Measure A funds that RAP receives for our area are rest rooms. Do we need to set up a meeting with you or someone else to do this? There is also an account with approximately 25k in it that Ramon Barajas can probably help us identify again. It was set up for a PAB for the park and never spent. Mike Shull identified it for us and it should still be available.

Hi Brian,

I'm sorry this has taken so long. We appreciate you meeting with us and it was lovely to meet you, but I am very confused as to who we should be talking to regarding some of the specific questions about maintenance of the park. As you know I made our appointment with Wayne Neal and there are obviously issues that only he could answer. So I'm thinking that we can review a list of concerns we went over and maybe get an idea of who we have to lobby for answers/action.

There are 2 neighborhood councils that have Parks committees for the Sepulveda Basin. Lake Balboa and Encino. From what I am understanding there is no RAP representation at any of the meetings. Is this a recent department decision or did this just fall through the cracks?

As a nonprofit for the park we held two adoption events a year, a very popular Holiday event and a spring event. We think that it is a good location for more adoption events. You informed me that we will need permits going forward. Is there an event coordinator with RAP that we should talk to? Can I get a contact for that?

Two pressing issues for us may not be questions for you or Wayne but we keep asking everyone. The purple line and the bike path. We would like to know the status of both.

The biggest issue for the majority of the patrons of our park is the grass. I say grass but it is the erosion of the soil over the last 3 years that is one of the main concerns of the Army Corps as well. The sprinklers which were not readily visible are now an inch above the dirt line so we have eroded that much soil. In the Army Corps Master Plan I left with you, it advises that the dog park should be kept clean and not lead to the contamination of the LA River with feces and urine. In the past to satisfy that direction we have had grass as the vegetation but nothing has been done in the last 3 years. I just went to check out the 8x Pickleball courts that the City of LA just painted on 2 of the tennis courts at Westchester Tennis Center and they look great. See the pictures below.

Please, you've got to do the same for us. 4x Pickleball courts on 1 tennis court will simply be not enough. The popularity of Pickleball and the demand for more courts are real! You can't deny that. And since the contractor is already there, you might as well have them paint 8x on 2 tennis courts like they did here. We have been playing Pickleball on tennis court #8 at the Palisades Rec Center for almost a year now and we have yet to hear any complaint from the neighboring residents.

Again, I urge you to please reconsider painting 8x hybrid Pickleball courts like you did here at Westchester instead of 4x. What will it take for you to change your mind?

My name is Isabelle Duvivier. I'm a Community Forest Advisory Committee Rep for CD 11 as well as co-chair of the Verdant Venice Group, also known as VVG. We are a group of local volunteers that plants, mulches, and cares for trees. We have planted over 300 trees. VVG has collaborated with many city agencies to plant and care for our young trees. Last year we worked with Streets LA, to remove the permeable concrete, that was strangling 77 mature sycamore trees along Venice Blvd. Currently we are working with LADOT to improve and care for native understory plantings at several parking lots including Tabor court and the Farmer's Market site.

I am here today regarding Centennial Park next to the Venice Library that was fenced off several months ago to keep the homeless encampment away. Centennial Park has several dozen sycamores trees that were planted as part of a boulevard wide planting plan from Ocean to Lincoln Blvd. Those trees at Centennial Park were regularly watered until the homeless encampments moved to the site. That irrigation was recently turned off. VVG is hoping that RAP can help us care for that park and those trees by:

1. turning the irrigation back on, OR
2. allowing VVG to get into the fenced-in area so that we can mulch and water the trees, AND
3. keeping in-communication with VVG with regards to the future landscaping plans.

We hope to see our sycamore trees at Centennial Park well nurtured. We also hope that the future understory plantings will be coastal CA natives.

### **Neighborhood Councils**

Neighborhood councils are the boots on the ground for LA city government and are often the first place stakeholders turn when having issues. Our service to the City and our communities is on a volunteer basis, but there is a limit to how much time and labor each of us can give. When the pandemic hit and all departments were asked to cut their budgets, Neighborhood Councils took a disproportionate 24% reduction. We need our budgets restored to their original \$50,000 plus an adjustment for inflation which would bring our budgets to \$82,000 per year. It is very hard to function on our current \$32,000 a year allocation and make a significant difference in our communities.

If we provide simple snacks for our meetings that's 2% of our budget. If we fully fund a single neighborhood purpose grant and that's over 15% of our yearly budget. Our rent to have a meeting space in our community as required under the Brown Act is over 56% of our budget. We have to decide between basic operational expenses and making a difference in our neighborhoods. Most NCs are making this up by over relying on the free labor of our board member volunteers and we are getting exhausted and worn out.

This has a disproportionate effect on disadvantaged communities where board members do not have the luxury and privilege of time to dedicate hours upon hours to service of their communities. It has become clear that the City is leaning very heavily on our free labor and the situation is untenable and will drive active volunteers out of the NC system. It was especially disheartening to hear Capri Maddox exemplify this point during the Budget Hearings on May



2nd, saying that the Civil, Human Rights, and Equity Department was leveraging the free labor of Neighborhood Councils to save money in their outreach budget. If the NC system is to survive and thrive, we need our budgets reinstated to \$50,000 a year with an additional adjustment for inflation which would bring our budgets to \$82,000 a year.

The Reseda Neighborhood Council opposes the request by the Department of Neighborhood Empowerment for increased engagement and awareness budget. We refer the City Council to our previously filed community impact statement available [here](#).

### **Emergency Management Department**

The Reseda Neighborhood Council is also very concerned about the capacity of the Emergency Management Department. Los Angeles County was ranked highest in the nation for natural disasters in FEMA's 2020 Natural Risk Index and while experts on urban emergency response recommend that cities the size of Los Angeles have 100 people for emergency management, as of November 2021, the Emergency Management Department had 18 filled positions.

We ask that, in addition to proper funding and access to immediate funds in emergencies, that the Emergency Management Department develop a five-year plan to bring itself up to the basic level of being able to protect Los Angeles and that the City Council work with the Department to implement it. To save lives, we urge the creation of a revolving fund of \$10 million that can be drawn on without delays.

### **Ethics Department**

Furthermore, given the City's well-publicized ethics issues, the Reseda Neighborhood Council asks that the City strengthen the Ethics Department by increasing its authority and independence. Angelenos should not settle for less. **Two of the three following recommendations should be implemented:**

- Give the Ethics Department the ability to place legislation directly on the ballot.
- Give the Ethics Department its own independent legal counsel outside of the City Attorney.
- Give the Ethics Department a steady source of funding not under City influence.

### **Department of Transportation**

We recommend that LADOT be funded to work towards Vision Zero and Mobility 2035 goals. We also recommend that the West Valley traffic engineer and its support staff be fully funded. The West Valley needs long lasting traffic improvements that can be best done by smart road design. The Reseda Neighborhood Council is committed to street design changes that prioritize safety and reduce pedestrian fatality and injury.

We also would like to see the city prioritize shade equity along transportation routes and invest more in transportation infrastructure in communities that have traditionally been overlooked.



## **Recreation and Parks**

Lastly, the Reseda Neighborhood Council strongly desires park improvements, particularly the development of a splash pad in the West Valley. We ask that the planned improvements for “triangle park” include a splash pad water play feature. This was recommended in the [LA County Parks Needs Assessment](#) and the need for a splash pad only grows as heat increases and the West Valley grows. A splash pad play feature would be a much needed recreation feature but also provide a modest economic boost to Reseda as families from areas outside Reseda would travel to our area to use this amenity.

I am a daily user of golf facilities at Rancho Park. Rancho is one of the busiest facilities in the City's golf division, let alone the entire rec & park system. Yet its clubhouse facilities have been ragged for years, decades in fact, and now they have been closed for over two years. I learned this week that disputes between the City and the restaurant development team have completely broken down and the parties have withdrawn. As a retired developer of comparable facilities I was pleased and impressed when this new arrangement first rolled out. I was then patient and now I am very frustrated and worried about what is to come. There was so much potential and there still is.

While there must be a lot of fingers to point, what matters most is how the City is going to go about resolving issues that led to dispute, select a new lessee (with comparable or better qualifications), and remobilize. As we look to what could be months or years until construction is again mobilized, I hope the Administration can provide some transparency to the public and golfers in particular. Here are some questions:

- 1) Have arrangements been made for a new temporary food and beverage service?
- 2) How will the site be secured and maintained until construction commences again? We should be concerned about safety, convenience and protecting the structures from vandalism. As an aside,
- 3) Bathroom facilities are too few and abysmal. The two replacement bathrooms installed prior to the pandemic do not have any ventilation. With everything we know about health and ventilation, that this continues is shocking.

4) What steps is the City taking to select a new lessee?

I would appreciate if you could provide me with publicly available management reports on this matter to advisory committees, the Park and Rec Commission, and City Council. Perhaps there are websites and search links where the reports are available.

I trust there is great urgency to get this situation turned around and the case for expediting good solutions is being made.

We could clearly hear sounds of hammering and sawing this morning so our friends are clearly expanding their abode in a very permanent endeavor. And I'm reiterating here, as far as I was able to determine based on the city council's mandate

of no camping withing 500' feet of a park or school, these new camps are well within Park & Recs jurisdiction to enforce eviction.

Thanks to all the CITIZENS who are responding to this thread and monitoring the ongoing fires and pollution in Debs and playgrounds/Sycamore Grove/Arroyo environs.

I can't help but notice that there has been NO response (at least in a reply all format) from ANY city official...oh, except for turning on a spigot at Peanut lake and a small amount of graffiti abatement. Personally, I have had to call 911/FD three times in the last 2 weeks for active fires. This has become a nearly useless exercise, and a deadly game of Russian roulette.

Unless there is a public meeting scheduled that actual city (public servants) authorities attend (fire, ranger, police, city council, RAP) within the next 2 weeks, I wholeheartedly embrace informing media about the ongoing threat to hundreds of thousands in the area around Debs Park because it is not a matter of IF, it is WHEN a major fire escapes the homeless arsonists and takes out homes and people.

There are at least TWO ordinances now that give authorities (public servants) the ability to evict and/or arrest those who continue these arsenious activities...and yet, all we hear is that "we are waiting for the go-ahead". From WHOM, exactly? The city council passed ordinances, so cops and rangers are able to get going NOW. The FD has always had authority, but they seem to be bored and are becoming less responsive ("Is the fire in the arroyo? Well, call us back if any brush starts up"...yes, that is a direct quote from 911 dispatch).

OUR PUBLIC SERVANTS somehow think that they are no longer answerable to constituents. We can't let this continue.

--I didn't walk yesterday, but my hiking partner told me that she had to call 911 because Fire Dude had ANOTHER conflagration happening up north of the pedestrian bridge on Griffen. FD responded, but how many of these fires are going to happen before NELA goes up?

--I am attaching 3 pics taken this morning from the pedestrian bridge. The first is a lovely trash abode just north of the bridge IN the channel, almost in the water. You can clearly see the orange toidy bucket that they are no doubt dumping directly into the water after use. Do we care that there is not only a hygiene issue, but potential flash flood danger to whoever is in that mess?

--The other 2 photos are really crappy, but are from south of the bridge showing a nice beach front umbrella set up with a new Plywood Palace up the west embankment in the bushes. We could clearly hear sounds of hammering and sawing this morning so our friends are clearly expanding their abode in a very permanent endeavor. And I'm reiterating here, as far as I was able to determine based on the city council's mandate of no camping withing 500' feet of a park or school, these new camps are well within Park & Recs jurisdiction to enforce eviction.

However, it's also obvious that it's a "pick your authority" situation: Parks, Police and Cal Trans are overlapping here, with any and all being able to step in and deal with this. CAN we deal with this?

Re: HISTORIC SHORT LINE BRIDGE AND GRAND CANAL MOTION

Dear Commissioners:

Please be advised that at a regular public meeting of the Venice Neighborhood Council (VNC) Board of Officers held on August 16, 2022, the following motion was approved.

Whereas the bridge traversing Grand Canal between North and South Venice Boulevards was built for the original Short Line Railroad in the 1900s and is one of the oldest bridges in Los Angeles, facilitating the original creation of Venice of America and the continued visit of hundreds of thousands of people until the 1960s; and

Whereas the Grand Canal is the sole remaining portion of Abbot Kinney's original Venice Canals built in 1904 and is on the National Register of Historic Places; and

Whereas it was this bridge that enabled people of color to come from other parts of Los Angeles to work in Venice before the time when they were able to live or own property in the area; and

Whereas the bridge and canals were primarily constructed by Black, Mexican and Chinese people whose rich cultural history has been overlooked; and

Whereas the Venice Canal is a biologically sensitive coastal wetland in the Duel Coastal Zone, which the California Coastal Commission mandated be a habitat conducive to native wildlife including the endangered Least Tern bird; and

Whereas the City of Los Angeles is in violation of the California Coast Commission mandate that the canal boat ramp be accessible to the public for recreation in addition to continuing to serve the entire Venice Canals maintenance needs; and

Whereas the City has not maintained this parcel in good repair such that it is an eyesore to the hundreds of thousands of visitors to Venice Beach and the Historic Venice Canals and has not installed interpretative historic signage and plaques as agreed by U.S. Army Corps of Engineers, the National Advisory Council on Historic Preservation, and the City of Los Angeles; and

Whereas the City is currently proposing to develop 40 contiguous lots located on both sides of this portion of Grand Canal, to sandwich the bridge and canal between two tall buildings, cutting off the aprons of the bridge, rendering it unusable by cyclists, scooters and strollers who for generations have loved traversing it, eliminating public access to the boat ramp and showing no general public access to the entire historic site; and

Whereas the balance of the Venice Canals are residential, thus this site lends itself to public enjoyment of the natural wildlife, historic and recreation not possible elsewhere; and

Whereas Venice has fewer parks than most other parts of the City of Los Angeles.

VIOLATIONS OF CIVIL RIGHTS

"City of Los Angeles Ordinance 187134, COVID-19 Vaccination Requirement, requires proof of COVID-19 vaccination for all current and future City personnel, including volunteers. This mandate extends to all Recreation and Parks (RAP) volunteers. At this time, there is no vaccine exemption policy for RAP volunteers."

The statement highlighted above in yellow is false. The ordinance 187134 states in the following sections:

Sec. 4.702. Qualified Exemptions.

All current and future City employees shall have the right to petition for a medical or religious exemption to be evaluated on a case-by-case basis, consistent with City procedures for reasonable accommodation requests.

**Sec. 4.700. Definitions.**

(b) Employees" includes, full, part-time and as-needed City employees regardless of appointment type, **volunteers**, in terns, hiring hall, appointed officers, board members and commissioners, 120-day retired employees, elected officials and at-will appointees of elected officials.

These are activities that conflict with my religious beliefs, practice and observance. **Expression of my religious faith is protected by state and federal laws.**

Any delay that results in my further religious persecution will be your responsibility. You will be held responsible for violating 18 U.S. Code §241, Conspiracy of deprivation of rights. This is a felony.

**I am requesting your written response in 7 days.** I look forward to hearing the resolution you will put forth, adding "religious exemptions" to the **Volunteer's Proof of Vaccination Guide** and widely publicizing this information.

Any delay that results in my further religious persecution will be your responsibility. You will be held responsible for violating 18 U.S. Code §241, Conspiracy of deprivation of rights. This is a felony.

**I am requesting your written response in 7 days.** I look forward to hearing the resolution you will put forth, adding "religious exemptions" to the **Volunteer's Proof of Vaccination Guide** and widely publicizing this information.
