I am writing to you to express concern over the opening of this park adjacent to our residential neighborhood on irresponsible conditions. We live on one of the residential streets along the canyon, and have been concerned about this park since moving here in 2012. Since moving here, we have unfortunately experienced, on our street alone, a notable increase in property crime, homeless squatters, and an increased frequency of fires and fire hazards in the area.

What I am hearing is the city's plan to open this park imminently is absolutely not safe and highly irresponsible.

This park provides direct access into our residential neighborhoods and backyards. With zero park ranger oversight, zero lighting, zero security, zero rules or regulations, you are inviting more of these incidents. The city has known about all the risks and issues in the area. Opening the park with no plan in place in the context of all the issues we have had is irresponsible and negligent at best.

Has the city decided to turn a blind eye to the fire hazards caused by nighttime camping in the bluffs? It is common sense that if you keep a park like this adjacent to pch, with no barriers whatsoever, open all night with no restrictions or enforcement of any rules, these fires will occur even more often. You cannot be willfully blind to this risk.

As you know, since we have been alerting the fire department for years, some of the streets along the canyon — in particular De Pauw street where I live— is so narrow that, given the parked cars along the street, a fire truck is not always guaranteed access. So if there is a fire, which there will 100% be in a park like this with no restrictions or oversight, how does the city plan to have the emergency vehicles access the area in time to save lives and property? What is your plan, because you need one. The residents deserve to know.

How about the high rate of residential break-ins of the homes specifically along the canyon, where broken glass along the canyon-facing windows, coupled with an exit by the burglars via the canyon, is consistently the point of entry and exit in all cases? No lighting, no security, no rules or oversight? How can this possibly not encourage more of this? It's literally providing a paved pathway to invite more of this behavior. What is the city's plan to mitigate this risk in connection with the opening of a park that has no restrictions on access or use?

It seems, given the issues in our neighborhood, that the city's proceeding to open the park on these conditions (actually on no conditions at all whatsoever as I understand it) is indicative of the city intentionally ignoring the reasonable needs of the residents and our neighbors to keep our community safe. It is shocking.

The park needs to be gated and locked during restricted hours, like we were assured it would be. If the park must be built there, it can only be opened and operated in a responsible manner, with restricted hours and rules about usage, and enforcement of those rules, to minimize the danger to the residents who live around it. Knowing about all the risks, and yet choosing to ignore them completely, is not an option. The city still has a responsibility and duty to its tax-paying residents.

Dear City Officials,

I am writing to you in my capacity as Safety Chair on the board of directors of the Hollywoodland Homeowners Association.

What are your plans for public safety in Hollywoodland, including fire prevention (no smoking), trespassing, and traffic congestion caused by vehicular and pedestrian traffic during the winter holiday season which will soon be here? We have absolutely NO infrastructure for visitors, and our hundred year old substandard narrow, winding, dead-ended streets with no turnarounds or sidewalks just barely cover the needs of residents.

Daily we have problems with the issues mentioned above. (For example there can be close to 100 cars at the illegal view site. How would you ever evacuate these visitors along with residents if such an undertaking were necessary?) We also have extremely limited ingress and egress as we jut into the park as a bottleneck, 80% surrounded by dry brush. When the holidays come there are so many more visitors, and conditions here are even more dangerous.

We have already received notice that there are holiday plans in other parts of Griffith Park east of us "if the park becomes overly impacted during this busy week." And the east part of Griffith Park is where there is long standing infrastructure in place for tourism. What are your plans for us? We want to know the specific criteria you are using in Hollywoodland in determining what is a safe capacity for our streets and magnets, and exactly what is that capacity. When is it too much and what will you do then? Those questions of limits and capacity are common place all over the world where the public gathers.

At times you have placed some DOT officers in our neighborhood. They are mainly stationed at the bootlegged magnets. This is not sufficient. The numbers of visitors have skyrocketed, and their negative impacts have spread to streets further away from these points, and into areas that are even more fragile and narrow.

Dear David Kim and Matthew Rudnick,

I am writing to comment on my experiences since A Bridge Home shelter was built. I am planning to call into the RAP Commission meeting tomorrow as well.

My wife and I have lived in the same apartment on Riverside Drive for almost six years now and have experienced a dramatic negative shift in our safety since A Bridge Home was built. I will outline our experiences below:

- Trash and litter are all over the area in front of the Bridge Housing and up and down the street (this is a constant since the shelter was constructed and did not happen before).

- A few days ago I had to call the fire department to put out a fire in the park area next to the Bridge Home started by people who reside at ABH.

- My neighbor was walking his child home from Ivanhoe elementary earlier this month and had his way blocked by two people smoking drugs out of what was obviously a crack pipe on the Hyperion steps.

- Last month, and many times before, I have witnessed people who I know live in the Bridge Housing doing drugs and blocking the right of way on the Hyperion steps.

- All last year there was a sudden rash of windshield smashing. At least five and maybe up to ten vehicles that were parked on Riverside in legal parking spaces right in front of our apartment building had large rocks hurled through their windshields. This happened during the day and at night.

- Also last year our building's glass front door was smashed overnight at least as many times as the car windshields were. It has happened so often that I lost count.

- The Park and Rec building that used to stand on Riverside was burned down by unhoused people who were living inside it. While the burned out shell of the building still stood awaiting demolition unhoused people would climb up its walls and jump onto the

balconies of the apartment building next door. Two people who live in that building told me about this last year.

- Our parking garage is constantly broken into and vehicles damaged since the shelter was put in.

- There are transient people acting illegally near A Bridge Home Shelter. Since the shelter was constructed there has been an increase in the number of people breaking into our building, tents and illegal camping right outside the Bridge Home fence, as well as drug use in the adjoining Mullholland Memorial Fountain park area.

- There is a group of unhoused people who have been offered shelter but refuse it who camp illegally behind the Friendship Auditorium. They use the bushes outside this community meeting place as a bathroom and have vandalized the Friendship Auditorium by smashing out its windows. They also build illegal and unsafe fires behind this community space.

- Several homeless encampments cropped up after the shelter was built all up and down Riverside drive. It has been a constant battle to keep the sidewalks clear of tents, trash, and drug paraphernalia ever since the Bridge Home was built.

- There are a few residents of the Bridge home who are apparently mentally disturbed and hang around near the shelter and scream at passersby. This has been and continues to be a common issue ever since the shelter was built.

I understand the need to house those in need, but the current situation is untenable and endangers me, my wife, and all our neighbors and visitors.

Thank you so much for your time and the hard work you do for our great city.

My note is in regards to Pedlow Field Skate Park located in CD6 at 17334 Victory Blvd., Van Nuys. This park is a staple in the Van Nuys community. Being so close to Birmingham High School, it is a meeting place for a very diverse group of folks. Kids and adults alike enjoy this skate park.

On a personal note, my 9-year old son, Cory, is on the Autism Spectrum and I've never seen him thrive more than when he is skating among his peers and elders. He's found a community who accepts him regardless of his neurodivergence. For that I am truly grateful.

Pedlow Field Skate Park is the largest in the valley. I've been in touch with the architect who penned the project some 20 years ago and he is in agreement that the park is well overdue for a renovation. More importantly, this park is without lights which forces closing at 5pm. This is an extreme impediment to adults who wish to skate after work and now that high schools have moved their start time to 8:30am, they are now dismissed at 4:30pm which barely gets them there in time for closing.

Lights are not only a matter of safety, but a necessity to the community. Parents and kids alike agree.

I implore you to consider the importance of funding this project.

To Any Representative at RAP -

I would like to ask and request if there is anyone on your team that could assist me on the process/request to amend LAMC regarding dog parks to include, 'a maximum number of dogs per person in the park'? Specifically, I am requesting that the City adopt a similar language used by the County of LA in the matter: *"I. No more than three dogs are allowed per person responsible in attendance in the Dog Off-Leash Area."* [17.04.412 - Dog Off-Leash Area Rules and Regulations](#). Primarily for the safety of both visitors and their pets.

Visiting Veteran's Barrington Park in the afternoon (12/26/22) for the first time, my dog (mix shepherd/husky) was immediately chased and attacked by a group of large dogs (two german shepherds, and a pit bull) whom of which, were part of a larger group of 15-20+ dogs overseen by ONE dogwalker (see image below). The dogwalker was too distracted to notice since she was watching the other dogs and was not able to recall or chase after the dogs since she was 1) not the dog owner, and 2) on the other side of the park. Fortunately, my dog was able to run back to me without any serious injuries.

The issue with this scenario is that this could've happened to anyone else (pet or human) with far worse outcomes. Yet, there are unfortunate examples of these incidents that are evident in [Yelp](#), and Google reviews specifically at this park. This appears to be an ongoing and pervasive problem. Any dog owner can tell you that one person cannot safely control and oversee the unpredictable actions of more than two to three dogs at a time. Still, dogwalkers are bringing 20+ dogs into the park.

Sadly, these dog walkers make coming to these perceived safe places for dogs to be unleashed turn into a risky, unsafe, and volatile environment for pet owners and their pets. Sometimes to the extent of not wanting to visit at all.

Any help would be greatly appreciated and I am more than open to discussing this over the phone and/or zoom.

I urge you to act immediately to halt the pending eviction of the Griffith Park Pony Rides, a treasured legacy business and attraction that will celebrate its 75th anniversary in 2023—if you let it.

I have read the City Council file #21-1457 and supporting documents, and it seems clear that concession holder Steve Weeks is invested in caring for the ponies and responding to all recommended policy changes made by the third party equine expert.



Regarding the Closure of the Griffith Park Pony Rides

Mr. Rudnick,

I am a citizen of the City of Los Angeles and I attended the protest concerning the closure of the Pony Rides 12-18-22 at Griffith Park. I don't understand why the contract is not being renewed. I implore you to reconsider the position in this matter and help to reopen the facility for the good of all concerned especially the children of Los Angeles living in an urban environment. These small ventures allow for the first ride on a real pony as I did when I was a child. My first experience was overwhelming wonder for these beautiful animals and led to a lifelong love and respect for them.

I have seen the letter to Matthew Rudnick dated May 25th, 2022, which finds no wrongs committed by Steve Weeks and with every inspection was found that "the ponies appeared healthy, well-kept and cared for, and appropriately utilized in the riding program; there was no evidence of neglect or abuse". "The Department of Animal Services has found no grounds for a permit revocation or any further action at this time and will continue to evaluate any further complaints." I can't understand what reason can be given for not reissuing the permit. If reasonable additional requirements need to be made, then I'm certain that these can be adhered to.

From the experience on 12-18-22 of (PETA) radical protesters that were screaming falsehoods and misinformation inches from parents, telling them to stop eating meat and become vegetarian, berating them for wanting to have their children ride ponies and using foul language toward supporters and families with children present (and crying from being harassed). In fact-checking, PETA has a kill rate on animals that far exceeds any shelter by a great margin. Their adoption rate, according to one source, is less than 1%. They have evolving agendas that include extreme measures about all pet ownership as well. It is unfair to have this harassment happening when parents just want to have a pleasant day with their families.

I would hope that the City of Los Angeles Department of Recreations and Parks would not be swayed by radical groups and would please reconsider the reinstatement of the permit for the pony rides. trails from which the various groups of animals may be seen to the best advantage.

While I may think that elephants and camels might be impractical, members of the equine family are the perfect choice for children to experience and learn about. Urban areas need to have these facilities available for the children and adults. It gives us the opportunity to connect in a very real way to the natural world, away from the stress of city life. We then live in the moment, relating to *this animal here and now* as we ride together. Our blood pressure goes down, our muscles relax. Horses, ponies, mules - are our "life" partners. I hope that you can see this or at least try to understand it. Please Ms. Raman, help to reinstate the Pony Rides at Griffith Park.



Dear Mr. Kim,

I started taking my horse obsessed child to the Griffith Park Pony Rides at the age of three. For a child who was extremely shy, clinging to my leg, to be picked up by a stranger and put on a pony, all smiles and giggles, was nothing short of miraculous. This started our family on an equestrian journey that led us to ultimately purchase a ranch in Lake View Terrace, where we now live with our five horses. We enjoy riding the local trails, and my child is a successful show jumping and dressage rider, and at 18 now teaches lessons to beginner riders.

We are fortunate enough to have the means to realize our equestrian dream. A majority of the families who patronize the Griffith Park Pony Rides, about 70%, are low income, and a \$5 pony ride is all they can afford. I've seen the magic of the interaction with ponies in my own child, and the idea of this opportunity being taken away from low-income children breaks my heart.

The animal rights extremists protesting know nothing about horses. The initial veterinarian report showed only minor issues, very common in horses. These issues were immediately remedied by the owner, and verified by the veterinarian. There was no neglect or abuse, also verified by the veterinarian. I inspected the ponies myself, and saw nothing that concerned me. I assure you, if there were any neglect or abuse happening, the horse lovers of the equestrian community would be the first to speak up. The ponies that passed away were among the retired ponies, and they died of causes that are very common in horses. There was no requirement to report the death of ponies, yet this was cited as the reason for not renewing the contract. Seems clear this was an excuse, and the real motivation was the protests. I personally witnessed the abusive behavior of these protestors, yelling at parents and children, calling them pony abusers, telling them they have blood on their hands, making children cry. Giving in to this horrendous behavior does not fix the problem, it only emboldens the protestors to continue with these abusive tactics. I also have been made aware that the protestors appeared at your home and the homes of other RAP officials, and I believe that is unacceptable behavior, and I am sorry that you and your family had to endure this abuse. They already have other city animal and equestrian venues in their sights, so if you thought this decision would make them go away, you are mistaken.

I urge you to reconsider this decision, and to renew the pony rides contract.

Dear Los Angeles Commissioner,

I am asking you to reconsider your position on the Griffith Park Pony Rides and I am asking on behalf of the ponies themselves.

I consider myself to be an advocate for the proper treatment of animals. However, I am a horse-owner myself. Furthermore, I am a PONY owner. I am also the Chairman of the local Gymkhana here in my town of Leona Valley.

All of my horses/ponies are rescues/adopted. I adopted them all from reputable horse rescues, one of them being "Love This Horse Equine Rescue", which was highlighted in Forbes magazine for being one of the most transparent equine rescues in existence.

I would like to shed some light for you on what happens to ponies 98% of the time.

A new horse owner, purchases or acquires a pony for their small child. IF the pony is well trained, like the ones at Griffith Park Pony rides, hopefully the child will have a great experience, learning how to ride. However, around year 10 or 11 of the child's life, they begin to yearn for a bigger, faster horse. And so, the pony is put on the back-burner and the family puts the pony up for sale.

The pony goes on to the next home, and the next, and the next (if it's lucky) or like most, ends up at a Kill Buyer's auction

That is a fact. Right now, this week alone, I saw 4 adds for people looking to rehome their ponies on social media. It is saddening to me because I know what their fate will be.

A pony is more likely to bounce around and have an unstable life and end up at the kill buyer than a full sized horse because of their small stature and the limited amount of time that a child will remain a child.

What does the science tell us about horses and ponies? They establish deep bonded relationships with the other ponies and horses around them AND their CARE-TAKERS. They enjoy PREDICTABLE, ROUTINE, and a stable home

life and environment.

They grieve, panic, become stressed, and experience separation anxiety when they are separated from their herd. They are herd animals, to be alone, is to be DEAD. They have feelings, they remember, they have a photographic memory!

I can and will predict that the majority of the ponies at Griffith Park, if the rides are forced to close, will either bounce around from home to home and or end up at the kill buyer/feed lot. Ponies live for a VERY LONG TIME, longer than a horse. Ponies can live up to 30 years old or older in captivity and with good care. The ponies at Griffith Park are VERY well cared for.

Horses in the wild have an average lifespan of up to 12 years.

I rescued all of my horses and ponies from the kill lot. They were emaciated when I got them. I nursed them back to health. My horses/ponies have a home with me for LIFE, but that is a RARE, EXTREMELY RARE situation for ponies/horses.

Would closing down the pony rides do more harm than good for the ponies? YES, it will.

What animal rights activists such as PETA aren't aware of is how many horse/ponies are sent to the kill buyer EVERY DAY! There are already too many! Shall we increase the amount of animals sent to their death because a group of people who do not have any experience with horses or the horse world itself is making the most noise about animal welfare right now? Or because you think it's politically incorrect??? These groups do not know what goes on behind the scenes, most of them have probably never ridden a horse or even seen a pony in person.

Dear Mayer, our nation's FEDERAL GOVERNMENT even has a program that subsidizes the adoption of our wild mustangs to try to save them as they are being gathered up for the slaughter on a daily basis! Our Federal Government has an adoption program where they PAY THE ADOPTER to take home a wild mustang, in order to preserve these animals.

I ask you to reconsider your position based on the information that I just gave you. I am not talking about the children or the pony owner or PEOPLE. I am asking you to consider the WELFARE of the HORSE! It's always for me, about the welfare of the horses/ponies.

Please take this information to heart! I also want you to know that I am a Registered Democrat.

As the Director of The Children's Ranch Foundation, a therapeutic animal caretaking program in the Atwater Village Equestrian District, I join other business owners, equestrians and residents of the City of Los Angeles in urging you to act immediately to halt the pending eviction of the Griffith Park Pony Rides.

At The Children's Ranch, we teach kids, adolescents and adults with learning, social/emotional and developmental challenges how to care for horses. There is a delicate balance that must be found in both helping our students learn important life skills, and caring for the needs of our horses. We are careful to always prioritize the health and well-being of the equines we care for, while still teaching our students important life and independence skills.

For many Los Angeles kids, the Griffith Park Pony ride is the only low-cost opportunity they will ever have to interact with a horse (a sensitive prey animal). I am confident that the Griffith Park Pony Ride concession holder, Steve Weeks, could similarly prioritize the health and wellbeing of the ponies in his program, while still offering this unique chance for children to interact with a pony in the middle of the city. I also feel confident that Mr. Weeks can address any concerns that animal rights activists have, and respond to all recommended policy changes made by the third-party equine expert.

Closing the pony ride so suddenly puts the ponies at grave risk. It is extremely difficult to re-home ponies in the middle of the city, especially over the holidays, and with no notice.

Dear Mr. Rudnick:

The Department of Animal Services issues permits to animal related businesses within the City of Los Angeles and performs yearly inspections to verify compliance with state and local ordinance. The Department of Animal Services has routinely conducted yearly inspections of the Griffith Park Pony Rides located at 4730 Crystal Springs within Griffith Park. The Griffith Park Pony Rides is a children's attraction to provide affordable access to ponies for riding and farm animals for petting. In addition to the yearly permit inspections conducted, the Department of Animal Services will also conduct inspections when complaints are received regarding handling or maintenance of the animals at any animal related business with a permit issued by the Department of Animal Services.

The Griffith Park Pony Rides has been issued two animal related business permits by the Department of Animal Services: a Petting Zoo Permit which expires in July 2022 and a Pony Ride Permit which expires in March 2023. Prior to the issuance of the Pony Ride and Petting Zoo Permits, inspections were conducted and all local and state ordinances enforced by Animal Services were in compliance.

The Department has received complaints from an animal advocacy group and similar complaints from individuals. In response the Department has conducted numerous inspections and requested an inspection by two Certified Equine Animal Cruelty Investigators: a Veterinarian and an Animal Control Officer. The Veterinarian stated: "In conclusion, at the time of my inspection of the Griffith Park Pony Rides, the ponies appeared healthy, well-kept and cared for, and appropriately utilized in the riding program; there was no evidence of neglect or abuse." The Department of Animal Services has found no grounds for a permit revocation or any further action at this time and will continue to evaluate any further complaints.

Dear LA RAP Commissioners,

Firstly, I'd like to express my deep gratitude for RAP's wise decision to not renew the contract at Griffith Park Pony Rides and Petting Zoo, where animals exploited like vehicles and petting toys have been enduring immense stress for decades. It's about time the progressive city of LA transform this cruel, antiquated concession into a NON-ANIMAL MODEL, as there's a major shift worldwide away from using animals for food, fashion, entertainment, and other anthropocentric purposes. So-called "tradition" or "culture" should not allow animal cruelty to continue in a modern society. It's fundamental that a civilized society properly educate the future generations to respect and coexist nature and animals, and concessions like the pony rides and petting zoo was a threat to establishing such an opportunity for children through miseducation.

As expected, you may have already been receiving some outcries from the equestrian communities to "save the pony rides," "Children will lose their fun," or other messages of that manner. However, children can still interact with animals, in fact, in far healthier and more respectful and educational ways in sanctuaries, where animals won't be exploited for profit or be stressed, which is safer for both the animals and the children.

What these equestrian communities fail to recognize or seldom bring up is the fact that animals, including horses, are not naturally meant to be ridden by humans. There are numerous scientific studies that demonstrate that riding horses causes skeletal, muscle, and tissue damage under any circumstance. Please refer to studies by Dr. Deb Bennett and Matilda Holmer and colleagues if this subject matter is of great interest to you. Simply put, both wild and domestic (a euphemism for "broken" or "psychologically and physically dominated by humankind to go against their natural behaviors") horses do not carry their young or each other on their backs. An equine's back is a very sensitive part that allows communication between the brain and the rest of the body and is not meant for a human to apply pressure on. Many former equestrians themselves are coming to realization that if they truly loved and cherished horses, they would not be burdening their backs, legs, or other body parts. Barbaric "traditions" like horse-racing, rodeos, animal circuses, and more are under great criticism, as more and more people are educating themselves on the cruelty behind using animals for entertainment. There is no right way to do the wrong thing. There are myriads of ways to grow healthy companionship and provide equines with utmost care and ample exercise without riding them.

On this note, I'd like to present a few ideas for potential amenities to be set up in the place where the pony rides and petting zoo used to be:

◇ The only acceptable animal model would be a sanctuary.

Kindred Spirits Care Farm, Chatsworth, is hoping to move closer into the city, and this would be a great replacement to allow truly healthy and respectful interactions between animals and children. The operator of the sanctuary has wonderful educational programs for children, including children's arts and crafts corner.

◇ Children today lack physical activity, and the following sports activities may also help fight the high child obesity rate in the U.S.:

Tennis, squash, badminton, volleyball, basketball courts, rock-climbing, trampoline park, skating park, yoga at the park, etc.

◇ Giant board games: chess & checker boards, jenga, connect four, etc

◇ Children's playground, ground fountains, giant floor pianos, outdoor concert area, ferris wheel, mini rollercoaster, Go-Kart, small-scale botanical gardens, science park, library

◇ A plant-based/vegan cafe with ample outdoor seating for parents to relax in while they await their kids, giving the Parisian afternoon stroll-at-the-park atmosphere. A wonderful inspiration would be our local Coffee and Plants vegan cafe in Old Town Pasadena owned by the talented singer Leona Lewis.

There are so many other excellent ways this area of Griffith Park can be transformed into without exploiting animals.



PONY RIDE BEGINS OPERATIONS


The Griffith Park and Southern became a success in large part because a compatible attraction was established next door. As with the Griffith Park Merry-Go-Round, the park's Pony Ride concession was originated in Lincoln Park. Tommy T. Wright began a pony ride there in 1946. It was apparently a low-investment operation—he rented his horses from an El Monte stable.

After a couple of years of successful operation, the Recreation and Parks Department asked Wright (who was also a Recreation and Parks employee) to start a similar concession at Griffith Park's Riverside Drive entrance. World War II surplus Quonset huts were originally used to board the horses; they were eventually replaced by wooden stables. And the ponies were no longer rentals. Wright bought ponies, bred them and eventually showed them for prizes.⁷

Re: Request for L.A. City Parks and Recreation to Exercise the Second Renewal of the Pony Ride Contract

Dear Councilmember Raman, Department of Recreation and Parks (RAP) Commissioners and RAP General Manager Kim,

The Atwater Village Neighborhood Council respectfully requests that the second one-year extension of the Griffith Park Pony Ride Concession Contract (No. 281) be exercised to allow continued operations.

In its letter dated November 22, 2022, RAP stated that the decision not to exercise the second one-year extension was based on the Pony Ride Owner not informing RAP of the death of four ponies.

However, based on recent media reports, RAP acknowledged that the Pony Ride Contract did not in any way require the Pony Ride Owner to inform the city of any pony deaths. It is further reported following this November 22 letter that these four ponies were elderly, retired and no longer working - part of the herd of aged ponies maintained at the owner's expense. Three of four ponies passed due to maladies associated with old age and the fourth pony passed due to an injury as a result of an errant kick from another pony over food.¹

Moreover, RAP did not seek any public input before deciding to terminate the Pony Ride Contract. We believe that stakeholder input is critical in making any decision of this magnitude. The City Council has called for public input as to activities in Griffith Park. The time for public input should have come BEFORE the pony rides were given notice. The public should be allowed to voice their opinions. The need to rehome the ponies due to nonrenewal of the Pony Ride Contract is a gigantic task and once this well-functioning operation is torn apart, it will be almost impossible to reconstruct.

The closure of the Griffith Park Pony Rides, after 74 years of successful operation, deprives generations of Los Angeles children the opportunity to interact with an equine (traditionally thought to be available only to a privileged few) in an affordable manner. The \$5.00 per ride charge puts this wonderful opportunity well within the reach of modest and low-income residents. Losing this one-of-a-kind opportunity to touch the children of families with limited means would be a deep loss.

Atwater Village is fortunate to include Griffith Park at its western boundary. We also enjoy a vibrant equine community of many villagers who have dedicated their lives to the care and welfare of horses. Mr. Stephen




It should finally be noted that even the city's own Equine Advisory Committee urges RAP to renew the Pony Ride Contract.²

Re: Request for L.A. City Parks and Recreation to Exercise the Second Renewal of the Pony Ride Contract

Dear Councilmember Raman, Department of Recreation and Parks (RAP) Commissioners and RAP General Manager Kim,

The Atwater Village Neighborhood Council respectfully requests that the second one-year extension of the Griffith Park Pony Ride Concession Contract (No. 281) be exercised to allow continued operations.

In its letter dated November 22, 2022, RAP stated that the decision not to exercise the second one-year extension was based on the Pony Ride Owner not informing RAP of the death of four ponies.

However, based on recent media reports, RAP acknowledged that the Pony Ride Contract did not in any way require the Pony Ride Owner to inform the city of any pony deaths. It is further reported following this November 22 letter that these four ponies were elderly, retired and no longer working - part of the herd of aged ponies maintained at the owner's expense. Three of four ponies passed due to maladies associated with old age and the fourth pony passed due to an injury as a result of an errant kick from another pony over food.¹

Moreover, RAP did not seek any public input before deciding to terminate the Pony Ride Contract. We believe that stakeholder input is critical in making any decision of this magnitude. The City Council has called for public input as to activities in Griffith Park. The time for public input should have come BEFORE the pony rides were given notice. The public should be allowed to voice their opinions. The need to rehome the ponies due to nonrenewal of the Pony Ride Contract is a gigantic task and once this well-functioning operation is torn apart, it will be almost impossible to reconstruct.

The closure of the Griffith Park Pony Rides, after 74 years of successful operation, deprives generations of Los Angeles children the opportunity to interact with an equine (traditionally thought to be available only to a privileged few) in an affordable manner. The \$5.00 per ride charge puts this wonderful opportunity well within the reach of modest and low-income residents. Losing this one-of-a-kind opportunity to touch the children of families with limited means would be a deep loss.

Atwater Village is fortunate to include Griffith Park at its western boundary. We also enjoy a vibrant equine community of many villagers who have dedicated their lives to the care and welfare of horses. Mr. Stephen




It should finally be noted that even the city's own Equine Advisory Committee urges RAP to renew the Pony Ride Contract.²

PONY RIDE BEGINS OPERATIONS


The Griffith Park and Southern became a success in large part because a compatible attraction was established next door. As with the Griffith Park Merry-Go-Round, the park's Pony Ride concession was originated in Lincoln Park. Tommy T. Wright began a pony ride there in 1946. It was apparently a low-investment operation—he rented his horses from an El Monte stable.

After a couple of years of successful operation, the Recreation and Parks Department asked Wright (who was also a Recreation and Parks employee) to start a similar concession at Griffith Park's Riverside Drive entrance. World War II surplus Quonset huts were originally used to board the horses; they were eventually replaced by wooden stables. And the ponies were no longer rentals. Wright bought ponies, bred them and eventually showed them for prizes.⁷

Dear LA RAP Commissioners,

Firstly, I'd like to express my deep gratitude for RAP's wise decision to not renew the contract at Griffith Park Pony Rides and Petting Zoo, where animals exploited like vehicles and petting toys have been enduring immense stress for decades. It's about time the progressive city of LA transform this cruel, antiquated concession into a NON-ANIMAL MODEL, as there's a major shift worldwide away from using animals for food, fashion, entertainment, and other anthropocentric purposes. So-called "tradition" or "culture" should not allow animal cruelty to continue in a modern society. It's fundamental that a civilized society properly educate the future generations to respect and coexist nature and animals, and concessions like the pony rides and petting zoo was a threat to establishing such an opportunity for children through miseducation.

As expected, you may have already been receiving some outcries from the equestrian communities to "save the pony rides," "Children will lose their fun," or other messages of that manner. However, children can still interact with animals, in fact, in far healthier and more respectful and educational ways in sanctuaries, where animals won't be exploited for profit or be stressed, which is safer for both the animals and the children.

What these equestrian communities fail to recognize or seldom bring up is the fact that animals, including horses, are not naturally meant to be ridden by humans. There are numerous scientific studies that demonstrate that riding horses causes skeletal, muscle, and tissue damage under any circumstance. Please refer to studies by Dr. Deb Bennett and Matilda Holmer and colleagues if this subject matter is of great interest to you. Simply put, both wild and domestic (a euphemism for "broken" or "psychologically and physically dominated by humankind to go against their natural behaviors") horses do not carry their young or each other on their backs. An equine's back is a very sensitive part that allows communication between the brain and the rest of the body and is not meant for a human to apply pressure on. Many former equestrians themselves are coming to realization that if they truly loved and cherished horses, they would not be burdening their backs, legs, or other body parts. Barbaric "traditions" like horse-racing, rodeos, animal circuses, and more are under great criticism, as more and more people are educating themselves on the cruelty behind using animals for entertainment. There is no right way to do the wrong thing. There are myriads of ways to grow healthy companionship and provide equines with utmost care and ample exercise without riding them.

On this note, I'd like to present a few ideas for potential amenities to be set up in the place where the pony rides and petting zoo used to be:

◇ The only acceptable animal model would be a sanctuary.

Kindred Spirits Care Farm, Chatsworth, is hoping to move closer into the city, and this would be a great replacement to allow truly healthy and respectful interactions between animals and children. The operator of the sanctuary has wonderful educational programs for children, including children's arts and crafts corner.

◇ Children today lack physical activity, and the following sports activities may also help fight the high child obesity rate in the U.S.:

Tennis, squash, badminton, volleyball, basketball courts, rock-climbing, trampoline park, skating park, yoga at the park, etc.

◇ Giant board games: chess & checker boards, jenga, connect four, etc

◇ Children's playground, ground fountains, giant floor pianos, outdoor concert area, ferris wheel, mini rollercoaster, Go-Kart, small-scale botanical gardens, science park, library

◇ A plant-based/vegan cafe with ample outdoor seating for parents to relax in while they await their kids, giving the Parisian afternoon stroll-at-the-park atmosphere. A wonderful inspiration would be our local Coffee and Plants vegan cafe in Old Town Pasadena owned by the talented singer Leona Lewis.

There are so many other excellent ways this area of Griffith Park can be transformed into without exploiting animals.

Dear Mr. Rudnick:

The Department of Animal Services issues permits to animal related businesses within the City of Los Angeles and performs yearly inspections to verify compliance with state and local ordinance. The Department of Animal Services has routinely conducted yearly inspections of the Griffith Park Pony Rides located at 4730 Crystal Springs within Griffith Park. The Griffith Park Pony Rides is a children's attraction to provide affordable access to ponies for riding and farm animals for petting. In addition to the yearly permit inspections conducted, the Department of Animal Services will also conduct inspections when complaints are received regarding handling or maintenance of the animals at any animal related business with a permit issued by the Department of Animal Services.

The Griffith Park Pony Rides has been issued two animal related business permits by the Department of Animal Services: a Petting Zoo Permit which expires in July 2022 and a Pony Ride Permit which expires in March 2023. Prior to the issuance of the Pony Ride and Petting Zoo Permits, inspections were conducted and all local and state ordinances enforced by Animal Services were in compliance.

The Department has received complaints from an animal advocacy group and similar complaints from individuals. In response the Department has conducted numerous inspections and requested an inspection by two Certified Equine Animal Cruelty Investigators: a Veterinarian and an Animal Control Officer. The Veterinarian stated: "In conclusion, at the time of my inspection of the Griffith Park Pony Rides, the ponies appeared healthy, well-kept and cared for, and appropriately utilized in the riding program; there was no evidence of neglect or abuse." The Department of Animal Services has found no grounds for a permit revocation or any further action at this time and will continue to evaluate any further complaints.

I am confident that the Griffith Park Pony Ride concession holder, Steve Weeks, could similarly prioritize the health and wellbeing of the ponies in his program, while still offering this unique chance for children to interact with a pony in the middle of the city. I also feel confident that Mr. Weeks can address any concerns that animal rights activists have, and respond to all recommended policy changes made by the third-party equine expert.

Closing the pony ride so suddenly puts the ponies at grave risk. It is extremely difficult to re-home ponies in the middle of the city, especially over the holidays, and with no notice.

Instead, my hope is that a compromise can be found – one that honors the needs of the ponies, and also preserves the Griffith Park Pony Ride for future generations of children.
