To RAP Commissioners:

I've been a Los Feliz resident and landlord for 12 years. I absolutely love the neighborhood. It's lively, vibrant, eclectic and feels like a community. In the last few years I've seen my beloved neighborhood deteriorate. A once safe neighborhood where I would be able to walk home from having dinner out with friends at midnight, has now become a magnet for crime and drug use. When the A Bridge Home opened its doors, I thought it was a good thing. Now I realize that it's a magnet for crime and drug use. I frequent the park and tennis courts across the street. I've been followed, threatened and harassed by multiple young men who stay ABH. The residents of ABH make their way into Los Feliz. I've been followed and harassed by unhoused men in Los Feliz. I've seen these same men pull their pants down and masturbate in front of me in broad daylight. We've seen dozens of young men smoke crack on our street. We had an issue with a young man selling drugs. Just the other day as I was walking down Vermont, an unhoused man threatened to beat me and punch me in the face. Just this morning I witnessed an unhoused man urinate next to the Coffee Bean and Tea Leaf on Hillhurst. I understand that there are some people who need help and assistance however I have rights as well. I should be able to walk down the street at 10 a.m. without being threatened and yelled at. My tenants are all women and I worry for their safety constantly. We had to install security cameras. I'm taking jiu jitsu classes to be able to defend myself. I carry pepper spray. I rarely park on the street overnight mostly because my car was once stolen. Local businesses are vandalized constantly. This is not sustainable. This is a huge liability for RAP. I urge you to take action and do something to restore safety and sanity. Thank you for your time.

Managers, Director and Commissioners:

The past few months I've been told by several Los Feliz residents and stakeholders there has been a profound change to the area surrounding the Southeastern portion of Los Feliz (which bo ABH placed there. This profound change has apparently spread in all four directions:

- Northeast Residential Hills above Los Feliz Blvd
- Tennis Courts, Open Parkland and the Preschool across the street on Riverside Drive
- Atwater to the East
- Los Feliz to the West and South

R&amp;P leases this land to ABH for free and this lease is up for renewal in 2023.

The 2023 ABH lease renewal should be investigated and considered for denial, and this consideration be added to the agendas for public discussion of all R&amp;P Commission and Griffith Park C

The three reasons provided below are:

1. SAFETY
2. R&P's MISSION
3. LIABILITY

## 1. SAFETY

I've been told by residents and stakeholders of Los Feliz:

- ABH is a magnet for life-long active felons from throughout the surrounding City and County of Los Angeles and beyond, who settle long term into ABH and the surrounding area
- ABH's location, because it is so proximate to the LA River, induces a criminal community exchange between the criminal elements of ABH and the decades-long entrenched criir
- oversized RV's parked in front and around ABH, as well as luxury and other vehicles come and go, inside of which both prostitution and hard drug transactions take place

- fires are regularly set along this Open Parkland at ABH
- rapes regularly took place inside encampments, when they were intermittently set up along Riverside Drive in front of ABH
- residents' homes are broken into at the neighboring Northeast corner of the Los Feliz Hills (including two elderly people bound and gagged while robbed inside their home)
- and more

I found such reports to be so extreme and seemingly fantastical it was hard for me to believe

Then last month I took a momentary look at an app called "Next Door." (Local neighbors report and share events of the day, offer their possessions for sale, and report on other kinds of agenda.

Attached to this email are screenshots of two posts I came across after a cursory glance. Below are its transcripts:

- Ann Daniels, Atwater Village: "Hello Atwater, Approximately 7:30pm Saturday, 11/26/22, I ran into a woman who was crying frantically as she ran for help at Shell [sic] gas station a knife point raped at LA river near Sunnynook. The rapist ran to Griffith View according to the victims [sic] statement. Please be on the outlook [sic] as our neighborhood has no"
- Laura Garcia, Atwater Village: "Hello all. Today my mom was forced by an older woman and a man in his thirties on Seneca Ave around 11:30AM to give them money. They force of dollars. They even came to the house and asked for more money and threatened her. Has anyone had anything like this happen to them? We would appreciate if [sic] anyone

If this is what can be found by merely a one-time, casual, momentary glance at a local app, it begs the question - how much more is also going on?

One obviously cannot absolutely surmise these two violent crimes - a rape and a kidnapping/extortion - are directly caused by ABH and/or the environment which ABH is creating.

But then another neighbor a few days later reported this to me:

- In the handicapped bathroom stall of the Tennis Courts directly across from ABH a woman was in a state of undress after sexual activity with a male resident of ABH which me nearby and was reluctant and afraid to report what happened

Given all the above, there is good cause for an investigation by R&P as to the possible severe degradation of safety - both fire and threats to persons and property - which may be occu

## 2. R&P's MISSION

In this very same corner of R&P at Griffith Park several services which used to provide leisure activity - most often to those who are less affluent - have now been in disrepair and either

These include:

- Mulholland Fountain (previously a regular photography site for wedding pictures by many in the Hispanic community)
- The Public Swimming Pool
- The Petting Zoo
- The Merry-Go Round

In this area, R&P and Griffith Park have lost their focus. Instead, dangers possibly brought to this area by ABH are the antithesis and direct violation of R&P's explicit - both legal and ch: Angeles.

This corner of R&P at Griffith Park needs to return to focusing on its assets in this location, and on the ones there it also plans to build, after years of degradation and neglect, and excl

## 3. LIABILITY

The other question is - what forms of legal and financial liability do the possible ongoing events brought by ABH on R&P Open Parkland place at the feet of R&P and therefore the taxp

Who might be forced to pay and face lawsuits and prosecution by Los Feliz, Atwater, and/or others who are impacted by ABH?

Shelters are well outside the expertise of R&P. It unfortunately seems a case can be made of negligence by R&P by entering into this kind of enterprise on its grounds, for which R&P ai accounts are true evidence of both an ongoing fire and person & property threat, a liability case of negligence likely exists.

\*\*\*

All decision-makers within R&P should make a concerted, responsible effort to become educated about what is happening around this Southeast corner of Los Feliz and its surrounding areas, Los Feliz Blvd.

This would include talking to LAPD, LAFD and inquiring the surrounding residents and park participants. And include an investigation of all reported activities which apparently are happening e

R&P has a clear and obvious responsibility to its communities, in this case Southeast Los Feliz and the neighborhoods surrounding it including Atwater, when deciding which institutions it hou hazard causing damage both on the record and untold to innocent and vulnerable adults, children and property around this ABH location.

As well, both its Parkland and potentially the surrounding Residential Areas are also subject to ongoing fire hazards due to ABH.

R&P also needs to give all due attention to if the free lease to ABH is violating R&P's mission of safe leisure for all residents of Los Angeles.


A 2023 lease renewal denial to ABH is a reasonable, prudent consideration in light of all the above, and needs to be a scheduled Agenda for public discussion at all R&P and Griffith Park Mee

Otherwise R&P and Griffith Park leaves itself unnecessarily open to liability. Without a good faith effort to explore and address these safety issues, a case could be made of willful negligence at this area of Griffith Park, including: the toddlers and their parents at the Riverside Drive Preschool on R&P grounds; the surrounding home and land owners; and the Los Angeles citizens who section Griffith Park.



### **RE: RESTORATION OF THE VENICE LIFEGUARD HEADQUARTERS TOWER**

NOW THEREFORE, The Venice Neighborhood Council, Board of Officers requests that the California Coastal Commission, Los Angeles County Department of Beaches and Harbors, and the City of Los Angeles refrain from demolishing the Venice Lifeguard Headquarters Tower until the feasibility of its repairs and restoration for use by lifeguards OR other purpose such as a public observation tower and/or lifeguard / ocean or other museum can be fully evaluated in conjunction with representatives of the Venice Neighborhood Council, and public and private nonprofit organizations.

1975 LA City transferred lifeguard and beach maintenance services to the County per the:

**JOINT POWERS AGREEMENT  
NO. 25273**

“County shall **lease** headquarters buildings from City for \$1/year...”

“**County shall maintain** all equipment and facilities...”


If “capital development or improvements” are desired, approval must first be obtained from the Commissioners of the LA City Department of Recreation & Parks. This does not include “demolition.”

**NOTHING AUTHORIZES** the County to **DEMOLISH** any portion of the building. As noted in County correspondence, demolition would require modification of the Agreement and full City approval.

Rumors of the tower being an “immediate safety concern” are not supported by the facts nor County’s structural engineers.

County commissioned an “Architectural, Structural, Mechanical and Electrical” Building Assessment in 2014

**Regarding the 2nd & 3rd floors, “tower,” the report repeatedly states:**



**There is no structural deficiency found**

**Further, the building remains in constant use 24/7.**

A Coastal Development Permit De Minimis Waiver was issued July 2022 **based upon material factual errors.**

Per CCC guidelines, we are requesting that it be invalidated.

### **Coastal Development Permit De Minimis Waiver Coastal Act Section 30624.7**

Based on the project plans and information provided in your permit application for the development described below, the Executive Director of the Coastal Commission hereby waives the requirement for a Coastal Development Permit pursuant to Section 13238.1, Title 14, California Code of Regulations. If, at a later date, this information is found to be incorrect or the plans revised, this decision will become invalid; and any development occurring must cease until a coastal development permit is obtained or any discrepancy is resolved in writing.

**Waiver:** 5-22-0482-W  
**Applicant:** Los Angeles County Department of Beaches and Harbors  
**Location:** 2300 Ocean Front Walk, Venice (APN: 4226-002-900)

**Proposed Development:** Demolition of a two-story, 40-ft. tall lifeguard tower on top of an existing County-owned structure, construction of a new roof where the tower will be removed, and addition of one new parking space to the existing 21-space County staff parking lot. No other work is proposed to the existing 11,600 sq. ft. structure and no grading proposed.

**Rationale:** The lifeguard tower is attached to a one-story County building with a maintenance yard and 21 parking spaces limited to County staff use. The tower has reached the end of its development lifespan and has not been used since 2017. The applicant proposes to remove the tower and replace the portion of first floor roof exposed by removal of the tower. The project also

My name is Tim Rudnick. I have lived in my house in Venice since 1967, more than 50 years.

I am director of the non-profit Venice Oceanarium, a Museum-Without-Walls. We do not have a permanent facility, but, nevertheless, for the last 30+ years we have been doing events on the Venice Fishing Pier and on Venice beach, itself. Our events have become a tradition in Venice. We conduct an annual reading of Moby Dick, on the beach, at the Venice Breakwater, and we do a grunion party in the Spring that attracts hundreds of people. We do beach walks, and tide pool talks. We go to schools and rec Centers and do workshops on beach ecology.

We see the iconic and architecturally significant Tower at Venice to be a very attractive possible venue for the Oceanarium and we will submit a proposal for it's renovation, upgrading and repurposing to be used as an ocean themed museum and a permanent home for the Venice Oceanarium.

**Re: Council District 4 Letter of Support for *Under the Oaks* Mural Proposal at Griffith Park Visitor Center**

Dear Commissioners,

Griffith Park is Los Angeles' preeminent park in the region, located at the heart of a sprawling metropolis, and containing some of the region's most beloved park assets in over 4200 acres of park land. In addition to the built and maintained portions of the park, Griffith Park is also an integral part of the Rim of the Valley and the wider Southern California ecology, containing thousands of acres of natural habitat, that until recently, hosted an adult mountain lion named P-22. I am proud to be the Councilmember whose district encompasses the entirety of Griffith Park and P-22's range throughout the Hollywood Hills.

Several weeks ago, medical professionals with the California Department of Fish & Wildlife and the National Park Service made the difficult decision to euthanize P-22, after he experienced acute injury and age-related health issues. Prior to this decision, planning to honor P-22's unique presence in our city had already been underway via a mural.

*Under the Oaks*, a three-wall mural installation at the Griffith Park Visitor Center designed by Studio Tutto, a local public art studio, captures P-22 in a layered style, presenting the local flora and fauna in an absorbing piece which calls to mind water-color landscapes and decoupage. P-22 sits at the center of this mural, but is hidden in plain sight by the trees, shrubs, and grasses on the hillsides that were his home. The mural will be painted at the Griffith Park Visitor Center and donated to the City by the Friends of Griffith Park.

The full scope of work will include a mural as well as the relocation of existing building signage, and replacement of existing non-native shrubbery, with a *Seed Spire* pollinator garden. These compressed soil spires form a conical shape with native wildflower seeds, and naturally disintegrate back into the earth.

I am a tennis instructor with the City of Los Angeles. I have a permit to teach tennis at Poinsettia Park Tennis Courts.

I need to inform you that the courts have been neglected. Unfortunately, the courts at times can be slick and dangerous for myself, the children I teach, and the general public who pay to use the facilities.

My concern arose a few days before Christmas when yet another one of my young students slipped in the corner of the court which had been neglected, this same issue came up 2 weeks prior with an adult that slipped on court and has been out for 3 weeks with that injury. In this most recent incident the parent voiced their concern with me about the neglect of the facility and asked who was responsible for the maintenance of the courts. I informed her the City of Los Angeles. It's with this incident and my own close call that I wanted to voice my concern.

The trees around the court have been pruned but the berries from the trees fall on the court and when the courts aren't washed, the combination of weeks of dirt, soot, and leaves falling on the court combines to make them slick and dangerous.

We have a tennis shack that provides a leaf blower and brooms which would help remedy this situation. However, even though they have these supplies and don't use them they now refuse to let us use them to remedy this problem.

Along with the rise in the homeless sleeping on the courts, drug paraphernalia, used rubbers, bed spreads, dirty needles, broken meth pipes, and other debris I'm finding myself sweeping up more and more, it would be nice to have some support from Parks and Recreations at Poinsettia to support each other in keeping the parks as safe as possible.

Because of my concern for the welfare of myself, the teaching staff, the children I teach, and the general public, I wanted to make sure it's noted that I attempted to voice my concerns to find a solution to make Poinsettia Tennis Courts a safe place to enjoy recreation in our great city.

Please let me know how I can help. I'm happy to sweep, squeegee, or clean I just access to the equipment.

Dear City Officials,

I first want to give you an additional brief and limited update on the New Years holidays in Hollywoodland. The holiday weekend was a continuation of gridlock caused by unsustainable numbers of vehicles and pedestrians. The use of DOT locked into a particular location and not ticketing even nearby cars, continued. Yes, the rain did cut down on the number of visitors, but we were still impacted, including on the Monday holiday. In the face of the City for the first time since we've had these problems deciding to basically provide nothing, residents felt they had to act on their own. Barriers were put up in Hollywoodland at various locations. Some residents felt more comfortable leaving the neighborhood for the day, because they did not feel safe in their own homes. This is unacceptable. I did a brief drive around at the end of the day because I thought doing this in the rain and approaching darkness would probably present me with the best of conditions. On Deronda pedestrians were walking in the middle of the street and would not move over to the side. Because of all the blind curves, I had to follow them past 15 houses before I felt I could go around them. There were illegally parked cars at Deronda and Rockcliff. When I got to the illegal view site there were pedestrian walking past the no pedestrian signs, and I counted approximately 60 cars. This was in the dark in the rain! What was it like earlier in the day?

We have another holiday weekend approaching with the Martin Luther King Holiday. I am asking what are your specific plans? So far we have been told nothing. Why are we always kept in the dark? Why are we not asked for input? Why do you not approach us with your planning? Why are we always begging for help and for responses from the City? These are all dates on a calendar with issues that are foreseeable months ahead.

Yes, we are expecting rain, but you can see it lessens the impacts but does not eliminate them. Will DOT again be stationing personnel at the magnets? You need additional enforcers to roam and a supervisor stationed here in order to direct your resources where they are needed. But again, the best solution to most efficiently use your limited resources and accomplish the greatest result for Hollywoodland in order to achieve public safety and navigable streets would be to close down Hollywoodland entirely to tourists over the holidays as was done in the past.

**We are requesting something very simple, obvious, proper and of utmost importance---that the City finally make public safety the PRIORITY in dealing with the impacts of the Hollywood Sign on the visitors and residents in Hollywoodland. The alternative is unsustainable and dangerous and should not be allowed to continue a single hour. We want the same protections that are norms throughout the rest of the City.**

Residents reported additional deteriorating conditions throughout Hollywoodland.

For example, LedgeWood was particularly hard hit. Several people reported that it took **15 minutes to go 2 blocks** because of the total gridlock! LedgeWood is not directly adjacent to any of the magnets, so the negative impacts, because of the huge number of visitors, are spreading. LedgeWood, although very narrow and where every parked car prevents two way traffic, is an evacuation route and a major artery in Hollywoodland, secondary to Beachwood Drive. How are these conditions acceptable if emergency vehicles need access? How is this acceptable in case of emergencies like a fire? I did not know you could block "fire doors/exits".

Yesterday was not an official holiday, but is in the holiday period when up until this year we have had supervision and enforcement. Nothing was provided this year. **This year's holiday planning for Hollywoodland has been lacking, haphazard, insufficient, and negligent.**

Thursday, Dec. 29th,

There has been light rain on and off today so the crowds are fewer.

**We still need help. Will we have more supervision on Friday? Will the 2PM deadline on Jan. 1st for deployment be extended? Will we have supervision/enforcement on Monday, Jan 2nd, which is also an official holiday?**

**So far, no one has responded.**

**If you cannot help us, will you please forward it on to officials who can. Or if you can do nothing, you must shut this all down.**

Hello,

I have written to you already voicing my anger at the egregious manner by which the Griffith Park Pony Rides were shut down. You are now soliciting ideas for "reimagining" the venue. I think you need look no further than the recommendations of Dr Rachael Sachar DVM, CVA, the veterinarian hired by the city. In the conclusion her final report she stated

"I suggest there be additional discussions, provisions, and modifications to expand the concession's potential use beyond its current value as a recreational activity and/or place of entertainment. It would be of greater value to the community for the concession to incorporate educational opportunities to the public and collaborate with existing community programs to ensure that it continues to be a viable and sustainable concession and feature for Los Angeles and surrounding communities as well as an important attraction and recreational activity for its residents." This sentiment was echoed by Dr Ramey DVM and President of the Los Angeles Equine Advisory Board who wrote in strong support of keeping a pony ride concession in Griffith Park.

Dr Sachar in her first report says that she was asked to research policies for working animals in other cities which she said was beyond the scope of her initial contract with RAP. She also noted that she has worked with sanctuaries and animals in film and TV that are under intense scrutiny by the most extreme animal rights advocates. They voluntarily follow more intense guidelines She recommends that Griffith Park Pony Rides do the same. To me this is the win/win answer. The current, mostly older ponies have all gone to good homes, the more reasonable protesters can claim a victory. The most extreme protesters who hold that riding a horse, in and of itself, is a form of abuse, as well as those who continue to attack Mr Weeks personally should have no place in this discussion. We should start again with new ponies and far stricter guidelines and regulations, as well as educational components. No one supports animal abuse, but the vast majority of people do not believe that riding a horse is abusive. If we allow the pony rides to be shut down we embolden Ms Fahim and LAAA to go after other horse related venues. What's next, trail rides, and Griffith Park Mounted Rangers? The LA mounted police horses? What about the Rose Parade? And how do we justify holding the Olympics in Los Angeles if we are not an equestrian friendly city?

Lastly there is Sec. 595 b) Lease of Facilities from the Los Angeles Charter Recreation and Parks Department. I'm not a lawyer, but if this is still current and means what I think it means, then the venue can only be leased as a pony ride.

### **Sec. 595. Lease of Facilities.**

The Board of Recreation and Park Commissioners may lease for recreational purposes any municipal auditoriums, arenas, sports centers or related facilities subject to the following conditions:

(a) The term of the lease shall not exceed 35 years. Leases in excess of five years shall be approved by the Council by ordinance.

(b) The public must be entitled to use and enjoy the property or facility for the purposes for which it was acquired, constructed or completed and any lease shall require the lessee to operate the property or facility so as to furnish the public with that use and enjoyment.

(c) The board may enter into the lease without inviting bids and may prescribe other terms and conditions as it deems appropriate.
