CALL TO ORDER

APPROVAL OF THE MINUTES

President Simril called for a motion to approve the minutes of the Regular Meeting of April 4, 2024. Vice President Sanchez made such motion, and it was seconded by Commissioner Hutton. There being no objections, the motion was unanimously approved by a vote of 5-0.

GENERAL MANAGER'S UPDATE

Matthew Rudnick, Executive Officer, introduced Anita Meacham, Superintendent of the Metro Region Recreation Division. to introduce staff and provide a little background of our Metro Region and the Glassell Park Recreation Center.

Mr. Rudnick began by highlighting a few events, he stated RAP has a number of Earth Day events occurring this coming Saturday. Mr. Rudnick mentioned that the department has received various communications from constituents which staff is following up on as well as some of the public comments from our last meeting including comments made by a Local Neighborhood Council related to the Bill Green Memorial Park and is coordinating with the Council Office on those communications

.Mr. Kim provided the Commission regarding the golf division. He stated the golf division did go live and implement the \$10 nonrefundable deposit that the Board had approved last meeting. RAP will be providing an update on the response and the impacts of that policy change

Veronica Polanco, Chief Innovation Officer provided a brief update on our Race/Ethnicity data for our sports and aquatic programs which is collected in RecTrac.

Ms. Chinyere Stoneham, Acting Assistant General Manager of our Recreation Services Branch introduced Yamil Verdi and his team and thanked them for their heroic actions that took place at our Sylmar Recreation Center. She stated that on Tuesday, April 16th they found a young teenage girl who appeared to be suffering from an overdose and quickly became unresponsive. In an effort to save the girls life, Yamil not only had to administer Narcan, but also had to provide chest compression several times to keep her alive until the paramedics arrived. All three employees were presented with a certificate of appreciation.

President Simril introduced Councilman Blumenfeld to share a few words on the Caballero Creek Park project.
