### SUMMARY

RAP anticipates additional appropriations are needed in the Overtime General account in the amount of \$1,500,000, the Hiring Hall Salaries account in the amount of \$280,000, and the Transportation account in the amount of \$30,000. These transfers are needed to pay for the cost incurred by RAP to react promptly to unforeseen events (e.g. windstorm and fires response), debris clean up, activation of the shelters, drop-in and child care services. Additional funding is also needed to support operations as a whole and preparation for seasonal
