RECOMMENDATIONS

- 1. Authorize the Department of Recreation and Parks (RAP) to submit grant applications for the projects as detailed in Attachment No. 1 to the Los Angeles County Regional Park and Open Space District (RPOSD) under the Measure A 2025 Competitive Grant Programs;
- 2. Authorize RAP's General Manager to accept the funds, if awarded, for the amount, scope, and the performance period outlined in Attachment No. 1, subject to the approval of the Mayor and City Council pursuant to Section 14.6 c of the Los Angeles Administrative Code;
- 3. Direct RAP as the designated Grant Administrator for the Measure A Grant Program to submit these requests to the L.A. For Kids Steering Committee in accordance with City Council instructions (Council File 18-0611) and to the Mayor and City Council for approval;
- 4. Designate RAP's General Manager or designee as the agent to conduct all negotiations, execute and submit all grant documents, including, but not limited to applications, agreements, amendments, and payment requests, which may be necessary for the acceptance and use of grant funding; and
- 5. Authorize RAP staff to make necessary technical corrections to carry out the intent of this Report.

SUMMARY

On July 15, 2025, RPOSD launched the Measure A 2025 Competitive Grant Programs. The programs will distribute a total of \$58 million in Measure A funding to support planning and development efforts throughout Los Angeles County. The programs aim to promote park equity, expand access to parks and regional recreation spaces, and support environmental resilience.

The submission deadline for these competitive programs is October 30, 2025, and are described as follows.

1. Category 3 - Natural Lands, Local Beaches, Water Conservation and Protection

Funds shovel-ready development projects that protect, restore, or enhance open space, natural lands, and water resources. Projects may improve water quality, restore habitats, expand park space, or enhance public access to rivers, beaches, lakes, and other natural systems.

Available Funding: \$24 million

2. Category 4 - Regional Recreation, Multi-use Trails and Accessibility

Funds shovel-ready development projects that expand or improve regional recreation, multi-use trail systems, and public accessibility to parks and open space. Projects must demonstrate regional significance by serving diverse populations across multiple communities.

Available Funding: \$16 million

3. Category 3 and 4 – Planning and Design

Funds early-stage work that leads to eligible, shovel-ready projects. Eligible projects include pre-construction efforts such as design, permitting, environmental review and community engagement.

Available Funding: \$18 million

RAP intends to submit applications under this competitive cycle, as outlined in Attachment No. 1 (Attachment). If these grant applications are successfully awarded, RAP anticipates grant agreements to be executed by late Spring 2026.

BACKGROUND

In 2016, Los Angeles County voters approved Measure A, which provides the City of Los Angeles formula-based annual allocations for capital improvement projects under Community-based Park Investment Program (Category 1) and Neighborhood Parks, Healthy Communities, & Urban Greening Program (Category 2); competitive grants for capital improvement projects

and recreational access programs under Natural Lands, Local Beaches, Water Conservation and Protection (Category 3); Regional Recreation Facilities, Multi-use Trails and Accessibility (Category 4); and additional competitive grants for Youth and Veteran Job Training and Placement (Category 5) as well as an Implementation, Operations and Oversight Category. Additional annual allocations are available under a Maintenance and Servicing Program to offset Proposition A and Measure A funded capital projects. Funding through the Measure A grant program will be generated in perpetuity through the collection of a parcel tax. In October 2018, City Council designated the L.A. For Kids Steering Committee as the administering entity for Measure A with RAP serving as the Grant Administrator (Council File 18-0611).

In accordance with C.F. 18-0611-S5, RAP executed RPOSD's Annual Allocation Agreement. Once the grant application is reviewed and approved by RPOSD staff, a Notice to Proceed (NTP) is issued to begin project implementation.

The 2025 Competitive cycle is funded through Categories 3 and 4.

ENVIRONMENTAL IMPACT

The proposed Board action consists of authorizing RAP Staff to submit applications for grants to support capital projects. At this point not enough information is available to assess whether they will have a direct or indirect impact on the environment or whether they are exempted from the California Environmental Quality Act (CEQA).

Staff will provide adequate environmental determination when the projects come back to the Board for final approval.

FISCAL IMPACT

There is no anticipated fiscal impact to RAP's General Fund from the submission of these applications or the acceptance of Measure A Competitive funds if awarded. No matching funds are required.
