Good evening,

I am writing to formally address the treatment my family, particularly my six-year-old daughter, Sophia, has received at the Cypress Park Recreation Center from Director Mike Garcia and Coordinator Analuisa Castro.

We have been regular visitors to this park for over two years, participating in various activities without any major issues. For context, we joined the park alongside family friends, the Aroche's, whose daughter, Arely, is the same age as Sophia. Their request for the girls to play on the same team has always been accommodated, and the staff often jokes about them being a "package deal." Until the recent SNL sessions, we would simply remind the office of their request when submitting paperwork, and that was sufficient.

This summer, we enrolled in basketball, and they were placed on different teams. Although we believed we communicated our request clearly, it seemed to have slipped through the cracks. Both of our families reached out separately, apologetically asking if the girls could be placed on the same team, not knowing where the gap in communication truly occurred. At no point did we demand this and based on our positive history with the park; we assumed it would be straightforward. Instead, we felt as if we were imposing and burdening staff with what should have been a simple request. We were met with condescension, as staff repeatedly reminded us that they were doing us a "huge favor."

During the first basketball practice, we noticed available spots for soccer and decided to register the girls for that as well. We again asked to have them on the same team but were immediately rudely dismissed by Mike, who stated, "We already did it for you for basketball; we aren't doing it again." This interaction was beyond uncomfortable, with staff observing in silence, seemingly reluctant to intervene. Following this, we

chose not to place the girls on a soccer team at the park and informed our respective coaches of our decision via text when the team notices went out.

However, a couple of weeks went by and the Aroche family's daughter still wanted to play soccer with Sophia, so they ended up attending a practice and spoke to the coach, who agreed to discuss it with Mike. We were later informed that the coach had received approval since the teams were short on players. Despite our earlier experience, we decided to give it another try, as the girls were excited to spend time together.

On July 19, we attended the game, spoke with the coach, and everything went well. There was not a coach present, so the father of the Aroche family stepped in and led the team during warm-ups and the game. He and I created a snack list with the other parents, as that was also never discussed. Because of this disorganization and the fact that there were just enough kids to play, it led us to believe our request had been approved due to the lack of available players. We were informed that uniforms would be ready for the game on July 23 and moved forward without a second thought. We were a bit late, and Arely already had her uniform and was on the field practicing, so I rushed towards the offices to pick up Sophia's uniform. However, before I even made it off of the field, Analuisa stopped me and stated immediately, without so much as a hello, "Sophia is not allowed to play; she was dropped from the league." This was shocking, especially since the coach had assured us it was fine for her to participate. The confrontational tone stunned me, and I truly had no idea how to respond. I tried telling her that both Starly and the coach of the team talked to the offices and got the ok, but Analuisa insisted that she was the decision-maker, she made the teams, and that the coach had no authority in this matter. I was blindsided by this interaction, especially since the Aroche family faced no such issue and their daughter was allowed to pick up her uniform and play. Sensing my discomfort my husband and Starly came over to see what was wrong and were met with the same impudence. It appears they were unwilling to honor their previous approval, failing to communicate internally, creating a completely unnecessary hostile environment and making the kids suffer as a result.

After my conversation with Analuisa, we went to the office to get some clarity where Mike smugly asserted, "You cannot do whatever you want." In all my years working with people, I have never encountered such unconscionable behavior, and I would be appalled if I were to find out this is the way any of my staff, especially at a Director level, behaved. Our intention was never to circumvent rules, act inappropriately, or "do whatever we wanted". We have always been kind and cordial to all staff, parents, and children. The grandstanding from their entire office was off-putting, hurtful, and extremely unjustifiable. Even if we did what they insisted on and had not informed them of the need for the girls to be on the same team, there would still be no excuse for a fraction of the mistreatment we received. I truly believe they found joy in telling us no. There have been a few other instances in the past, such as being denied the opportunity to volunteer as a coach, which I dismissed at the time. However, in hindsight, I realize that these experiences were simply setting the stage for their true intentions to reveal themselves once given the opportunity. I feel as though we've been marked with a scarlet letter, and our only option now is to find another park and uproot what we've built to escape further power struggles and hostility.

I understand this may seem minor and, for a time, I feared that I may be overreacting or projecting my discomfort. The more I thought about it, however, I realized how much these experiences can negatively impact our children in profound ways. Feelings of isolation, exclusion, and guilt are some of the worst emotions a child can encounter, and they are too young to understand the implications and instead carry that uncomfortable weight with them. I saw this firsthand when Sophia sat on the sidelines as her friends played, calling her name from the field, confused about why she was not allowed to play. It was both heartbreaking and impossible to explain the reasoning behind how this situation was handled, so we tried our best. This has left both of our families feeling targeted and uncomfortable. Ultimately, these are six-year-old children we are talking about; if we are truly and genuinely looking out for their best interests, this is a horrifyingly bad way to set that stage. Facilities like this have a responsibility to foster an inclusive and supportive environment for ALL children. I wonder how many other families

have faced similar treatment, feeling afraid to speak up or, even worse, accepting this as normal behavior? I believe that people who have a flair for mistreating others by abusing their positions of power should not be working closely with children.

As a final note, I wanted to make it clear that I have held off on sending this to prevent any retaliation while our daughters are still engaging in basketball. The season ended yesterday, the 15th of August. We entertained the idea of pulling them out entirely, but that would be another disservice to our children that they do not deserve. Thank you for your time and attention to this matter. I hope it leads to positive changes and protects other families from experiencing anything similar in the future.

Hello.

I am following-up after speaking with Sarah Swanseen at the Parks and Rec meeting this past tuesday. I've been writing on and off for years with Jose Hernandez, Public Project Deputy & Area Representative for the Councilwoman (who I have copied on this email), about our park. Jose was very helpful in getting a broken climbing dome removed in our park back in 2021. Our park is connected to our townhouse community, but it is a public park, and only consists of swings in sand, and originally a climbing dome. The climbing dome was broken with pieces of metal sticking out of the sand for at least a year. Eventually hazard tape and signs were placed and finally after contacting Jose, it was removed.

I was hoping it was going to be replaced, but that never happened. Every 6 months I would reach out to Jose (lucky him) to see if there's anything that could be done. There are a lot of kids in the area and no other playground structure for miles. The new West Lakeside Street Park is beautiful and appreciated, but I was disappointed to find out there was no playground structure. The only other playground close by, Carey Ranch, is so outdated and dangerous. The ground is so uneven, I can't bring my small kids because they trip around the ground.

I want to make clear that while I would love to get a nice playground structure at Telfair Park- and there is space for it, as well as update Carey Ranch, what I really would appreciate at minimum would be to simply replace the climbing dome that was originally in our Telfair Park. This replacement, and anything else you can provide in terms of equipment would be so appreciated by all our neighborhood kids including my 5 and 2-year-old girls. We definitely drive to all the parks in the area and love them, but my husband and I are big commuters during the week for work, and it would be so nice to be able to enjoy our park more, staying close to home. I'm sure we aren't the only ones that feel this way.

I'll attach some pictures of our park including the current setup, the Park and Rec sign that Jose had me provide, and I found an old picture online of the original dome. I look forward to hearing from you about any attention you can provide on this matter.

Dear Department of Parks and Recreation,

My name is Tai Beauchamp, I am the founder or Morning Mindset with Tai and Tai Life Media. I have been a consistent partner with The Parks for close to 4 years. I am writing to file an official complaint regarding overdue reimbursements related to events hosted at Griffith Park.

I have had the pleasure of working with your team in the past and have always found the people to be gracious and supportive. However, I am deeply disappointed and frustrated by the lack of resolution regarding our pending reimbursement.

We were originally due to receive a \$500 refund of our deposit in October 2024, and a second \$500 reimbursement is now more than two months past due. As of today, we are still awaiting a refund of \$1,000, which is long overdue. Despite multiple follow-ups, there has been no confirmation of payment, nor have we received an ACH transfer or tracking number for a mailed check, as previously requested.

As a small business, the continued delay has placed an undue burden on us. While we value and cherish our relationship with the Department of Parks and Recreation, this delay is unacceptable. I understand that internal teams may be attempting to resolve the matter, but as both a resident of Los Angeles County and an ongoing partner of the Department, I expected this issue to have been addressed long ago.

At this point, I respectfully request:

- An immediate update on the status of the \$1,000 reimbursement;
- Confirmation of the payment method (ACH transfer or mailed check with tracking);
- A firm timeline for when we can expect the funds to be received.

If we cannot resolve this matter promptly through our direct contacts, we will be forced to escalate further.

Section 22.819 of the Los Angeles Administrative Code provides, in part:

(b) Board and Commission Meetings. The agenda for each City Board or Commission meeting shall contain an agenda item for a Neighborhood Council representative to provide the Neighborhood Council's formal position on any matter listed on the agenda for that Board or Commission meeting. The Neighborhood Council representative shall provide the Board or Commission with a copy of the Neighborhood Council's Resolution or Community Impact Statement. The agenda item for the Neighborhood Council's formal position should be listed on the agenda in an order that ensures prompt consideration of the Neighborhood Council position and should be listed separately from general public comment. In the chair's discretion at the City Board or Commission meeting, the Neighborhood Council representative may be asked to have a seat at the table typically reserved for City staff and may provide the Neighborhood Council representative more comment time than allotted to members of the general public.

In my opinion, the mere listing of "Neighborhood Council Comments" AFTER that portion of the agenda during which the Commission typically votes to approve its Board Reports violates the spirit and intent of the highlighted provision: "The agenda item for the Neighborhood Council's formal position should be listed on the agenda in an order that ensures prompt consideration of the Neighborhood Council position and should be listed separately from general public comment."

I am requesting that the Commission revise its agenda order as suggested above, effective prior to its next meeting, in an attempt to resolve this issue.



Executive Summary

- During a recent Natasha Watley Championship game on 08/23 opposing coach Liz instructed her player/ Pitcher to intentionally hit a batter, which resulted in one of my players being struck.
- Liz is the wife of Rudy Sánchez, Park Director of Fernangeles. Mr. Sánchez was present, condoned the behavior, and failed to intervene.
- Both Liz and Mr. Sánchez have a documented history of unsportsmanlike, inappropriate, and unsafe conduct, which is widely known among the parks.
- They continue to work with multiple travel ball (basketball & Softball) teams, including those competing as the Phoenix, placing many children under their supervision despite this history.
- The original umpire ended the game early and noted he felt uncomfortable officiating further. His account is essential to the investigation and should be formally included.
- This behavior endangers children, undermines the integrity of the program, and violates the values of sportsmanship and safety.

Requested Action:

A thorough investigation, including testimony from the original umpire, and decisive corrective measures to prevent such incidents in the future.

Full Complaint Letter

I am writing not only as a concerned community member but also as a volunteer coach for the Ritchie Valens softball Majors division to bring to your immediate attention a very serious incident that occurred during the Natasha Watley, Majors Division Championship game, which took place on 08/23 at Branford Recreation Center.

During the game, the opposing coach, Liz, was heard by multiple coaches and parents instructing one of her players to intentionally hit the batter. That batter was a player on my team, who was subsequently struck.

What makes this matter even more concerning is that Coach Liz is the wife of Rudy Sánchez, the Park Director of Fernangeles. Not only did she issue this instruction, but Mr. Sánchez himself was present and condoned this behavior. As Park Director, he holds a responsibility to uphold the highest standards of conduct, fairness, and safety. Yet, in this case, he failed to intervene and instead supported conduct that deliberately endangered a child. Both individuals should be held accountable for their actions.

It is also important to note that both Coach Liz and Mr. Sánchez have a history of this type of behavior, which is well known amongst the parks. This troubling pattern raises serious concerns about their continued involvement in leadership and coaching roles within the program.

Even more troubling, they are actively involved with several travel ball teams (Softball & Basketball) from Fernangeles—including teams that compete in the name of Phoenix—placing them in positions of direct influence over many children. For individuals with a known history of unsportsmanlike and unsafe conduct to continue acting in this manner poses an unacceptable risk to the young athletes under their supervision.

This type of behavior is unacceptable and stands in direct opposition to the values of sportsmanship, respect, and safety that your program is intended to promote. Encouraging or condoning deliberate harm to another player not only endangers children but also undermines the integrity of the program and sets a dangerous example for families and participants.

As a volunteer coach, I take seriously my responsibility to ensure that every child on the field competes in a safe, positive environment. When coaches or park leadership encourage or condone unsportsmanlike and unsafe play, it violates the trust that parents and players place in this program.

I respectfully request that this incident be thoroughly investigated and that decisive action be taken to ensure such conduct does not occur again. As part of the investigation, I ask that the

original umpire who officiated the game be interviewed, specifically regarding why he chose to call the game early and how he expressed feeling uncomfortable continuing to officiate under those circumstances. His perspective is critical to fully understanding what took place. I further request to be informed of the outcome of this matter.

Addressing this issue promptly and firmly will reinforce the standards of safety and sportsmanship that all participants deserve.

Thank you for your attention to this matter and for your continued commitment to the integrity of our recreational programs.

Fast forward to 2025 Natasha Watley during the Championship game Coach Rudy started off with again an unusual behavior at first inning raising his voice and having an aggressive body language when calls were being made by the umpire. Coach Liz (Fernangeles coach) as well was getting loud and inappropriate name calling the umpire. There was also a man from the stands who also used inappropriate language who did get kicked out of the game and shortly after a mother (Vanessa- daughters name is Mia) behind us started raising her voice with foul language towards the umpires call and then continued to verbally attack one of the moms from Ritchie Vallens. I reached out to her and told her to please stop since our girls are watching this behavior, she continued with "I dont give a " "No one is going to talk about my daughter".

Her daughter Mia when being on the mound (from Fernangeles team) was heard telling her teammates she was purposely going to hit Cailey (the batter from Ritchie Vallens team), she indeed hit her. The coaches heard her the umpire heard her and even some of us parents heard her.

This is not the first time we have encountered horrible behavior from the Fernangeles staff/parents, but this is the first time I am reporting what I have witnessed.

As I'm sure you all have heard the news about that awkward incident that took place on Saturday 8/23/25. All the girls worked very hard to get that far and make the championship.

This is not the first time we have been part of the Natasha Watley Tournament but might be the last. Horrible experience and all because Fernangeles Staff are sore losers.

Ritchie was at bat and Fernangles fielding. We had our batter in place and proceeded to a fake bunt/swing (normal softball routine). Then it is heard the Fernangeles staff say, "next time she does that hit her".

The batter proceeded to once again show bunt and pitcher hit her. That hit could have been worse and caused damage to a child that is there to grow and learn the sport. I hope this is taken very seriously because that parent can file a lawsuit and take legal action on that staff member and parents.

I find it very disturbing that the coach found the need to say, "next time she does it hit her" and with no hesitation the pitcher hit the batter. Why? Why play dirty like that and who are the parents to allow that kind of behavior from a coach. Embarrassing!!

Those words were heard by the umpire and our side of the stands (Ritchie). The ump proceeded to give them a warning. From that warning Fernangeles proceed to escalate the issue causing the umpire to call the game. A lot of back and forth in between before we continued with the game. Once we continued with the game Fernangeles keep contesting everything which just made the rest of the game uncomfortable to watch and support the teams.

This behavior from any coach, director, staff, or parent is unacceptable and should be followed with termination/removal from the park. I've never seen such aggression, negative vibes, and negative talk from park staff like Fernangeles. I have 3 kids, and they all have played at multiple GPLA's and not once have we seen unprofessional staff like them. They walk and act like they own GPLA and are very angry when they lose a game.

Besides this past Saturday the previous negative encounter was Wednesday 8/6/25. A parent from the Fernangeles team has video(after we were told we couldn't record) on this game 8/6 because they were recording the game. You can hear the staff yelling out that our girls (Ritchie) are not earning the runs. Who says that... Why the negative talk towards the opposing team, why not offer words of encouragement to your own team.

Also, Fernangeles staff/coaches hate when other teams record, and I see why.. they don't want their horrible behavior or words recorded.

In response to your letter the Request for Proposal (RFP) process required two site tours be scheduled for each childcare center for potential bidders. The site tour schedule was coordinated by the Contracts, Partnerships, and Child Care divisions from the City of Los Angeles, Department of Recreation and Parks (RAP).

When determining the site tour schedule, travel time between centers, the availability of potential bidders and RAP staff during operational business hours, was considered. Effort was made to minimize disruption, by scheduling in advance an early dismissal, instead of cancelling the program for the day of the tours. Consequently, the regularly scheduled early dismissal on Friday, July 25, 2025, (scheduled for staff development) was canceled, in lieu of the site tours. The disruption at Downey was due to a miscommunication with the site director. Regarding staffing changes, the former director requested a reassignment, which was granted.

During the budget hearing for 2024-2025 the Chief Legislative Analyst submitted an overview of the proposed budget, cuts, and responses. In that report it instructed the Department of Recreation and Parks to report with a plan to transition provision of childcare operations from the department to non City providers. See attachment H.

As stated in the May 2025 parent meetings, RAP began drafting the RFP in October 2024 in response to budget constraints in an effort to continue the licensed child care program. This process spanned several months. Parents were not provided with a formal statement regarding the process, as information had not been finalized.

Twenty million dollars was allocated through ARPA funding. \$16M was utilized for capital improvements to the park property to support licensed child care operations for the community. The remaining \$4M was designated for start-up costs including furniture, staff training, educational materials and supplies, staff oversight, along with staffing for the 10 sites to provide child care services at no charge for the community.

This has been a challenging time for Recreation and Parks. The ongoing and future budget constraints will require a continued focus on defining RAP's core programming and the development of additional strategic partnerships to provide the same level of service for the

community as has been previously provided. RAP will continue to consider collaborative efforts to ensure the continued success of our programs and services for the community.

Dear Ms. Tillie-Jones,

Thank you for your response. I feel that both the initial response and yours illustrate a remaining lack of accountability and clarity of ownership for decision-making.

Your response deflected responsibility to "miscommunication" with directors rather than addressing who made these decisions at RAP. I feel the pattern of mismanagement and poor planning stems from above the director level, and I'm seeking transparency about who is making these choices.

While I appreciate the attempts to acknowledge the emotion behind our concerns, the response did not address these key concerns:

- Why site tours required midday closures instead of after-hours scheduling, prioritizing RFP convenience over children's stability
- Who decided on the timing for staff development closures
- · Who is accountable for all these operational choices

This pattern extends beyond recent weeks. I share these examples to demonstrate a year-long pattern of not centering the experience of children and parents:

- · RAP ordered directors NOT to inform parents of potential closures in February 2025
- Families had to discover closure plans through their own advocacy
- RAP representatives at May meetings couldn't answer basic questions about burn rates or alternatives
- Downey's former director got reassigned last minute to another center, likely to close in August 2025

A \$20M public investment was converted to a privatized subsidy with minimal to no family input.

I feel concerned about how we treat constituents, **especially children**, **when they deserve greater accountability** standards we expect in other professional settings.

You speak of accountability and learning from this experience, but I need to see specific, measurable actions rather than general promises. While I appreciate the attempts to acknowledge the emotion behind the concerns

I would like to understand:

- 1. Names and titles of who made the tour scheduling decisions, the decisions to not tell parents in February, and who Mayor Bass assigned to create a plan for these centers in the summer 2024
- 2. The organizational structure showing who oversees these decision-makers
- 3. Specific actions RAP will implement to prevent similar issues in other programs

I believe families deserve this transparency, which I have yet to see from RAP since our enrollment in August 2024. I am ever grateful for the center directors and staff who have made our experience wonderful over this year in spite of administrative burdens.

Thank you for sharing your candid feedback. I hear the frustration and concern in your message, and I want to acknowledge how deeply these decisions are affecting families—especially during such a significant transition.

Regarding your first point: the timing of the site tours was a difficult decision. The intention was not to prioritize adults over children, but to ensure transparency and thoroughness in the RFP process. We recognize that the midday closures were disruptive, and as mentioned in previous correspondence, the second closure was the result of a miscommunication among staff. Your feedback on this is well taken.

As for staff participation in development week, our child care centers remain licensed facilities, and we are required by Community Care Licensing to maintain ongoing staff training. The goal was to honor our educators' expertise and provide continuity—even as operations shift. While the center is closing under City management, many of these staff members will continue working with children in new settings. Their involvement in development activities was intended to support a smoother transition for everyone, especially for children who may encounter familiar faces in future programs. That said, your point about timing and relevance is valid, and we'll reflect on how to better align training with operational realities.

We remain committed to learning from this experience and doing better by our families. Thank you again for holding us accountable.

Eh. Throwing the director (the one person parents actually trust has been consistent with us time and time again) is an interesting leadership/PR strategy.

The email response doesn't really have answers for the key questions raised originally.

- 1. Why were the adults (RFP bidders and Central staff) prioritized over kids for the tours. Salaried adults can more easily show up at 4pm for a site tour than have kids dis-regulated by two straight 12pm closure days. That seems like a choice to center the adults.
- 2. Why are staff pulled into "development" week when the center is closing permanently in City operations? If the staff are getting reassigned anyway, why not wait until the program is closed to cross-train then? The private RFP bidders will have their own training for whatever staff they hire.

Again, decisions to center the adult experience versus toddlers. That's quite the leadership choice.

I am writing to express my profound disappointment at the mismanagement of our neighborhood daycare center's closure (Downey Childcare Center - a licensed preschool).

The actions taken over the past 6 months tell me that the plan is to 'quietly' kill this program as early as possible, despite the estimated closure timeline of December/January discussed in May 2025. This approach prioritizes potential payments to privatized childcare providers over the families who depend on these services. Many in leadership seem to have lost sight of a fundamental truth: **the end clients of your services are not RFP bidders, but the families and staff of our neighborhoods.**

The recent operational decisions are not acceptable. Closing the daycare during precious caregiving hours to accommodate RFP site visits—which could easily be scheduled before or after care hours—demonstrates a callous disregard for working families. Adding insult to injury, scheduling a "professional development week," when staff knows their positions are most likely to be moved out of childcare altogether or eliminated, is both wasteful and demoralizing.

These closures create a gap of 22% of our weekly caregiving time that we rely on as working parents. Closing for two consecutive days at noon—eliminating more than half the day's childcare for over a dozen families—so that potential bidders can tour the facility, is illogical, if not cruel. The center operates 6.5 hours per day; it is glaring that minimal, if any, consideration has been given to the children and families this center serves.

The actions taken in the last few weeks, let alone the last 6 months, **put the needs of children and families dead last and make your promises of a "seamless transition" nothing but empty words.** These thoughtless decisions reveal a portion of the RAP department that has abandoned its responsibility to the community it claims to serve.

We demand accountability to address these failures, which deprioritize the families left scrambling by poor planning and execution.

EXHIBIT H REQUIRED ORDINANCE CHANGES AND OTHER BUDGETARY ACTIONS

The list below outlines actions necessary to be taken by the Mayor and Council to effectuate the 2024-25 Budget. These include ordinance changes and other actions.

I. ORDINANCE CHANGES

 Authorize the issuance of an amount not-to-exceed \$1.7 billion in Tax and Revenue Anticipation Notes to address short-term cash flow needs and to make the full annual contribution payments to the Los Angeles City Employees' Retirement System Fund and to the Los Angeles Fire and Police Pensions Fund.

City Attorney

2. Request the City Attorney to prepare and present all revenue-generating ordinances as expeditiously as possible, but no later than 30 days after final budget adoption.

II. OTHER BUDGETARY ACTIONS

Citywide

3. No layoffs are authorized as part of the 2024-25 Budget. Insofar as the budget includes the elimination of filled positions, departments are instructed to transfer incumbent employees into existing vacant positions, where appropriate. If no such vacancy exists, the City may pursue other administrative actions, including the approval of substitute and in-lieu position authorities, to retain these employees. Departments are expected to absorb the costs of these additional authorities. If a department is unable to absorb these costs, the City Administrative Officer shall recommend transfers of funds through financial status reports, including from the Unappropriated Balance - Department Payroll Reconciliation Account, to pay for the costs of these authorities.

City Administrative Officer

- 4. Instruct the City Administrative Officer (CAO), to include in 2024-25 Financial Status Reports, the transfer of interest from the Engineering Special Services Fund No. 682/50 to the Reserve Fund No. 101/62.
- 5. Instruct the CAO to report on the personnel, contracting support and other needs to develop a Grants Application and Support unit within the Office of the CAO, the function of which should be to maximize the funding from private or foundation donors, as well as the State and Federal government available to the City of Los Angeles. The report should also outline additional streamlining recommendations to ensure that the City is able to apply for and receive awards expeditiously, comply with grant terms and requirements, and focus on preparing for the 2028 Olympic and Paralympic Games.
- 6. Instruct the CAO to convene, in concert with the Mayor and Council and at the start of July, a reassessment of departmental base budgets to ensure that City services are aligned with requests from the public, that staffing levels for those core services identified are sufficient to meet the needs of the City and a plan to address the future staffing needs of our departments is developed in time for the 2025-2026 budget process.

General Services

7. Authorize the Controller and the General Services Department (GSD) to transfer funds from the Motion Picture Coordination Fund No. 417 to GSD Fund No. 100/40, Salaries, General Account No. 001010, Overtime General Account No. 001090, Salaries, As-Needed Account No. 001070, Hiring Hall Account No. 001100, Construction Projects Account No. 001014, Hiring Hall Construction Account No. 001101, Hiring Hall Fringe Benefits Account No. 001120, Construction Hiring Hall Fringe Benefits Account No. 001121, Construction Overtime Hiring Hall Account No. 001191, Maintenance Materials Account No. 003160, Construction Materials Account No. 003180, Office and Administrative Account No. 006010, and Operating Supplies Account No. 006020.

Housing

8. Disencumber and revert to the special fund cash balance the balances remaining in each of the following accounts in the same amounts as exist on June 30, 2024, and authorize the Controller to take all necessary steps to accomplish this action: Accessible Housing Fund No. 10D, Chief Architect Account Nos. 43V919, 43W919, 43Y919, City Architectural Plans Account No. 43V920, Contract Programming – For Systems Upgrades Account Nos. 43T900, 43V900, 43W900, 43Y900, Court Monitor Account Nos. 43W621, 43Y621, Outside Auditor Account Nos. 43W644, 43Y644, 43T280, Plaintiff Counsel Account Nos. 43V280, 43W280, 43Y280, Retrofit Account Nos. 43R698, 43S698, 43V698, 43W698, 43Y698, Technical Services Account Nos. 43T844, 43Y844, Translation Services Account Nos. 43T560, 43V560, 43W560, 43Y560.

Bureau of Sanitation

- 9. Instruct the Public Works, Bureau of Sanitation to report to the Municipal Facilities Committee with an evaluation of the need and logistics of hiring and the necessary facility space support required, prior to requesting reauthorization of approved MICLA funding for 2024-25 vehicles.
- 10. Instruct the Public Works, Bureau of Sanitation to report on fee studies and recommendations, including required Charter or ordinance changes, to achieve full cost recovery for the following programs:
 - a. Solid Waste Extra Capacity and Intermittent Extra Capacity
 - b. Clean Water Septage Discharge; Industrial User; Sewer Permit Dye Test; Sewer Capacity Availability Reviews
 - c. Watershed Protection Planning and Land Development-Low Impact Development Review

Bureau of Street Lighting

11. Instruct the Bureau of Street Lighting to begin developing a resiliency investment strategy that will combine solar lighting retrofits, hardening of fixtures, conversion to cheaper commodity material wiring, and any other viable strategies to address copper wire theft, and to prepare for reassessment of street lighting maintenance districts to support those investments.

Bureau of Street Services and Department of Transportation

12. Instruct the Bureau of Street Services and the Department of Transportation to develop an implementation plan for Measure HLA that will leverage existing funds and attract new grant funding, determine least-cost/best-fit street interventions that meet or exceed design requirements for the mandated elements of the Mobility Plan, and report to the Mayor and Council

within the first 90 days of the 2024-25 Fiscal Year with the revised plan for street maintenance and investment.

Recreation and Parks

13. Instruct the Recreation and Parks Department to report to the Mayor and Council with a plan to transition provision of childcare operations from the Department to non-City providers. The report should include: a timeline for the transition, the names of childcare facilities for which operations will be transitioned to an outside provider, the names of facilities that the City will continue to operate, the costs for outsourcing childcare services as compared to the costs for services when the City provides them, and current and projected enrollment and capacity for each facility.
