METRO REGION SOCCER TOURNAMENT FORMAT

1. All participants must sign the card prior to playing in the game.
2. Citywide Soccer rules shall apply.
3. Home and visiting teams are listed on the schedule and will be positioned on the same side of the field. All parents and spectators will remain on the bleachers as they are **not allowed** on the field.
4. Coaches must sign a Code of Conduct and are responsible for conduct of their teams and fans.
5. Teams forfeiting due to A) Code of Conduct violation B) Playing an ineligible player during the tournament will forfeit their last game and their opponent shall advance.
6. It is the responsibility of the coach to find out when and where their team plays when advancing in the tournament.
7. RULES PROTEST PROCEDURES: Protests will only be accepted concerning a misinterpretation of the rules by only the Head Coach and/or the Assistant Coach. Coaches must notify officials prior to the start of the next play if there is a protest. The game will be stopped at that point and the committee will be called to make the final decision. The committee's decision shall be final. Protest time is not part of game time. Protests will not be heard on official's judgment calls.
8. ELIGIBILITY PROTEST PROCEDURE: The Sports Board has taken reasonable steps to verify that all players in the tournament meet eligibility requirements. All players must appear on a league roster and have shown a valid proof of age. Any eligibility protests require proof from the manager that is protesting. A hearing will be held on such protests and the decision of the committee is final. Eligibility protests must be made immediately after the last game played.
9. Teams have been divided into various pools of teams. The winning team in each pool will move on and play in the Region Single elimination bracket.
10. Games will start on time. There is no grace period. It is up to each team to allow proper travel time to get to each game venue on time.
11. A team may begin the game with (8) eight players, however, the ninth (9th) player must arrive by the beginning of the second half. If the (9) ninth player fails to arrive by the start of the second half, the game will be forfeited.
12. In all divisions there shall be (2) twenty five-minute halves, with an intermission of 5 minutes between halves.
13. Mandatory play rule will be enforced: Players starting both the first and second half must play the first eight consecutive minutes. Eight minutes into each half, there will be a mandatory substitution whereas; the players that didn't start must play the next eight consecutive minutes. The remainder of each half will be free substitutions.
14. The Sports Board will provide the official game ball. Minors will be using size 4 and Majors will be using a size 5 game ball.
15. Pool play games can end in a tie.
16. Pool play winners will be determined by the best record.
17. In the event of a tie in pool play, tie breaker will be as follows:
 - Head to Head matchup between tied teams
 - Fewest goals allowed between tied teams
18. Single elimination games that remain tied after regulation will go to Penalty Kicks to determine the winner.

SPORTSMANSHIP STATEMENT

Good sportsmanship among spectators, parents, coaches, players, and officials are expected.

We require that ALL spectators practice supportive and encouraging behavior at all times.

Inappropriate conduct and/or negative gestures are not allowed during any part of the game.

Examples of such behavior include the following:

Taunting the opposing team and their supporters.

Derogatory comments to the officials/referees and others

Distracting players with stomping, yelling, and/or banging devices.

Usage of loud sounds such as horns/whistles/bells are prohibited.

Failure to comply with the above rules may officially end the game and result in a forfeit loss for the offending team(s).

Synthetic Turf Soccer Fields are specialized fields designed specifically for the needs of the community and sports organizations. It is critical that all participants be aware of the conditions for use. Failure to follow these specific conditions will negatively impact the quality of the field for all users.

To protect and preserve this field, please observe the following rules:

- No metal cleats, spikes or plastic cleats longer than 3/4". Please clean footwear prior to entering the field.
- No food or beverages (including gum). **Only** water bottles are ok but, please deposit them in the trash after use.
- No pets.
- No vehicles or bicycles. Only vehicles equipped with turf tires are allowed on the field. If an emergency vehicle needs to drive onto the field, instruct them to turn wide and to use care when stopping and starting.
- Only players, coaches and league officials are allowed on the playing turf. **Parents and spectators are only allowed in the bleacher/viewing area.**
- No field markings of any sort.
- No furnishings on the field, tables, chairs etc

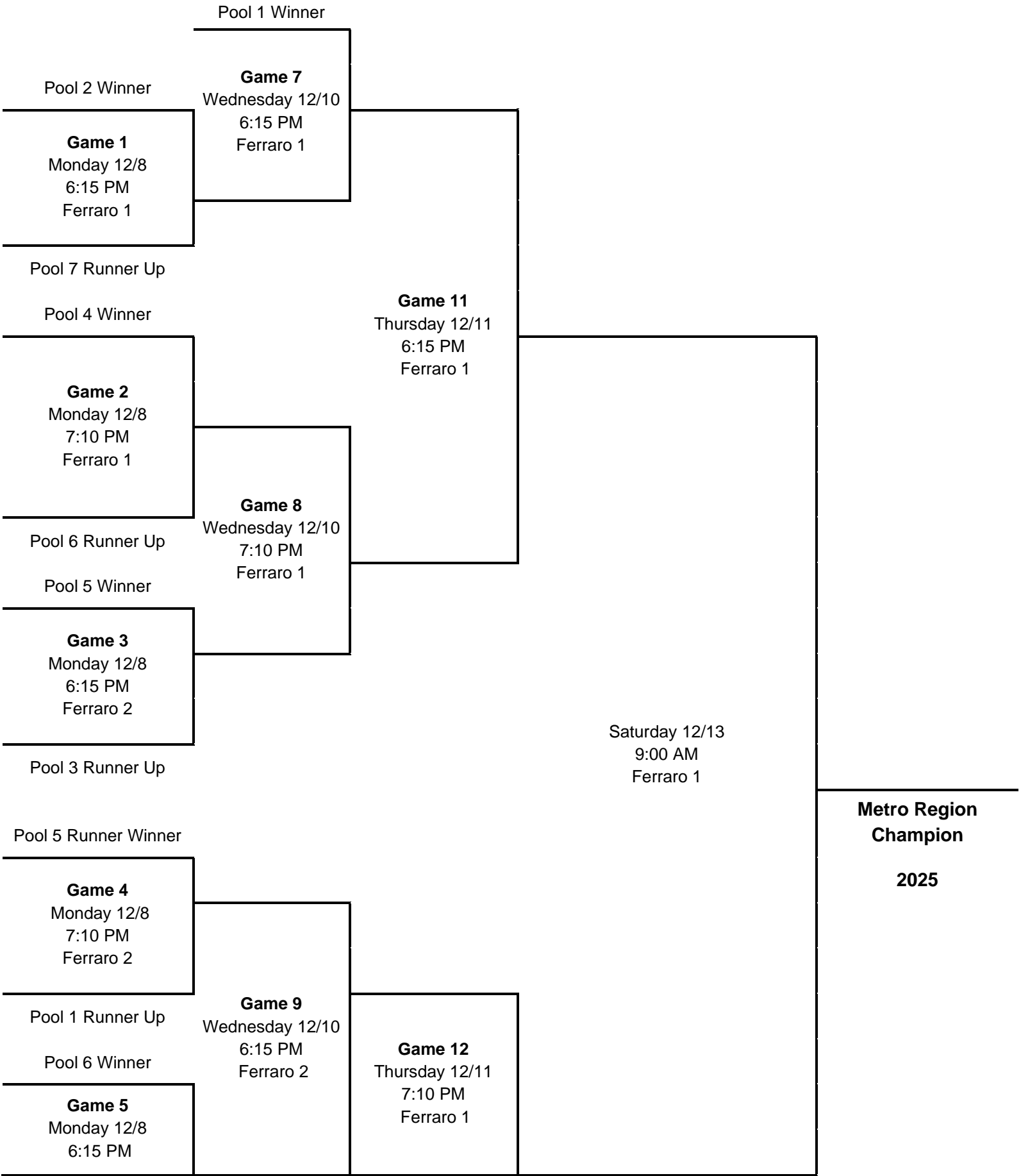

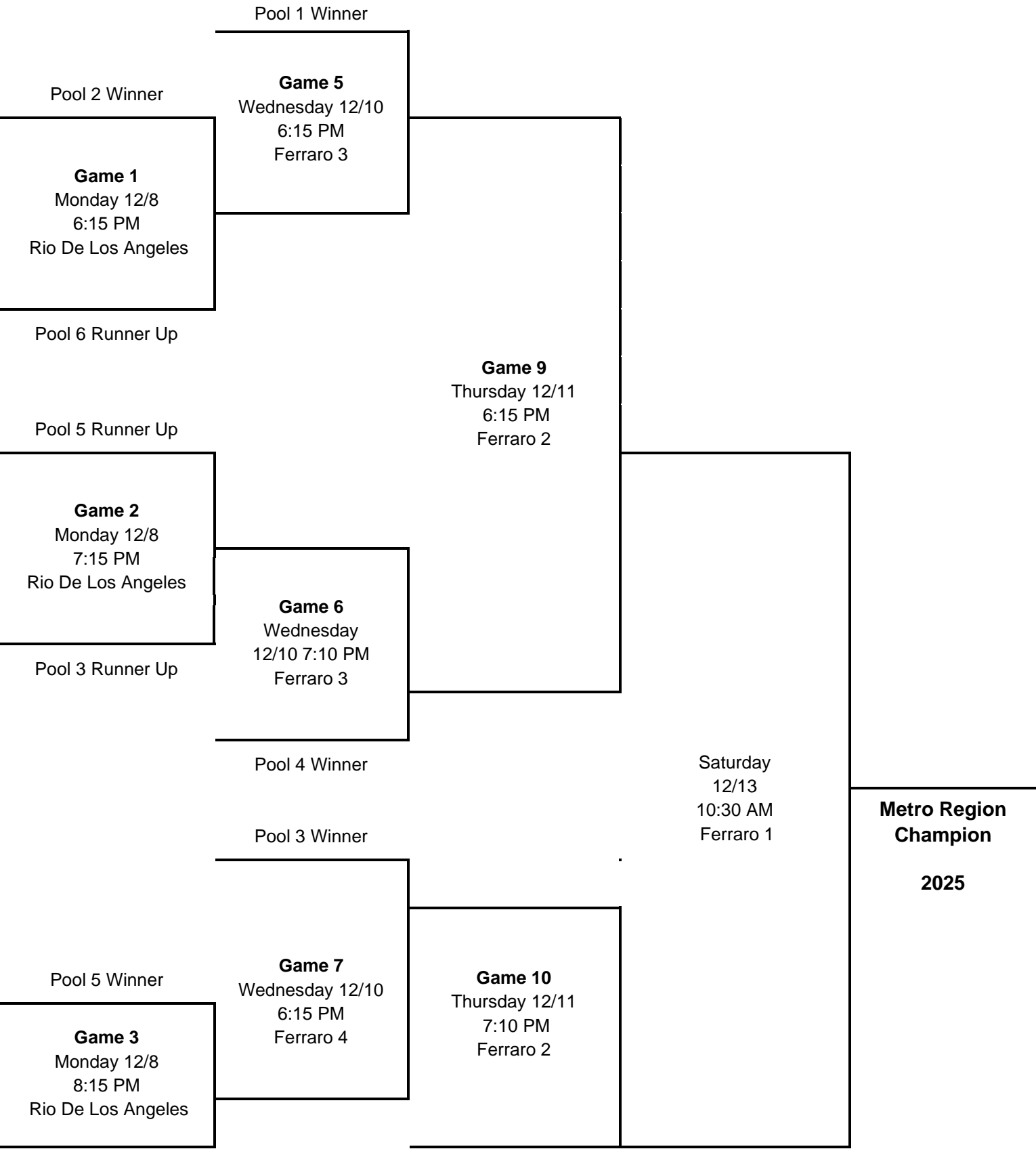

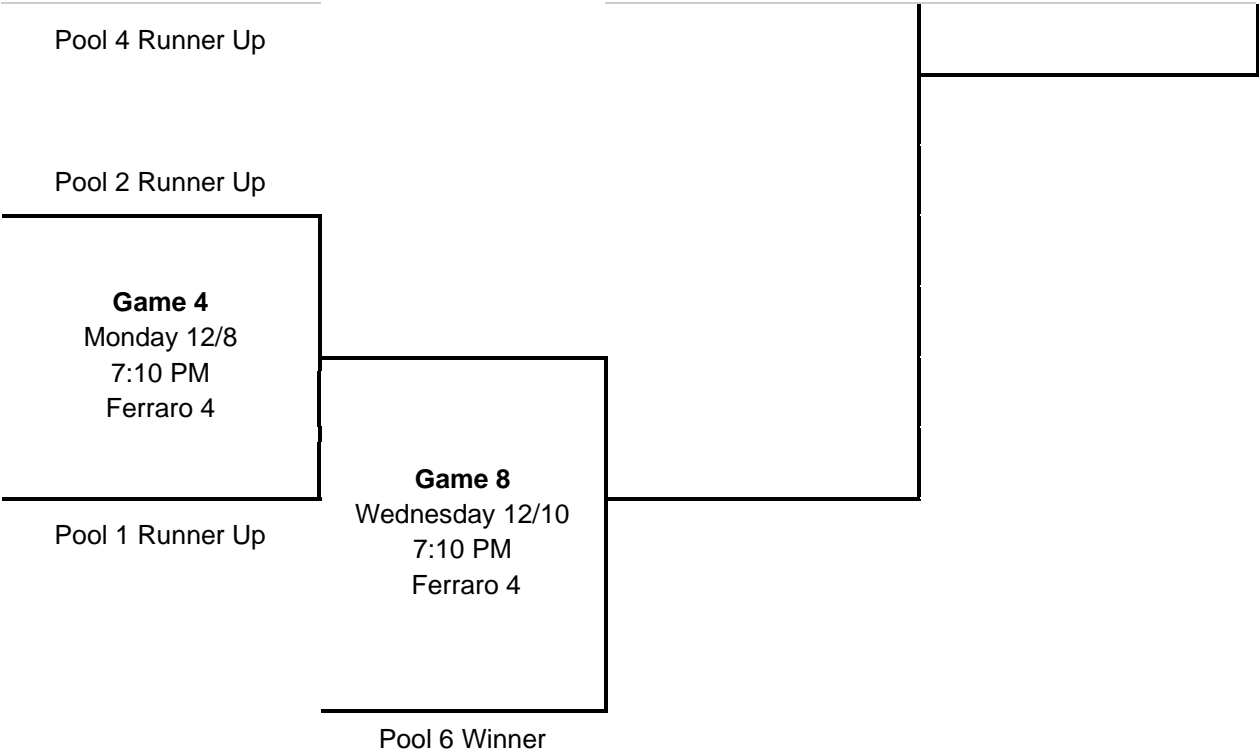
